

ASSEMBLY BILL NO. 434—ASSEMBLYMEN MUNFORD, KIHUEN,
KOIVISTO, MANENDO, MARVEL AND SEGERBLOM

MARCH 19, 2007

Referred to Committee on Education

SUMMARY—Revises provisions governing education.
(BDR 34-1270)

EXPLANATION – Matter in ***bolded italics*** is new; matter between brackets [~~omitted material~~] is material to be omitted.

AN ACT relating to education; requiring the boards of trustees of certain school districts to carry out certain actions requested by the general public under certain circumstances; revising provisions governing courses of study; revising provisions governing eligibility for a millennium scholarship; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 **Section 1** of this bill requires the board of trustees of a school district located in
2 a county whose population is 400,000 or more (currently Clark County) to take
3 action on certain matters submitted by a member of the general public. If the board
4 of trustees does not take such action within 60 days after the request is made, the
5 board shall issue a written explanation setting forth the reasons for declining to take
6 the requested action.

7 **Section 2** of this bill requires the State Board of Education to adopt a program
8 of multicultural education.

9 Existing law requires instruction in American government and American
10 history. (NRS 389.020, 389.030) **Section 3** of this bill requires the course in
11 American government to include the study of the government of the State of
12 Nevada.

13 Existing law requires the Department of Education to prescribe a code of honor
14 relating to cheating for pupils enrolled in public schools. (NRS 392.461) Existing
15 law creates the Governor Guinn Millennium Scholarship Program and prescribes
16 the criteria for eligibility of a millennium scholarship. (NRS 396.911-396.938)
17 **Section 4** of this bill provides that if a pupil violates the code of honor relating to
18 cheating while he is enrolled in a public high school, the pupil is not eligible for a
19 millennium scholarship.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 386 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *1. A person may request that the board of trustees of a school
4 district located in a county whose population is 400,000 or more to
5 consider and take action on a matter within the jurisdiction of the
6 board by submitting the request to the board at a public meeting of
7 the board, including an oral request submitted during a period of
8 the meeting devoted to comments by the general public.*

9 *2. The board of trustees of a school district located in a
10 county whose population is 400,000 or more shall carry out each
11 request for action submitted to the board of trustees pursuant to
12 subsection 1. If the board of trustees declines to carry out a
13 request for action submitted pursuant to subsection 1 within 60
14 days after the request is submitted, the board of trustees shall issue
15 a written explanation setting forth the specific reasons for
16 declining to take the requested action.*

17 **Sec. 2.** Chapter 389 of NRS is hereby amended by adding
18 thereto a new section to read as follows:

19 *1. The State Board shall adopt regulations that prescribe a
20 program of multicultural education, including, without limitation,
21 information relating to the contributions made by men and women
22 from various racial and ethnic backgrounds.*

23 *2. The board of trustees of each school district shall ensure
24 that the program prescribed pursuant to subsection 1 is provided
25 to pupils enrolled in grades 2 to 12, inclusive, with particular
26 emphasis for pupils enrolled in elementary school and middle
27 school and junior high school.*

28 **Sec. 3.** NRS 389.020 is hereby amended to read as follows:

29 389.020 1. In all public schools, the Caliente Youth Center,
30 the Nevada Youth Training Center and any other state facility for
31 the detention of children that is operated pursuant to title 5 of NRS,
32 instruction must be given in American government, including,
33 without limitation, the:

34 (a) Essentials of the:

35 (1) Constitution of the United States, including, without
36 limitation, the Bill of Rights;

37 (2) Constitution of the State of Nevada; and

38 (3) Declaration of Independence;

39 (b) Origin and history of the Constitutions; ~~and~~

40 (c) ***Study of the government of the State of Nevada; and***

41 (d) Study of and devotion to American institutions and ideals.

1 2. Except as otherwise provided in NRS 392A.100, the
2 instruction required in subsection 1 must be given during at least 1
3 year of the elementary school grades and for a period of at least 1
4 year in all high schools.

5 **Sec. 4.** NRS 396.930 is hereby amended to read as follows:

6 396.930 1. Except as otherwise provided in subsections 2 , **3**
7 and **[3.] 4**, a student may apply to the Board of Regents for a
8 millennium scholarship if he:

9 (a) Has been a resident of this State for at least 2 years before he
10 applies for the scholarship;

11 (b) Except as otherwise provided in paragraph (c), graduated
12 from a public or private high school in this State:

13 (1) After May 1, 2000, but not later than May 1, 2003; or

14 (2) After May 1, 2003, and, except as otherwise provided in
15 paragraph (c) of subsection 2, not more than 6 years before he
16 applies for the scholarship;

17 (c) Does not satisfy the requirements of paragraph (b) and:

18 (1) Was enrolled as a pupil in a public or private high school
19 in this State with a class of pupils who were regularly scheduled to
20 graduate after May 1, 2000;

21 (2) Received his high school diploma within 4 years after he
22 was regularly scheduled to graduate; and

23 (3) Applies for the scholarship not more than 6 years after he
24 was regularly scheduled to graduate from high school;

25 (d) Maintained in high school in the courses designated by the
26 Board of Regents pursuant to paragraph (b) of subsection 2, at least:

27 (1) A 3.00 grade point average on a 4.0 grading scale, if he
28 was a member of the graduating class of 2003 or 2004;

29 (2) A 3.10 grade point average on a 4.0 grading scale, if he
30 was a member of the graduating class of 2005 or 2006; or

31 (3) A 3.25 grade point average on a 4.0 grading scale, if he
32 was a member of the graduating class of 2007 or a later graduating
33 class; and

34 (e) Is enrolled in at least:

35 (1) Six semester credit hours in a community college within
36 the System; or

37 (2) Twelve semester credit hours in another eligible
38 institution.

39 2. The Board of Regents:

40 (a) Shall define the core curriculum that a student must complete
41 in high school to be eligible for a millennium scholarship.

42 (b) Shall designate the courses in which a student must earn the
43 minimum grade point averages set forth in paragraph (d) of
44 subsection 1.

1 (c) May establish criteria with respect to students who have been
2 on active duty serving in the Armed Forces of the United States to
3 exempt such students from the 6-year limitation on applications that
4 is set forth in subparagraph (2) of paragraph (b) of subsection 1.

5 (d) Shall establish criteria with respect to students who have a
6 documented physical or mental disability or who were previously
7 subject to an individualized education program under the
8 Individuals with Disabilities Education Act, 20 U.S.C. §§ 1400 et
9 seq., or a plan under Title V of the Rehabilitation Act of 1973, 29
10 U.S.C. §§ 791 et seq. The criteria must provide an exemption for
11 those students from:

12 (1) The 6-year limitation on applications that is set forth in
13 subparagraph (2) of paragraph (b) of subsection 1 and subparagraph
14 (3) of paragraph (c) of subsection 1 and any limitation applicable to
15 students who are eligible pursuant to subparagraph (1) of paragraph
16 (b) of subsection 1.

17 (2) The minimum number of credits prescribed in paragraph
18 (e) of subsection 1.

19 3. Except as otherwise provided in paragraph (c) of subsection
20 1, for students who did not graduate from a public or private high
21 school in this State and who have been residents of this State for at
22 least 2 years, the Board of Regents shall establish:

23 (a) The minimum score on a standardized test that such students
24 must receive; or

25 (b) Other criteria that students must meet,
26 ➔ to be eligible for millennium scholarships.

27 4. *A student is not eligible for a millennium scholarship if he
28 violated the code of honor relating to cheating prescribed
29 pursuant to NRS 392.461 while he was enrolled in a public high
30 school in this State.*

31 5. In awarding scholarships, the Board of Regents shall
32 enhance its outreach to students who:

33 (a) Are pursuing a career in education or health care;
34 (b) Come from families who lack sufficient financial resources
35 to pay for the costs of sending their children to an eligible
36 institution; or

37 (c) Substantially participated in an antismoking, antidrug or
38 antialcohol program during high school.

39 **Sec. 5.** This act becomes effective on July 1, 2007.
