

ASSEMBLY BILL NO. 454—COMMITTEE ON WAYS AND MEANS

AN ACT making an appropriation to the Nevada Discovery Museum for a hands-on children’s museum; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to the Nevada Discovery Museum the sum of
3 \$2,100,000 for the opening of a hands-on children’s museum.
4 2. Upon acceptance of the money appropriated by subsection 1,
5 the Museum shall:
6 (a) Prepare and transmit a report to the Interim Finance
7 Committee on or before December 15, 2008, that describes each
8 expenditure made from the money appropriated by subsection 1
9 from the date on which the money was received by the Museum
10 through December 1, 2008;
11 (b) Prepare and transmit a final report to the Interim Finance
12 Committee on or before September 18, 2009, that describes each
13 expenditure made from the money appropriated by subsection 1
14 from the date on which the money was received by the Nevada
15 Discovery Museum through June 30, 2009; and



1 (c) Upon request of the Legislative Commission, make available
2 to the Legislative Auditor any of the books, accounts, claims,
3 reports, vouchers or other records of information, confidential or
4 otherwise, of the Museum, regardless of their form or location, that
5 the Legislative Auditor deems necessary to conduct an audit of the
6 use of the money appropriated pursuant to subsection 1.

7 **Sec. 2.** Any remaining balance of the appropriation made by
8 section 1 of this act must not be committed for expenditure after
9 June 30, 2009, by the entity to which the appropriation is made or
10 any entity to which money from the appropriation is granted or
11 otherwise transferred in any manner, and any portion of the
12 appropriated money remaining must not be spent for any purpose
13 after September 18, 2009, by either the entity to which the money
14 was appropriated or the entity to which the money was subsequently
15 granted or transferred, and must be reverted to the State General
16 Fund on or before September 18, 2009.

17 **Sec. 3.** The appropriation made by the provisions of this act is
18 not intended to finance ongoing expenditures of state agencies, and
19 the expenditures financed with that appropriation must not be
20 included as base budget expenditures in the proposed budget for the
21 Executive Branch of State Government for the 2007-2009 biennium.

22 **Sec. 4.** This act becomes effective on July 1, 2007.
