SUMMARY—Makes an appropriation to the State Conservation Commission of the State Department of Conservation and Natural Resources for distribution to conservation districts. (BDR S-824)

AN ACT making an appropriation to the State Conservation Commission of the State Department of Conservation and Natural Resources for distribution to conservation districts; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** There is hereby appropriated from the State
2 General Fund to the State Conservation Commission of the State
3 Department of Conservation and Natural Resources for equal
4 distribution to conservation districts pursuant to NRS 548.178:
5 For the Fiscal Year 2007-2008.....\$140,000
6 For the Fiscal Year 2008-2009.....\$140,000

7 **Sec. 2.** Any balance of the sums appropriated by section 1 of
8 this act remaining at the end of the respective fiscal years must not
9 be committed for expenditure after June 30 of the respective fiscal
10 years by the entity to which the appropriation is made or any entity
11 to which money from the appropriation is granted or otherwise
12 transferred in any manner, and any portion of the appropriated

1 money remaining must not be spent for any purpose after
2 September 19, 2008, and September 18, 2009, respectively, by
3 either the entity to which the money was appropriated or the entity
4 to which the money was subsequently granted or transferred, and
5 must be reverted to the State General Fund on or before
6 September 19, 2008, and September 18, 2009, respectively.

7 **Sec. 3.** The appropriations made by the provisions of this act
8 are intended to finance ongoing expenditures of state agencies, and
9 the expenditures financed with those appropriations must be
10 included as base budget expenditures in the proposed budget for the
11 Executive Branch of State Government for the 2009-2011 biennium.

12 **Sec. 4.** This act becomes effective on July 1, 2007.
