AN ACT making an appropriation to the Department of Transportation to fund public transportation in rural areas; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** There is hereby appropriated from the State
2 General Fund to the Department of Transportation for rural transit
3 operations:

4 For the Fiscal Year 2007-2008.....\$4,999,999
5 For the Fiscal Year 2008-2009.....\$4,999,999

6 **Sec. 2.** For each fiscal year, the money allocated in section 1
7 of this act must be allocated as follows:

8 1. For the Elderly and Persons with Disabilities
9 Program\$212,499
10 2. For the Non-Urbanized Areas Public Transit
11 Programs\$3,222,500

1 3. For the Rural Job Access Reverse Commute
2 Funds\$65,000
3 4. For the Buses and Related Facilities Program.....\$1,500,000

4 **Sec. 3.** The Department of Transportation shall seek matching
5 federal funds available for rural transit for the money appropriated
6 by section 1 of this act.

7 **Sec. 4.** Any remaining balance of the appropriations made by
8 section 1 of this act must not be committed for expenditure after
9 June 30 of the respective fiscal years, by the entity to which the
10 appropriation is made or any entity to which money from the
11 appropriation is granted or otherwise transferred in any manner, and
12 any portion of the appropriated money remaining must not be spent
13 for any purpose after September 19, 2008, and September 18, 2009,
14 respectively, by either the entity to which the money was
15 appropriated or the entity to which the money was subsequently
16 granted or transferred, and must be reverted to the State General
17 Fund on or before September 19, 2008, and September 18, 2009,
18 respectively.

19 **Sec. 5.** This act becomes effective on July 1, 2007.
