AN ACT relating to criminal procedure; prohibiting certain governmental officers from requesting or requiring a victim of an alleged sexual offense to submit to a polygraphic or similar examination as a condition of investigating the offense; requiring judicial notification to persons convicted of a misdemeanor or felony that constitutes domestic violence that certain acts by such persons concerning a firearm or ammunition may be a felony under federal or state law; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 **Sections 1 and 2** of this bill amend existing state law to comply with certain
2 federal requirements that affect the eligibility of this State to receive certain federal
3 funding pursuant to the Violence Against Women Act, 42 U.S.C. §§ 3796gg et seq.
4 **Section 1** prohibits certain governmental officers from requesting or requiring a
5 victim of an alleged sexual offense to take or submit to a polygraphic examination
6 or other similar examination as a condition of investigating the offense. **Section 2**
7 requires a court to notify a person who is convicted of a misdemeanor or felony that
8 constitutes domestic violence that possession, shipment, transportation or receipt of
9 a firearm or ammunition by the person may constitute a felony under federal or
10 state law.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 171 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 **1. A law enforcement officer, prosecutor or other employee of**
4 **a governmental entity shall not, as a condition of investigating an**
5 **alleged sexual offense, request or require a victim of the alleged**
6 **sexual offense to take or submit to a polygraphic examination or**
7 **other similar examination that is used, or the results of which are**
8 **used, for the purpose of rendering a diagnostic opinion regarding**
9 **the honesty or dishonesty of a person.**

10 **2. As used in this section, "sexual offense" has the meaning**
11 **ascribed to it in NRS 179D.410.**

12 **Sec. 2.** Chapter 176 of NRS is hereby amended by adding
13 thereto a new section to read as follows:

14 **If a defendant is convicted of a misdemeanor or felony that**
15 **constitutes domestic violence pursuant to NRS 33.018, the court**
16 **shall notify the defendant that possession, shipment,**
17 **transportation or receipt of a firearm or ammunition by the**
18 **defendant may constitute a felony pursuant to NRS 202.360 or**
19 **federal law.**
