AN ACT relating to juries; exempting certain persons from jury service; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1        This bill revises provisions of existing law which exempt certain persons from  
2        jury service by reinstating certain exemptions from jury service which were  
3        repealed during the 72nd Session of the Nevada Legislature. (NRS 6.020; Chapter  
4        255, Statutes of Nevada 2003, p. 1347) Specifically, this bill reinstates exemptions  
5        from jury service for: (1) any federal or state officer; (2) any judge, justice of the  
6        peace or attorney at law; (3) any county clerk, recorder, assessor, sheriff, deputy  
7        sheriff, constable or police officer; and (4) any officer or correctional officer  
8        employed by the Department of Corrections. This bill also adds a new exemption  
9        from jury service for any other correctional officer.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1        **Section 1.** NRS 6.020 is hereby amended to read as follows:  
2              6.020     1. Except as otherwise provided in subsections 2 and 3  
3        and NRS 67.050, upon satisfactory proof, made by affidavit or  
4        otherwise, the following-named persons, and no others, are exempt  
5        from service as grand or trial jurors:

1       (a) While the Legislature is in session, any member of the  
2 Legislature or any employee of the Legislature or the Legislative  
3 Counsel Bureau; **[and]**

4       (b) Any person who has a fictitious address pursuant to NRS  
5 217.462 to 217.471, inclusive **[.]**;

6           (c) **Any federal or state officer;**

7           (d) **Any judge, justice of the peace or attorney at law;**

8           (e) **Any county clerk, recorder, assessor, sheriff, deputy sheriff,**  
9 **constable or police officer;**

10         (f) **Any officer employed by the Department of Corrections;**  
11 **and**

12           (g) **Any correctional officer.**

13       2. All persons of the age of 70 years or over are exempt from  
14 serving as grand or trial jurors. Whenever it appears to the  
15 satisfaction of the court, by affidavit or otherwise, that a juror is  
16 over the age of 70 years, the court shall order the juror excused from  
17 all service as a grand or trial juror, if the juror so desires.

18       3. A person who is the age of 65 years or over who lives 65  
19 miles or more from the court is exempt from serving as a grand or  
20 trial juror. Whenever it appears to the satisfaction of the court, by  
21 affidavit or otherwise, that a juror is the age of 65 years or over and  
22 lives 65 miles or more from the court, the court shall order the juror  
23 excused from all service as a grand or trial juror, if the juror so  
24 desires.
