

ASSEMBLY BILL NO. 503—COMMITTEE ON WAYS AND MEANS

MARCH 22, 2007

Referred to Committee on Ways and Means

SUMMARY—Makes an appropriation to the Greater Las Vegas After-School All-Stars for certain after-school programs. (BDR S-724)

AN ACT relating to education; making an appropriation to the Greater Las Vegas After-School All-Stars for the implementation and operation of certain after-school programs; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 The After-School All-Stars is an organization that provides after-school
- 2 programs for at-risk children throughout the country. The Greater Las Vegas After-
- 3 School All-Stars provides those programs to children in the Clark County School
- 4 District. This bill makes an appropriation to the Greater Las Vegas After-School
- 5 All-Stars for the implementation and operation of after-school programs in certain
- 6 at-risk schools within the Clark County School District.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
- 2 General Fund to the Greater Las Vegas After-School All-Stars the
- 3 sum of \$1,000,000 for the implementation and operation of after-
- 4 school programs in certain at-risk schools within the Clark County
- 5 School District.
- 6 2. The Greater Las Vegas After-School All-Stars shall work in
- 7 cooperation with the Clark County School District to identify the at-

1 risk schools within the School District in which the after-school
2 programs will be provided.

3 3. The Greater Las Vegas After-School All-Stars shall use the
4 money appropriated by subsection 1 to implement and operate an
5 after-school program at each school identified pursuant to
6 subsection 2, including, without limitation:

7 (a) Personnel for the program;

8 (b) Equipment and supplies for the program, including, without
9 limitation, educational and instructional materials and sports
10 equipment;

11 (c) Incentives for children who participate in the program,
12 including, without limitation, shirts and medals;

13 (d) Transportation for educational field trips; and

14 (e) The provision of healthy snacks for children who participate
15 in the program.

16 **Sec. 2.** Upon acceptance of the money appropriated by section
17 1 of this act, the Greater Las Vegas After-School All-Stars shall:

18 1. Prepare and transmit a report to the Interim Finance
19 Committee on or before December 15, 2008, that describes each
20 expenditure made from the money appropriated by section 1 of this
21 act from the date on which the money was received by the Greater
22 Las Vegas After-School All-Stars through December 1, 2008;

23 2. Prepare and transmit a final report to the Interim Finance
24 Committee on or before September 18, 2009, that describes each
25 expenditure made from the money appropriated by section 1 of this
26 act from the date on which the money was received by the Greater
27 Las Vegas After-School All-Stars through June 30, 2009; and

28 3. Upon request of the Legislative Commission, make available
29 to the Legislative Auditor any of the books, accounts, claims,
30 reports, vouchers or other records of information, confidential or
31 otherwise, of the Greater Las Vegas After-School All-Stars,
32 regardless of their form or location, that the Legislative Auditor
33 deems necessary to conduct an audit of the use of the money
34 appropriated pursuant to section 1 of this act.

35 **Sec. 3.** Any remaining balance of the appropriation made by
36 section 1 of this act must not be committed for expenditure after
37 June 30, 2009, by the entity to which the appropriation is made or
38 any entity to which money from the appropriation is granted or
39 otherwise transferred in any manner, and any portion of the
40 appropriated money remaining must not be spent for any purpose
41 after September 18, 2009, by either the entity to which the money
42 was appropriated or the entity to which the money was subsequently
43 granted or transferred, and must be reverted to the State General
44 Fund on or before September 18, 2009.
