**SUMMARY**—Revises provisions governing educational personnel and student teachers. (BDR 34-1370)

AN ACT relating to education; requiring the board of trustees of a school district to employ certain student teachers as substitute teachers in certain schools and in certain subject areas under certain circumstances; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law authorizes a school district to enter into an agreement for the  
2 assignment of student teachers within the school district for training purposes.  
3 (NRS 391.095) This bill requires a school district which has entered into such an  
4 agreement to employ certain student teachers as substitutes in at-risk schools and in  
5 hard to fill subject areas when licensed teachers are not available to fill those  
6 positions.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     **Section 1.** Chapter 391 of NRS is hereby amended by adding  
2 thereto a new section to read as follows:

3       ***1. A board of trustees of a school district that has entered into  
4 an agreement pursuant to NRS 391.095 shall, before assigning a  
5 long-term substitute who is not a licensed teacher, assign a student  
6 teacher who satisfies the requirements of subsection 2 as a  
7 substitute teacher to fill positions:***

8           ***(a) At schools in which 65 percent or more of the pupils who  
9 are enrolled in the school are children who are at risk; or***

1       (b) In the field of mathematics, science, special education or  
2 English as a second language.

3       2. A student teacher who has completed not less than 4 weeks  
4 of student teaching in a school district pursuant to NRS 391.095  
5 may apply to the board of trustees of that school district for  
6 employment as a substitute teacher. The application must include  
7 the written approval of:

8       (a) The teacher who supervises the student teacher through  
9 the Nevada System of Higher Education or accredited  
10 postsecondary educational institution, as applicable; and

11       (b) The teacher who is responsible for supervising the student  
12 teacher in the classroom.

13       3. If a school district employs a student teacher as a substitute  
14 teacher pursuant to this section, the school district shall ensure  
15 that the student teacher is directly supervised by a licensed  
16 teacher. A licensed teacher so assigned must:

17       (a) Be available to assist the student teacher during the school  
18 day;

19       (b) Observe the student teacher on a periodic basis; and

20       (c) Oversee the management of the classroom, instructional  
21 duties and administrative duties of the student teacher.

22       4. A student teacher who is employed as a substitute teacher  
23 pursuant to this section is entitled to the rate of pay otherwise  
24 payable to substitute teachers employed by the school district for  
25 each day the student teacher works as a substitute teacher.  
26 Nothing in this section entitles a student teacher to be paid for  
27 time spent completing his student teaching.

28       5. As used in this section, "student teacher" means a student  
29 of a branch of the Nevada System of Higher Education or an  
30 accredited postsecondary educational institution who is assigned  
31 to teach for training purposes pursuant to NRS 391.095.

32       Sec. 2. NRS 391.273 is hereby amended to read as follows:

33       391.273 1. Except as otherwise provided in subsections 4 and  
34 10 ~~H~~ and except for persons who are supervised pursuant to  
35 section 1 of this act, the unlicensed personnel of a school district  
36 must be directly supervised by licensed personnel in all duties which  
37 are instructional in nature. To the extent practicable, the direct  
38 supervision must be such that the unlicensed personnel are in the  
39 immediate location of the licensed personnel and are readily  
40 available during such times when supervision is required.

41       2. Unlicensed personnel who are exempted pursuant to  
42 subsection 4 must be under administrative supervision when  
43 performing duties which are instructional in nature.

1       3. Unlicensed personnel may temporarily perform duties under  
2 administrative supervision which are not primarily instructional in  
3 nature.

4       4. Except as otherwise provided in subsection 5, upon  
5 application by a superintendent of schools, the Superintendent of  
6 Public Instruction may grant an exemption from the provisions of  
7 subsection 1. The Superintendent shall not grant an exemption  
8 unless:

9           (a) The duties are within the employee's special expertise or  
10 training;

11           (b) The duties relate to the humanities or an elective course of  
12 study, or are supplemental to the basic curriculum of a school;

13           (c) The performance of the duties does not result in the  
14 replacement of a licensed employee or prevent the employment of a  
15 licensed person willing to perform those duties;

16           (d) The secondary or combined school in which the duties will  
17 be performed has less than 100 pupils enrolled and is at least 30  
18 miles from a school in which the duties are performed by licensed  
19 personnel; and

20           (e) The unlicensed employee submits his fingerprints for an  
21 investigation pursuant to NRS 391.033.

22       5. The exemption authorized by subsection 4 does not apply to  
23 a paraprofessional if the provisions of 20 U.S.C. § 6319 and the  
24 regulations adopted pursuant thereto require the paraprofessional to  
25 be directly supervised by a licensed teacher.

26       6. The Superintendent of Public Instruction shall file a record  
27 of all exempt personnel with the clerk of the board of trustees of  
28 each local school district, and advise the clerk of any changes  
29 therein. The record must contain:

30           (a) The name of the exempt employee;

31           (b) The specific instructional duties he may perform;

32           (c) Any terms or conditions of the exemption deemed  
33 appropriate by the Superintendent of Public Instruction; and

34           (d) The date the exemption expires or a statement that the  
35 exemption is valid as long as the employee remains in the same  
36 position at the same school.

37       7. The Superintendent of Public Instruction may adopt  
38 regulations prescribing the procedure to apply for an exemption  
39 pursuant to this section and the criteria for the granting of such  
40 exemptions.

41       8. Except in an emergency, it is unlawful for the board of  
42 trustees of a school district to allow a person employed as a  
43 teacher's aide to serve as a teacher unless the person is a legally  
44 qualified teacher licensed by the Superintendent of Public  
45 Instruction. As used in this subsection, "emergency" means an

1 unforeseen circumstance which requires immediate action and  
2 includes the fact that a licensed teacher or substitute teacher is not  
3 immediately available.

4       9. If the Superintendent of Public Instruction determines that  
5 the board of trustees of a school district has violated the provisions  
6 of subsection 8, he shall take such actions as are necessary to reduce  
7 the amount of money received by the district pursuant to NRS  
8 387.124 by an amount equal to the product when the following  
9 numbers are multiplied together:

10       (a) The number of days on which the violation occurred;  
11       (b) The number of pupils in the classroom taught by the  
12 teacher's aide; and

13       (c) The number of dollars of basic support apportioned to the  
14 district per pupil per day pursuant to NRS 387.1233.

15       10. The provisions of this section do not apply to unlicensed  
16 personnel who are employed by the governing body of a charter  
17 school, unless a paraprofessional employed by the governing body  
18 is required to be directly supervised by a licensed teacher pursuant  
19 to the provisions of 20 U.S.C. § 6319 and the regulations adopted  
20 pursuant thereto.

21       **Sec. 3.** This act becomes effective on July 1, 2007.
