(ON BEHALF OF THE NEVADA STATE BOARD OF EXAMINERS FOR
ADMINISTRATORS OF FACILITIES FOR LONG-TERM CARE)

SUMMARY—Makes various changes regarding licenses for and disciplinary action against administrators of facilities for long-term care. (BDR 54-570)

AN ACT relating to administrators of facilities for long-term care; providing for the reinstatement of expired licenses for administrators of a residential facility for groups or nursing facility administrators; requiring the payment of a fee for reinstatement; requiring the Nevada State Board of Examiners for Administrators of Facilities for Long-Term Care to make reasonable efforts to notify licensees of license renewal requirements and license expirations; revising provisions governing the authority of the Board to take disciplinary action against a person who holds a license; authorizing the Board to proceed with certain investigations, actions or disciplinary proceedings against persons with expired licenses; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law provides for the licensing of administrators of facilities for long-
2 term care. (NRS 654.140-654.180) The license of a nursing facility administrator or
3 an administrator of a residential facility for groups expires 2 years after it was
4 issued unless it is renewed. (NRS 654.170) **Section 2** of this bill requires the
5 Nevada State Board of Examiners for Administrators of Facilities for Long-Term
6 Care to reinstate a license that expired if the person who held the license pays a fee
7 and fulfills certain other requirements. **Section 2** also requires the Board to make

8 reasonable efforts to notify a person who holds a license that renewal of a license is
9 coming due and to notify a person if the license held by the person expired.

10 Under existing law, the Board may impose an administrative fine of not more than \$2,500 on a person who holds a license and may suspend or revoke a license for various violations. (NRS 654.190) **Section 3** of this bill increases the maximum amount of the administrative fine that the Board may impose to not more than \$5,000 and authorizes the Board to recover reasonable investigative fees and costs, to place conditions on a license and to place a person who holds a license on probation. **Section 3** also adds violations which would subject a person who holds a license to disciplinary action by the Board and provides that the expiration of a license or the voluntary surrender of a license does not deprive the Board of jurisdiction to continue disciplinary proceedings against the person who held the license.

21 Existing law authorizes the reinstatement of a suspended license of an administrator of a residential facility for groups if a majority of the members of the Board vote in favor of the reinstatement. (NRS 654.195) **Section 4** of this bill 22 additionally authorizes reinstatement of the license if the person who held the 23 license reappears for the license and the Board determines that the person meets the 24 requirements for the issuance of a license.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 654.028 is hereby amended to read as follows:
2 654.028 “Nursing facility administrator” means a person who
3 manages, supervises and is in general administrative charge of a
4 facility for skilled nursing or facility for intermediate care *of*
5 *patients*.

6 **Sec. 2.** NRS 654.170 is hereby amended to read as follows:
7 654.170 1. The Board shall issue a numbered license, in such
8 form as it may prescribe, to each applicant who meets the
9 requirements of NRS 654.150 or 654.155 and shall affix its official
10 seal to the license.

11 2. Each license issued by the Board pursuant to this chapter
12 expires 2 years after the last day of the calendar month in which it
13 was issued and may be renewed on or before that date biennially.

14 3. Any licensed nursing facility administrator or administrator
15 of a residential facility for groups may renew his license by applying
16 for renewal in the manner prescribed by the Board, paying the
17 renewal fee fixed by the Board and submitting all information
18 required to complete the renewal.

19 4. The Board shall, as a prerequisite for the renewal of a
20 license, require each holder to comply with:

21 (a) The requirements for continuing education adopted by the
22 Board; and

23 (b) The duties of the administrator set forth in NRS 449.0357.

24 **5. The Board shall reinstate a license which has expired
25 pursuant to subsection 2 if:**

1 (a) Not later than 2 years after the date the license expired, the
2 person who held the license:

3 (1) Applies to the Board for the reinstatement of the license
4 in the manner prescribed by the Board;

5 (2) Pays to the Board a fee for the reinstatement of the
6 license equal to twice the amount of the renewal fee fixed by the
7 Board pursuant to subsection 3; and

8 (3) Submits all information required by the Board pursuant
9 to subsection 3 for renewal; and

10 (b) The Board determines that the person meets the
11 requirements of NRS 654.150 or 654.155.

12 6. The Board shall make reasonable efforts to notify each
13 person who holds a license:

14 (a) Before the license expires pursuant to subsection 2, that if
15 the person does not submit the renewal fee and all the information
16 required to complete the renewal, the license will expire pursuant
17 to subsection 2; and

18 (b) That if the person did not pay the renewal fee and submit
19 all the information required to complete the renewal before the
20 license expired pursuant to subsection 2, the license has expired.

21 Sec. 3. NRS 654.190 is hereby amended to read as follows:

22 654.190 1. The Board may, after notice and a hearing as
23 required by law, impose an administrative fine of not more than
24 ~~\$2,500 on and suspend or~~ \$5,000 on, recover reasonable
25 investigative fees and costs incurred from, suspend, revoke or
26 place conditions on the license of, and place on probation any
27 nursing facility administrator or administrator of a residential
28 facility for groups who:

29 (a) Is convicted of a felony relating to the practice of
30 administering a nursing facility or residential facility or of any
31 offense involving moral turpitude.

32 (b) Has obtained his license by the use of fraud or deceit.

33 (c) Violates any of the provisions of this chapter.

34 (d) Aids or abets any person in the violation of any of the
35 provisions of NRS 449.001 to 449.240, inclusive, as those
36 provisions pertain to a facility for skilled nursing, facility for
37 intermediate care or residential facility for groups.

38 (e) Violates any regulation of the Board prescribing additional
39 standards of conduct for nursing facility administrators or
40 administrators of residential facilities for groups ~~for~~, including,
41 without limitation, a code of ethics.

42 (f) Engages in conduct that violates the trust of a patient or
43 resident or exploits the relationship between the nursing facility
44 administrator or administrator of a residential facility for groups

**1 and the patient or resident for the financial or other gain of the
2 licensee.**

3 2. The Board shall give a licensee against whom proceedings
4 are brought pursuant to this section written notice of a hearing not
5 less than 10 days before the date of the hearing.

6 3. An order that imposes discipline and the findings of fact and
7 conclusions of law supporting that order are public records.

8 **4. The expiration of a license by operation of law or by order
9 or decision of the Board or a court, or the voluntary surrender of a
10 license, does not deprive the Board of jurisdiction to proceed with
11 any investigation of, or action or disciplinary proceeding against,
12 the licensee or to render a decision suspending or revoking the
13 license.**

14 **Sec. 4.** NRS 654.195 is hereby amended to read as follows:

15 654.195 1. Except as otherwise provided in subsection 2, the
16 Board may reinstate the license of an administrator of a residential
17 facility for groups that has been suspended by the Board if **[a]**:

18 (a) A majority of the members of the Board vote in favor of the
19 reinstatement **[1]**; or

20 (b) **The person who held the license reapplies for a license as
21 an administrator of a residential facility for groups pursuant to
22 NRS 654.140 and the Board determines that the person meets the
23 requirements of NRS 654.155.**

24 2. The Board may reinstate a license of an administrator of a
25 residential facility for groups that has been suspended pursuant to
26 NRS 425.540 only if the holder of the license complies with the
27 requirements for reinstatement set forth in NRS 654.193.

28 3. In a manner consistent with the provisions of chapter 622A
29 of NRS, the Board may reinstate the license of an administrator of a
30 residential facility for groups that has been revoked by the Board if
31 all of the members of the Board vote in favor of reinstatement.

32 **Sec. 5.** NRS 654.195 is hereby amended to read as follows:

33 654.195 1. The Board may reinstate the license of an
34 administrator of a residential facility for groups that has been
35 suspended by the Board if **[a]**:

36 (a) A majority of the members of the Board vote in favor of the
37 reinstatement **[1]**; or

38 (b) **The person who held the license reapplies for a license as
39 an administrator of a residential facility for groups pursuant to
40 NRS 654.140 and the Board determines that the person meets the
41 requirements of NRS 654.155.**

42 2. In a manner consistent with the provisions of chapter 622A
43 of NRS, the Board may reinstate the license of an administrator of a
44 residential facility for groups that has been revoked by the Board if
45 all of the members of the Board vote in favor of reinstatement.

1 **Sec. 6.** 1. This section and sections 1, 2 and 3 of this act
2 become effective upon passage and approval.

3 2. Section 3 of this act expires by limitation on the date 2 years
4 after the date on which the provisions of 42 U.S.C. § 666 requiring
5 each state to establish procedures under which the state has
6 authority to withhold or suspend, or to restrict the use of
7 professional, occupational and recreational licenses of persons who:

8 (a) Have failed to comply with a subpoena or warrant relating to
9 a proceeding to determine the paternity of a child or to establish or
10 enforce an obligation for the support of a child; or

11 (b) Are in arrears in the payment for the support of one or more
12 children,

13 → are repealed by the Congress of the United States.

14 3. Section 4 of this act becomes effective 2 years after the date
15 on which the provisions of 42 U.S.C. § 666 requiring each state to
16 establish procedures under which the state has authority to withhold
17 or suspend, or to restrict the use of professional, occupational and
18 recreational licenses of persons who:

19 (a) Have failed to comply with a subpoena or warrant relating to
20 a proceeding to determine the paternity of a child or to establish or
21 enforce an obligation for the support of a child; or

22 (b) Are in arrears in the payment for the support of one or more
23 children,

24 → are repealed by the Congress of the United States.
