

ASSEMBLY BILL No. 54—COMMITTEE ON TRANSPORTATION

PREFILED FEBRUARY 1, 2007

Referred to Committee on Transportation

SUMMARY—Requires applicants for a special license plate to pay an application fee which is refundable in certain circumstances. (BDR 43-740)

AN ACT relating to motor vehicles; requiring an applicant requesting the design, preparation and issuance of a special license plate to pay an application fee; providing for the refund of the application fee in certain circumstances; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill requires a person submitting an application to the Department of
2 Motor Vehicles for the design, preparation and issuance of a special license plate to
3 submit a fee in the amount of \$5,000 with the application. (NRS 482.367002) The
4 Department is required to refund the fee to the applicant if the Department or the
5 Commission on Special License Plates decides not to issue the plate, or after at
6 least 1,000 plates are issued.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 482.367002 is hereby amended to read as
2 follows:
3 482.367002 1. A person may request that the Department
4 design, prepare and issue a special license plate by submitting an
5 application to the Department.

1 2. An application submitted to the Department pursuant to
2 subsection 1:

3 (a) Must be on a form prescribed and furnished by the
4 Department;

5 (b) Must be accompanied by a petition containing the signatures
6 of at least 1,000 persons who wish to obtain the special license
7 plate;

8 (c) Must specify whether the special license plate being
9 requested is intended to generate financial support for a particular
10 cause or charitable organization and, if so, the name of the cause or
11 charitable organization; **[and]**

12 (d) May be accompanied by suggestions for the design of and
13 colors to be used in the special license plate **H**; **and**

14 (e) **Must be accompanied by a fee in the amount of \$5,000.**

15 3. The Department may design and prepare a special license
16 plate requested pursuant to subsection 1 if:

17 (a) The Department determines that the application for that plate
18 complies with subsection 2; and

19 (b) The Commission on Special License Plates approves the
20 application for that plate pursuant to subsection 5 of
21 NRS 482.367004.

22 4. Except as otherwise provided in NRS 482.367008, the
23 Department may issue a special license plate that:

24 (a) The Department has designed and prepared pursuant to this
25 section;

26 (b) The Commission on Special License Plates has approved for
27 issuance pursuant to subsection 5 of NRS 482.367004; and

28 (c) Complies with the requirements of subsection 8 of
29 NRS 482.270,

30 → for any passenger car or light commercial vehicle upon
31 application by a person who is entitled to license plates pursuant to
32 NRS 482.265 and who otherwise complies with the requirements for
33 registration and licensing pursuant to this chapter. A person may
34 request that personalized prestige license plates issued pursuant to
35 NRS 482.3667 be combined with a special license plate issued
36 pursuant to this section if that person pays the fees for personalized
37 prestige license plates in addition to the fees for the special license
38 plate.

39 5. **The Department must promptly refund the application fee**
40 **subsequent to the issuance of the special license plate.**

41 (a) **If the Department or the Commission on Special License**
42 **Plates determines not to issue the special license plate; or**

43 (b) **If it is determined that at least 1,000 special license plates**
44 **have been issued pursuant to the assessment of the viability of the**

1 *design of the special license plate conducted pursuant to*
2 **NRS 482.367008.**

3 6. If, during a registration year, the holder of license plates
4 issued pursuant to the provisions of this section disposes of the
5 vehicle to which the plates are affixed, the holder shall:

6 (a) Retain the plates and affix them to another vehicle that meets
7 the requirements of this section if the holder pays the fee for the
8 transfer of the registration and any registration fee or governmental
9 services tax due pursuant to NRS 482.399; or

10 (b) Within 30 days after removing the plates from the vehicle,
11 return them to the Department.

12 **Sec. 2.** This act becomes effective on July 1, 2007.
