AN ACT making appropriations to the Department of Transportation for highway improvements; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** There is hereby appropriated from the State  
2 General Fund to the Department of Transportation for  
3 improvements, funded by State General Fund revenues in excess of  
4 the spending cap, to:

5       1. Interstate Highway 15 in Las Vegas, the sum of  
6 \$154,000,000.

7       2. State Route 160, Blue Diamond, the sum of \$16,000,000,  
8 except that no portion of this sum for improvements to State Route  
9 160 may be utilized by the Department unless the State Controller,  
10 upon satisfactory proof submitted by the Department, determines  
11 that \$2,000,000, in money or in goods and services provided in  
12 kind, or both, has been committed for such improvements from  
13 sources other than federal, state, regional or local governmental  
14 entities.

15       **Sec. 2.** Any remaining balance of the appropriations made by  
16 section 1 of this act must not be committed for expenditure after

1 June 30, 2011, by the entity to which the appropriations are made or  
2 any entity to which money from an appropriation is granted or  
3 otherwise transferred in any manner, and any portion of the  
4 appropriated money remaining must not be spent for any purpose  
5 after September 16, 2011, by either the entity to which the money  
6 was appropriated or the entity to which the money was subsequently  
7 granted or transferred, and must be reverted to the State General  
8 Fund on or before September 16, 2011.

9       **Sec. 3.** In addition to the appropriations made by section 1 of  
10 this act, there is hereby appropriated from the State Highway Fund  
11 to the Department of Transportation for improvements to Interstate  
12 Highway 15 in Las Vegas:

13              For the Fiscal Year 2007-2008.....\$8,000,000  
14              For the Fiscal Year 2008-2009.....\$8,000,000

15       **Sec. 4.** Any remaining balance of the appropriations made by  
16 section 3 of this act must not be committed for expenditure after  
17 June 30, 2011, by the entity to which the appropriations are made or  
18 any entity to which money from an appropriation is granted or  
19 otherwise transferred in any manner, and any portion of the  
20 appropriated money remaining must not be spent for any purpose  
21 after September 16, 2011, by either the entity to which the money  
22 was appropriated or the entity to which the money was subsequently  
23 granted or transferred, and must be reverted to the State Highway  
24 Fund on or before September 16, 2011.

25       **Sec. 5.** 1. This section and sections 1 and 2 of this act  
26 become effective upon passage and approval.

27              2. Sections 3 and 4 of this act become effective on July 1,  
28 2007.
