

ASSEMBLY BILL NO. 566—COMMITTEE ON EDUCATION

SUMMARY—Makes an appropriation to ComputerCorps to provide refurbished computers to certain pupils and their families. (BDR S-984)

AN ACT relating to education; making an appropriation to ComputerCorps to provide refurbished computers to certain pupils and their families; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. 1. There is hereby appropriated from the State General Fund to ComputerCorps the sum of \$1,953,000.

2. ComputerCorps shall use the money appropriated by subsection 1 to:

(a) Provide refurbished computers to pupils enrolled in public schools in this State and their families for use at home, based upon the recommendation of the school districts concerning the need of certain pupils and their families for a computer at home;

(b) Provide training to the pupils and their families who receive a refurbished computer concerning the use of the computer; and

(c) Provide technology training for youth through the ComputerCorps “TechCamp.”

3. Upon acceptance of the money appropriated by subsection 1, ComputerCorps shall:

(a) Prepare and transmit a report to the Interim Finance Committee on or before December 15, 2008, that describes each

1 expenditure made from the money appropriated by subsection 1
2 from the date on which the money was received by ComputerCorps
3 through December 1, 2008;

4 (b) Prepare and transmit a final report to the Interim Finance
5 Committee on or before September 18, 2009, that describes each
6 expenditure made from the money appropriated by subsection 1
7 from the date on which the money was received by ComputerCorps
8 through June 30, 2009; and

9 (c) Upon request of the Legislative Commission, make available
10 to the Legislative Auditor any of the books, accounts, claims,
11 reports, vouchers or other records of information, confidential or
12 otherwise, of ComputerCorps, regardless of their form or location,
13 that the Legislative Auditor deems necessary to conduct an audit of
14 the use of the money appropriated pursuant to subsection 1.

15 **Sec. 2.** Any remaining balance of the appropriation made by
16 section 1 of this act must not be committed for expenditure after
17 June 30, 2009, by the entity to which the appropriation is made or
18 any entity to which money from the appropriation is granted or
19 otherwise transferred in any manner, and any portion of the
20 appropriated money remaining must not be spent for any purpose
21 after September 18, 2009, by either the entity to which the money
22 was appropriated or the entity to which the money was subsequently
23 granted or transferred, and must be reverted to the State General
24 Fund on or before September 18, 2009.

25 **Sec. 3.** This act becomes effective on July 1, 2007.
