AN ACT relating to traffic laws; revising provisions governing the stopping, standing or parking of a vehicle near a crosswalk; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 This bill expands the prohibition in existing law from stopping, standing or  
2 parking a vehicle within 20 feet of a crosswalk that is located at an intersection by  
3 prohibiting such activity at any crosswalk, regardless of location. (NRS 484.399)

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 484.399 is hereby amended to read as follows:  
2 484.399 1. A person shall not stop, stand or park a vehicle,  
3 except when necessary to avoid conflict with other traffic or in  
4 compliance with law or the directions of a police officer or official  
5 traffic-control device, in any of the following places:  
6 (a) On a sidewalk;  
7 (b) In front of a public or private driveway;  
8 (c) Within an intersection;  
9 (d) Within 15 feet of a fire hydrant in a place where parallel  
10 parking is permitted, or within 20 feet of a fire hydrant if angle



1 parking is permitted and a local ordinance requires the greater  
2 distance;

3 (e) ~~On a crosswalk;~~

4 ~~(f)~~ Within 20 feet of a crosswalk ~~at an intersection;~~

6 (f) Within 30 feet upon the approach to any official traffic-  
7 control signal located at the side of a highway;

8 ~~(h)~~ (g) Between a safety zone and the adjacent curb or within  
9 30 feet of points on the curb immediately opposite the ends of a  
10 safety zone;

11 ~~(i)~~ (h) Within 50 feet of the nearest rail of a railroad;

12 ~~(j)~~ (i) Within 20 feet of a driveway entrance to any fire station  
13 and, on the side of a highway opposite the entrance to any fire  
14 station, within 75 feet of that entrance;

15 ~~(k)~~ (j) Alongside or opposite any highway excavation or  
16 obstruction when stopping, standing or parking would obstruct  
17 traffic;

18 ~~(l)~~ (k) On the highway side of any vehicle stopped or parked  
19 at the edge of or curb of a highway;

20 ~~(m)~~ (l) Upon any bridge or other elevated structure or within a  
21 highway tunnel;

22 ~~(n)~~ (m) Except as otherwise provided in subsection 2, within 5  
23 feet of a public or private driveway; and

24 ~~(o)~~ (n) At any place where official traffic-control devices  
25 prohibit stopping, standing or parking.

26 2. The provisions of paragraph ~~(n)~~ (m) of subsection 1 do not  
27 apply to a person operating a vehicle of the United States Postal  
28 Service if the vehicle is being operated for the official business of  
29 the United States Postal Service.

30 3. A person shall not move a vehicle not owned by him into  
31 any prohibited area or away from a curb to a distance which is  
32 unlawful.

33 4. A local authority may place official traffic-control devices  
34 prohibiting or restricting the stopping, standing or parking of  
35 vehicles on any highway where in its opinion stopping, standing or  
36 parking is dangerous to those using the highway or where the  
37 vehicles which are stopping, standing or parking would unduly  
38 interfere with the free movement of traffic. It is unlawful for any  
39 person to stop, stand or park any vehicle in violation of the  
40 restrictions stated on those devices.
