AN ACT relating to traffic laws; revising provisions governing the stopping, standing or parking of a vehicle near a crosswalk; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill expands the prohibition in existing law from stopping, standing or
2 parking a vehicle within 20 feet of a crosswalk that is located at an intersection by
3 prohibiting such activity at any crosswalk, regardless of location. (NRS 484.399)

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 484.399 is hereby amended to read as follows:
2 484.399 1. A person shall not stop, stand or park a vehicle,
3 except when necessary to avoid conflict with other traffic or in
4 compliance with law or the directions of a police officer or official
5 traffic-control device, in any of the following places:

- 6 (a) On a sidewalk;
7 (b) In front of a public or private driveway;
8 (c) Within an intersection;
9 (d) Within 15 feet of a fire hydrant in a place where parallel
10 parking is permitted, or within 20 feet of a fire hydrant if angle
11 parking is permitted and a local ordinance requires the greater
12 distance;
13 (e) On a crosswalk;
14 (f) Within 20 feet of a crosswalk ; [at an intersection;]

1 (g) Within 30 feet upon the approach to any official traffic-
2 control signal located at the side of a highway;

3 (h) Between a safety zone and the adjacent curb or within 30
4 feet of points on the curb immediately opposite the ends of a safety
5 zone;

6 (i) Within 50 feet of the nearest rail of a railroad;
7 (j) Within 20 feet of a driveway entrance to any fire station and,
8 on the side of a highway opposite the entrance to any fire station,
9 within 75 feet of that entrance;

10 (k) Alongside or opposite any highway excavation or
11 obstruction when stopping, standing or parking would obstruct
12 traffic;

13 (l) On the highway side of any vehicle stopped or parked at the
14 edge of or curb of a highway;

15 (m) Upon any bridge or other elevated structure or within a
16 highway tunnel;

17 (n) Except as otherwise provided in subsection 2, within 5 feet
18 of a public or private driveway; and

19 (o) At any place where official traffic-control devices prohibit
20 stopping, standing or parking.

21 2. The provisions of paragraph (n) of subsection 1 do not apply
22 to a person operating a vehicle of the United States Postal Service if
23 the vehicle is being operated for the official business of the United
24 States Postal Service.

25 3. A person shall not move a vehicle not owned by him into
26 any prohibited area or away from a curb to a distance which is
27 unlawful.

28 4. A local authority may place official traffic-control devices
29 prohibiting or restricting the stopping, standing or parking of
30 vehicles on any highway where in its opinion stopping, standing or
31 parking is dangerous to those using the highway or where the
32 vehicles which are stopping, standing or parking would unduly
33 interfere with the free movement of traffic. It is unlawful for any
34 person to stop, stand or park any vehicle in violation of the
35 restrictions stated on those devices.
