

ASSEMBLY BILL No. 590—COMMITTEE ON EDUCATION

(ON BEHALF OF THE CLARK COUNTY SCHOOL DISTRICT)

SUMMARY—Revises provisions governing educational personnel.
(BDR 34-434)

EXPLANATION – Matter in ***bolded italics*** is new; matter between brackets **[omitted material]** is material to be omitted.

AN ACT relating to education; authorizing the boards of trustees of schools districts to provide an alternative financial incentive to certain eligible employees; revising the requirements for eligibility for such a financial incentive; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires the boards of trustees of school districts to purchase one-fifth of a year of retirement service credit for each year that the following
2 employees meet certain criteria: teachers employed in schools designated as
3 demonstrating need for improvement and in at-risk schools, teachers who hold
4 certain endorsements and licensed school psychologists. (NRS 391.165) Under
5 existing law, with certain exceptions, 5 years is the maximum number of years of
6 such service credit that may be purchased. (NRS 286.300, 391.165)

7 This bill authorizes the boards of trustees to make a cash payment of \$4,000
8 each contract year to eligible employees in lieu of paying the cost for employees to
9 purchase retirement service credit. The board of trustees is given the discretion to
10 determine which of these methods of payment to provide to all eligible employees
11 and may change the method of payment chosen in future school years. This bill also
12 expands the eligibility for the financial incentive to all employees of a school
13 district who work in at-risk schools. This bill further revises the criteria for
14 eligibility for the financial incentive, including eliminating employment at a school
15 designated as demonstrating need for improvement that is not also an at-risk school
16 as a criteria.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 391.165 is hereby amended to read as follows:
2 391.165 1. Except as otherwise provided in subsection ~~3~~ 4 and except as otherwise required as a result of NRS 286.537, the board of trustees of a school district shall ~~pay~~:
3 (a) *Pay* the cost for ~~a licensed teacher or licensed school psychologist~~ all eligible employees to purchase one-fifth of a year of service pursuant to subsection 2 of NRS 286.300; or
4 (b) *Pay \$4,000 to each eligible employee.*
5 *→ The board of trustees has the sole discretion to determine whether the method of payment for all eligible employees will be pursuant to paragraph (a) or (b).*
6 2. An employee is eligible for a payment pursuant to subsection 1 if:
7 (a) The ~~teacher or school psychologist~~ employee is a member of the Public Employees' Retirement System and has at least 5 years of service;
8 (b) The ~~teacher or school psychologist has been employed as a licensed teacher or licensed school psychologist in this State for at least 5 consecutive school years, regardless of whether the employment was with one or more school districts in this State;~~
9 (c) *Each* most recent evaluation of the ~~teacher or school psychologist conducted pursuant to NRS 391.3125~~ employee is at least satisfactory ~~for the years of employment required by paragraph (b); and~~
10 (d) ~~In addition to the years of employment required by paragraph (b):~~
11 (1) *The teacher has*; and
12 (c) *The employee:*
13 (1) *Has* been employed ~~as a licensed teacher for 2 school years~~ for the full contract year at a school within the school district ~~during his employment at the school~~:
14 (I) ~~Which carried the designation of demonstrating need for improvement; or~~
15 (II) *At* ~~at~~ which at least 65 percent of the pupils who are enrolled in the school are children who are at risk;
16 (2) ~~The~~ *Is a licensed* teacher *who* holds an endorsement in the field of mathematics, science, special education or English as a second language and has been employed for ~~at least 1 school~~ the full contract year to teach in the subject area for which he holds an endorsement; or
17 (3) ~~The~~ *Is a* school psychologist *who* has been employed as a licensed school psychologist for ~~at least 1 school year~~.

6 of trustees of a school district shall pay the cost for ~~a licensed~~

cash payment pursuant to subsection 1, as determined by the

4 (a) A child is “at risk” if he is eligible for free or reduced-price
5 lunches pursuant to 42 U.S.C. §§ 1751 et seq.

6 (b) “Service” has the meaning ascribed to it in NRS 286.078.

7 **Sec. 2.** The provisions of NRS 354.599 do not apply to any
8 additional expenses of a local government that are related to the
9 provisions of this act.

10 **Sec. 3.** This act becomes effective on July 1, 2007.
