ASSEMBLY BILL NO. 611—COMMITTEE ON WAYS AND MEANS

MAY 7, 2007

Referred to Committee on Ways and Means

SUMMARY—Makes an appropriation to the Division of Health Care Financing and Policy of the Department of Health and Human Services for allocation to the Nevada Covering Kids and Families Coalition for outreach activities to identify and assist persons who are eligible for public programs of health care. AN ACT making an appropriation to the Division of Health Care Financing and Policy of the Department of Health and Human Services for allocation to the Nevada Covering Kids and Families Coalition for outreach activities to identify and assist persons who are eligible for public programs of health care; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
- 2 General Fund to the Division of Health Care Financing and Policy
- 3 of the Department of Health and Human Services for carrying out
- 4 the provisions of subsection 2:
- 5 For the Fiscal Year 2007-2008.....\$100,000
- 6 For the Fiscal Year 2008-2009.....\$100,000
- 7 2. The Division shall allocate the money appropriated pursuant
- 8 to subsection 1 to the Nevada Covering Kids and Families Coalition
- 9 to be used:

1 (a) For outreach activities to identify and assist those residents
2 of this State who are eligible for public programs of health care,
3 including, without limitation, the State Program for Medicaid and
4 the Nevada CheckUp Program; and

5 (b) To prepare and provide the report required pursuant to
6 subsection 3.

7 3. The Nevada Covering Kids and Families Coalition shall, on
8 or before February 1, 2009, submit a report concerning the use of
9 the money allocated to it pursuant to subsection 2, including,
10 without limitation, the specific outreach activities that it provided
11 and effectiveness of those activities, to the Division and to the
12 Director of the Legislative Counsel Bureau for transmittal to the
13 Legislature.

14 **Sec. 2.** The sums appropriated by section 1 of this act are
15 available for either fiscal year. Any remaining balance of those sums
16 must not be committed for expenditure after June 30, 2009, by the
17 entity to which the appropriation is made or any entity to which
18 money from the appropriation is granted or otherwise transferred in
19 any manner, and any portion of the appropriated money remaining
20 must not be spent for any purpose after September 18, 2009, by
21 either the entity to which the money was appropriated or the entity
22 to which the money was subsequently granted or transferred,
23 and must be reverted to the State General Fund on or before
24 September 18, 2009.

25 **Sec. 3.** This act becomes effective on July 1, 2007.
