**SUMMARY**—Provides that special mobile equipment or a farm vehicle that contains dyed special fuel in the fuel tank may be operated on certain highways in this State in certain circumstances. (BDR 32-1509)

AN ACT relating to special fuel; providing that a farm vehicle or special mobile equipment that contains dyed special fuel in the fuel tank may be operated on certain highways in this State under certain circumstances; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law allows a farm vehicle that contains dyed special fuel in the fuel  
2 tank to be operated on a highway in this State only when it is crossing the highway  
3 from one parcel of land to another parcel of land which is owned by or under the  
4 control of the person operating the farm vehicle. (NRS 366.203) This bill provides  
5 that any farm vehicle that is not required to be registered with the Department of  
6 Motor Vehicles or special mobile equipment that is incidentally operated or moved  
7 upon a highway may contain dyed special fuel in the fuel tank of the farm vehicle  
8 or special mobile equipment while it is operated on certain highways in this State.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** NRS 366.203 is hereby amended to read as follows:

2       366.203 1. Special fuel, other than compressed natural gas,  
3 liquefied petroleum gas or kerosene, which is exempt from the tax  
4 pursuant to subsection 3 or 4 of NRS 366.200 must be dyed before it  
5 is removed for distribution from a rack. The dye added to the  
6 exempt special fuel must be of the color and concentration required  
7 by the regulations adopted by the Secretary of the Treasury pursuant  
8 to 26 U.S.C. § 4082.

9       2. Except as otherwise provided in subsections 3 ~~[, 4 and 5.]~~  
10 **and 4,** a person shall not operate or maintain on any highway in this  
11 State a motor vehicle which contains dyed special fuel in the fuel  
12 tank of that vehicle. A person who operates or maintains a motor  
13 vehicle in violation of this subsection and the registered owner of  
14 the motor vehicle are jointly and severally liable for any taxes,  
15 penalties and interest payable to the Department.

16       3. A person who, pursuant to subsection 2, 3 or 4 of NRS  
17 366.200, is exempt from the tax imposed by this chapter may  
18 operate or maintain a motor vehicle on a highway in this State  
19 which contains dyed special fuel in the fuel tank of that vehicle.

20       4. ~~[To the extent permitted by federal law, a]~~ A person may  
21 operate or maintain on a highway in this State any special mobile  
22 equipment **that is incidentally operated or moved upon a highway**  
23 or farm equipment ~~[that]~~ which contains dyed special fuel in the fuel  
24 tank of the special mobile equipment or farm equipment. As used in  
25 this subsection:

26       (a) "Farm equipment" means any self-propelled machinery or  
27 motor vehicle that is designed solely for tilling soil or for  
28 cultivating, harvesting or transporting crops or other agricultural  
29 products ~~[from a field or other area owned or leased by the operator  
30 of the farm equipment and in which the crops or agricultural  
31 products are grown, to a field, yard, silo, cellar, shed or other facility  
32 which is:]~~

33       ~~(1) Owned or leased by the operator of the farm equipment;~~  
34 ~~and~~

35       ~~(2) Used to store or process the crops or agricultural  
36 products.~~

37       ~~→] and which is not required to be registered with the Department.~~  
38 The term includes a tractor, baler or swather, ~~[or]~~ any implement  
39 used to retrieve hay ~~[, or any special mobile equipment that is  
40 used for farming purposes. The term does not include a truck-  
41 tractor or any other vehicle primarily used for hauling loads long  
42 distances over a public highway.~~

1       (b) "Highway" does not include a controlled-access highway as  
2 defined in NRS 484.041.

3       (c) "*Truck-tractor*" has the meaning ascribed to it in  
4 NRS 482.130.

5       (d) "*Vehicle*" has the meaning ascribed to it in NRS 482.135.

6       ~~15. To the extent authorized by federal law, a person may  
7 operate or maintain a motor vehicle on a highway in this State that  
8 contains dyed special fuel in the fuel tank if the motor vehicle is  
9 used only to cross the highway to travel from one parcel of land  
10 owned or controlled by the person to another parcel of land owned  
11 or controlled by the person.~~

12       ~~—6.] 5.~~ There is a rebuttable presumption that all special fuel  
13 which is not dyed special fuel and which is sold or distributed in this  
14 State is for the purpose of propelling a motor vehicle.

15       6. *The Department shall, by regulation, define "incidentally  
16 operated or moved upon a highway" for purposes of this section.*
