SUMMARY—Makes various changes to provisions governing the Account for License Plates for the Support of the Education of Children in the Arts. (BDR 18-853)

AN ACT relating to motor vehicles; providing for a portion of the money in the Account for License Plates for the Support of the Education of Children in the Arts to be distributed to the VSA arts of Nevada; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 Existing law requires the Department of Motor Vehicles, in cooperation with
2 the Nevada Arts Council, to design, prepare and issue license plates for the support
3 of the education of children in the arts and to impose a fee for such license plates.
4 (NRS 482.3792) The fees collected must be deposited in the Account for License
5 Plates for the Support of the Education of Children in the Arts administered by
6 the Nevada Arts Council. (NRS 233C.094) This bill provides that one-half of the
7 money received from those special license plates, which must be deposited in the
8 Account for License Plates for the Support of the Education of Children in the Arts,
9 be distributed to the VSA arts of Nevada.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 233C.094 is hereby amended to read as
2 follows:

3 233C.094 1. The Account for License Plates for the Support
4 of the Education of Children in the Arts is hereby created in the
5 State General Fund. The Division shall administer the Account.

6 2. The money in the Account does not lapse to the State
7 General Fund at the end of any fiscal year.

8 3. **[The] Except as otherwise provided in subsection 4, the**
9 money in the Account must be used only for the support of
10 programs for the education of children in the arts and must not be
11 used to replace or supplant funding available from other sources.

12 4. **The Division shall retain one-half of the money deposited**
13 **in the Account to use pursuant to subsection 3. The Division shall**
14 **remit one-half of the money deposited in the Account to the VSA**
15 **arts of Nevada or its successor for the support of programs and**
16 **activities of the VSA arts of Nevada or its successor. If the VSA**
17 **arts of Nevada ceases to exist and there is no successor, the**
18 **Division shall retain all the money credited to the Account to use**
19 **pursuant to subsection 3.**

20 **Sec. 2.** This act becomes effective on July 1, 2007.
