

ASSEMBLY BILL NO. 97—COMMITTEE ON

SUMMARY—Revises provisions governing certain contracts between insurers and hospitals. (BDR 40-857)

AN ACT relating to health care; revising provisions governing contracts between certain insurers and hospitals that are located in certain counties; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill prohibits a hospital that is located in a county whose population is
2 100,000 or more but less than 400,000 (currently Washoe County) and a health
3 insurance company, self-insured employer, association of self-insured public or
4 private employers or a private carrier from entering into a contract for the provision
5 of health care to insureds or employees if the contract prohibits the insurer from
6 contracting with other hospitals which are located in that county. This prohibition
7 applies only to contracts that are executed or renewed on and after the effective
8 date of the bill.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 449 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 ***1. A hospital that is located in a county whose population is***
4 ***100,000 or more but less than 400,000 shall not enter into a***
5 ***contract for the provision of health care to insureds or employees,***
6 ***as applicable, with a health insurance company, a self-insured***



1 *employer, an association of self-insured public or private*
2 *employers or a private carrier if the contract prohibits the health*
3 *insurance company, self-insured employer, association or private*
4 *carrier from contracting with other hospitals which are located in*
5 *that county.*

6 2. As used in this section:

7 (a) "Association of self-insured private employers" has the
8 meaning ascribed to it in NRS 616A.050.

9 (b) "Association of self-insured public employers" has the
10 meaning ascribed to it in NRS 616A.055.

11 (c) "Health insurance company" has the meaning ascribed to
12 it in section 4 of this bill.

13 (d) "Private carrier" has the meaning ascribed to it in
14 NRS 616A.290.

15 (e) "Self-insured employer" has the meaning ascribed to it in
16 NRS 616A.305.

17 **Sec. 2.** Chapter 616B of NRS is hereby amended by adding
18 thereto a new section to read as follows:

19 1. A self-insured employer, an association of self-insured
20 public or private employers or a private carrier shall not enter into
21 a contract for the provision of health care to employees with a
22 hospital that is located in a county whose population is 100,000 or
23 more but less than 400,000 if the contract prohibits the self-
24 insured employer, association or private carrier from contracting
25 with other hospitals which are located in that county.

26 2. As used in this section, "hospital" has the meaning
27 ascribed to it in NRS 449.012.

28 **Sec. 3.** NRS 616B.527 is hereby amended to read as follows:

29 616B.527 1. A self-insured employer, an association of self-
30 insured public or private employers or a private carrier may:

31 (a) Except as otherwise provided in NRS 616B.5273, enter into
32 a contract or contracts with one or more organizations for managed
33 care to provide comprehensive medical and health care services to
34 employees for injuries and diseases that are compensable pursuant
35 to chapters 616A to 617, inclusive, of NRS.

36 (b) ~~{Enter}~~ Except as otherwise provided in section 2 of this
37 act, enter into a contract or contracts with providers of health care,
38 including, without limitation, physicians who provide primary care,
39 specialists, pharmacies, physical therapists, radiologists, nurses,
40 diagnostic facilities, laboratories, hospitals and facilities that provide
41 treatment to outpatients, to provide medical and health care services
42 to employees for injuries and diseases that are compensable
43 pursuant to chapters 616A to 617, inclusive, of NRS.

44 (c) Require employees to obtain medical and health care
45 services for their industrial injuries from those organizations and



1 persons with whom the self-insured employer, association or private
2 carrier has contracted pursuant to paragraphs (a) and (b), or as the
3 self-insured employer, association or private carrier otherwise
4 prescribes.

5 (d) Except as otherwise provided in subsection 3 of NRS
6 616C.090, require employees to obtain the approval of the self-
7 insured employer, association or private carrier before obtaining
8 medical and health care services for their industrial injuries from a
9 provider of health care who has not been previously approved by the
10 self-insured employer, association or private carrier.

11 2. An organization for managed care with whom a self-insured
12 employer, association of self-insured public or private employers or
13 a private carrier has contracted pursuant to this section shall comply
14 with the provisions of NRS 616B.528, 616B.5285 and 616B.529.

15 **Sec. 4.** Chapter 679A of NRS is hereby amended by adding
16 thereto a new section to read as follows:

17 ***1. A health insurance company shall not enter into a contract***
18 ***for the provision of health care to insureds with a hospital that is***
19 ***located in a county whose population is 100,000 or more but less***
20 ***than 400,000 if the contract prohibits the health insurance***
21 ***company from contracting with other hospitals which are located***
22 ***in that county.***

23 ***2. As used in this section:***

24 ***(a) "Health insurance company" means any person authorized***
25 ***pursuant to this title to provide or arrange for the provision of a***
26 ***plan of health insurance or health benefits, including, without***
27 ***limitation, an insurer, a producer of insurance, a managing***
28 ***general agent, a third-party administrator, an organization***
29 ***composed of or using preferred providers of health care, a health***
30 ***maintenance organization, a carrier serving small employers, a***
31 ***fraternal benefit society, a hospital, medical or dental service***
32 ***corporation, a plan for dental care or a prepaid limited health***
33 ***service organization.***

34 ***(b) "Hospital" has the meaning ascribed to it in NRS 449.012.***

35 **Sec. 5.** The provisions of this act do not apply to contracts that
36 are executed or renewed before the effective date of this act.

37 **Sec. 6.** This act becomes effective upon passage and approval.
