

ASSEMBLY BILL NO. 9—ASSEMBLYMAN PARKS

SUMMARY—Authorizes the licensure of a mortgage agent on behalf of a corporation or limited-liability company. (BDR 54-729)

AN ACT relating to mortgage agents; authorizing a natural person to be licensed as a mortgage agent on behalf of a corporation or limited-liability company under certain circumstances; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill authorizes a natural person who is qualified to be licensed as a
2 mortgage agent under existing law to be issued such a license on behalf of
3 a professional corporation of which he is the sole shareholder or on behalf of a
4 limited-liability company of which he is the manager.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 645B of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *1. Any natural person who meets the qualifications of a*
4 *mortgage agent and:*

5 *(a) Except as otherwise provided in subsection 2, is the sole*
6 *shareholder of a corporation organized pursuant to the provisions*
7 *of chapter 89 of NRS; or*

8 *(b) Is the manager of a limited-liability company organized*
9 *pursuant to the provisions of chapter 86 of NRS,*

1 ↪ *may be licensed on behalf of the corporation or limited-liability*
2 *company for the purpose of associating with a licensed mortgage*
3 *broker in the capacity of a mortgage agent.*

4 2. *The spouse of the owner of the corporation who has a*
5 *community interest in any shares of the corporation shall not be*
6 *deemed a second shareholder of the corporation for the purposes*
7 *of paragraph (a) of subsection 1, if the spouse does not vote any of*
8 *those shares.*

9 3. *A license issued pursuant to this section entitles only the*
10 *sole shareholder of the corporation or the manager of the limited-*
11 *liability company to act as a mortgage agent, and only as an*
12 *officer or agent of the corporation or limited-liability company*
13 *and not on his own behalf. The licensee shall not do or deal in any*
14 *act, acts or transactions included within the definition of a*
15 *mortgage broker in NRS 645B.0127, except as that activity is*
16 *permitted pursuant to this chapter to licensed mortgage agents.*

17 4. *The corporation or limited-liability company shall, within*
18 *30 days after a license is issued on its behalf pursuant to this*
19 *section and within 30 days after any change in its ownership, file*
20 *an affidavit with the Division stating:*

21 (a) *For a corporation, the number of issued and outstanding*
22 *shares of the corporation and the names of all persons to whom*
23 *the shares have been issued.*

24 (b) *For a limited-liability company, the names of members who*
25 *have an interest in the company.*

26 5. *A license issued pursuant to this section automatically*
27 *expires upon:*

28 (a) *The death of the licensed shareholder in the corporation or*
29 *the manager of the limited-liability company; or*

30 (b) *The issuance of shares in the corporation to more than one*
31 *person other than the spouse.*

32 6. *This section does not alter any of the rights, duties or*
33 *liabilities which otherwise arise in the legal relationship between a*
34 *mortgage broker or mortgage agent and a person who deals with*
35 *him.*
