ASSEMBLY CONCURRENT RESOLUTION—Celebrating the
95th anniversary of Girl Scouts in the United States and
the 75th anniversary of Girl Scouts in Nevada.

1 WHEREAS, For nearly a century, the Girl Scout movement has
2 played a pivotal role in America's history with a focus on
3 developing young women with the necessary skills to be leaders
4 who make a difference in their world, and this initial vision was that
5 of founder Juliette Gordon Low, when she gathered 18 girls to form
6 the first Girl Scout troop in Savannah, Georgia, on March 12, 1912;
7 and

8 WHEREAS, Throughout history, the Girl Scouts have assumed
9 leadership roles in their community, and today, with 3.6 million



1 members and over 55 million alumnae throughout the United States,
2 the Girl Scouts continue to develop girls' leadership skills and
3 prepare them for their futures as successful women; and

4 WHEREAS, Girl Scout alumnae now represent 70 percent of
5 women serving in Congress, 64 percent of women listed in *Who's*
6 *Who in America* and 53 percent of women who are business owners;
7 and

8 WHEREAS, The Girl Scout program is available to all girls from
9 5 to 17 years of age and is based on the Girl Scout Promise and Law
10 and four fundamental goals that encourage girls to develop their full
11 potential, relate to others with increasing understanding, skill and
12 respect, develop a meaningful set of values to guide their actions
13 and to provide for sound decision making, and contribute to the
14 improvement of society through the use of their abilities and
15 leadership skills, while working in cooperation with others; and

16 WHEREAS, As the Girl Scouts of America are celebrating 95
17 years as the premier leadership organization for girls, the Girl
18 Scouts of Frontier Council, an organization which develops and
19 manages Girl Scouting in central and southern Nevada, is
20 celebrating the 75th anniversary of the formation of the first Girl
21 Scout troop in Nevada on April 14, 1932, in Boulder City with 22
22 girls; now, therefore, be it

23 RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE
24 SENATE CONCURRING, That the members of the 74th Session of the
25 Nevada Legislature hereby congratulate all Girl Scouts as they begin
26 a year-long celebration of their 95th anniversary by participating in
27 community service activities and performing good deeds of their
28 choosing to carry out the theme of this historic occasion, "Make the
29 World a Better Place"; and be it further

30 RESOLVED, That the Nevada Legislature also congratulates the
31 members of the Girl Scouts of Frontier Council as they celebrate 75
32 years of Girl Scouting in central and southern Nevada and
33 commends the Council for their role in developing the leaders of
34 tomorrow; and be it further
