Co-Speaker and Minority Floor Leader Lynn C. Hettrick.

1 WHEREAS, Lynn C. Hettrick was born in Carmel, California,
2 and attended Claremont Men's College in Claremont, California;
3 and
4 WHEREAS, Lynn Hettrick moved to Douglas County, Nevada, in
5 1972, where he became a successful businessman and active
6 member of the community; and
7 WHEREAS, In 1992, Lynn Hettrick was elected to represent
8 Assembly District No. 39 in the Nevada Assembly where he served
9 for 14 years which included seven regular sessions and six special
10 sessions; and

1 WHEREAS, During the 1995 Regular Session of the Nevada
2 Legislature in which the Assembly was evenly divided with 21
3 Republicans and 21 Democrats, Lynn Hetrick was elected to serve
4 as Co-Speaker of the Assembly, a position to which he brought
5 great leadership and statesmanship and was able to engage in the
6 bipartisan effort necessary to accomplish the business for the people
7 of the State of Nevada; and

8 WHEREAS, Lynn Hetrick earned the respect of his party serving
9 as Minority Floor Leader from 1997 until 2005; and

10 WHEREAS, Assemblyman Hetrick actively participated in
11 various legislative organizations and was recognized for his
12 significant contributions, including his receipt of the Leader of the
13 Year Award from the National Republican Legislators Association
14 in 2001, his selection as National Chair of the Council of State
15 Governments (CSG) in 2005 and Chair of CSG-WEST for 2001-
16 2002, and his leadership role in the establishment of CSG-WEST's
17 Western Legislative Academy, an educational forum for new state
18 legislators to improve their effectiveness and build stronger
19 legislative institutions; and

20 WHEREAS, During his service in the Nevada Assembly, Lynn
21 Hetrick was supported and encouraged by his wife Arla, their four
22 children, Stacey, Holly, Tiffany and Andrew, and their eight
23 grandchildren, all of whom reside in western Nevada; and

24 WHEREAS, Assemblyman Hetrick's leadership abilities and
25 legislative and personal accomplishments will forever serve as a
26 model of public service for future members of the Nevada
27 Legislature; now, therefore, be it
