ASSEMBLY CONCURRENT RESOLUTION—Directing the
Legislative Commission to conduct interim studies
concerning chancery courts and issues relating to senior
citizens and veterans.

1 RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE
2 SENATE CONCURRING, That the Legislative Commission is hereby
3 directed to appoint a subcommittee to study the benefits, costs and
4 feasibility of the implementation of courts of chancery in Nevada
5 and a subcommittee to study issues relating to senior citizens and
6 veterans; and be it further

7 RESOLVED, That each subcommittee must be composed of three
8 members of the Assembly and three members of the Senate, one of
9 whom must be appointed as Chairman of the subcommittee; and be
10 it further

11 RESOLVED, That the study of courts of chancery must include,
12 without limitation, a compilation and analysis of the economic and
13 legal impact courts of chancery have had in states in which they
14 have been implemented and an assessment of expected revenues,
15 estimated costs of operation and any ancillary economic impact to
16 Nevada that might result from the implementation of courts of
17 chancery; and be it further

18 RESOLVED, That the interim committee studying issues relating
19 to senior citizens and veterans shall evaluate, review and comment

- 1 upon issues relating to senior citizens and veterans, including,
2 without limitation:
- 3 1. Health and human services;
 - 4 2. Elder abuse and exploitation;
 - 5 3. Financial and physical wellness initiatives;
 - 6 4. Housing and transportation; and
 - 7 5. Public outreach and advocacy; and be it further
- 8 RESOLVED, That any recommended legislation proposed by
9 either of the interim committees must be approved by a majority of
10 the members of the Assembly and a majority of the members of the
11 Senate appointed to the interim committee; and be it further
- 12 RESOLVED, That the Legislative Commission shall submit a
13 report of the results of the studies and any recommendations for
14 legislation to the 75th Session of the Nevada Legislature.
