ASSEMBLY CONCURRENT RESOLUTION—Encouraging the
creation of the Southern Nevada Automobile Theft
Advisory Commission.

1 WHEREAS, Clark County has the highest rate of automobile
2 thefts in the nation; and

3 WHEREAS, Such automobile thefts often lead to other crimes
4 involving the infliction of bodily harm; and

5 WHEREAS, The State of Arizona created an Automobile Theft
6 Authority which has been credited with significantly lowering the
7 incidence of automobile thefts in that state; and

8 WHEREAS, The creation of a similar automobile theft authority
9 in this State may be beneficial in reducing the incidence of
10 automobile theft in this State and assist in coordinating various
11 entities affected by and involved in preventing such crimes; now,
12 therefore, be it

13 RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE
14 SENATE CONCURRING, That the Nevada Legislature hereby
15 encourages the Director of the Department of Motor Vehicles, the
16 Commissioner of Insurance, the Director of the Department of
17 Public Safety, the Sheriff of Clark County, the Chief of Police of the
18 City of Henderson, the Undersheriff of the Las Vegas Metropolitan
19 Police Department and the Clark County District Attorney to
20 establish jointly the Southern Nevada Automobile Theft Advisory
21 Commission; and be it further

1 RESOLVED, That those persons are encouraged to provide that
2 the members of the Southern Nevada Automobile Theft Advisory
3 Commission serve without compensation; and be it further

4 RESOLVED, That those persons are encouraged to meet at least
5 quarterly during the biennium ending on June 30, 2009, and to
6 include in those meetings any other interested persons or entities;
7 and be it further

8 RESOLVED, That those persons are encouraged to report any
9 recommendations for addressing automobile theft, including,
10 without limitation, whether it is advisable to create a Nevada
11 Automobile Theft Authority by statute to the 75th Session of the
12 Nevada Legislature; and be it further

13 RESOLVED, That the Chief Clerk of the Assembly prepare and
14 transmit a copy of this resolution to the Director of the Department
15 of Motor Vehicles, the Commissioner of Insurance, the Director of
16 the Department of Public Safety, the Sheriff of Clark County, the
17 Chief of Police of the City of Henderson, the Undersheriff of the
18 Las Vegas Metropolitan Police Department and the Clark County
19 District Attorney.
