ASSEMBLY CONCURRENT RESOLUTION—Urging the Commission on Economic Development, regional economic development authorities and local redevelopment agencies to develop programs to promote economic development and urban renewal and to stimulate employment in certain areas.

1 WHEREAS, The health, safety and welfare of the people of this  
2 State are dependent upon a healthy economy and vibrant  
3 communities; and

4 WHEREAS, The continual encouragement, development, growth  
5 and expansion of private enterprise within the State require a  
6 cooperative and continuous partnership between government and  
7 private organizations; and

8 WHEREAS, There are certain depressed and blighted areas in this  
9 State that need the particular attention of government, business,  
10 labor and the residents of Nevada to help attract private investment  
11 into the area; and

12 WHEREAS, Many older neighborhoods in urban areas are in need  
13 of a redevelopment program focused on breathing new life into  
14 deteriorated areas plagued by social, environmental or economic  
15 conditions which act as a barrier to new investment by private  
16 enterprise; and

17 WHEREAS, Many of these areas are fully populated communities  
18 in this State that have not benefited from any new growth or new

1 industry in years, and this has led to a depressed economy, a  
2 negative image for the community and a lost sense of pride among  
3 its residents; and

4 WHEREAS, As taxpayers in this State, the residents of these  
5 areas deserve to see a portion of the revenue from their tax dollars  
6 used to restore and strengthen their communities, thereby improving  
7 their quality of life; now, therefore, be it

8 RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE  
9 SENATE CONCURRING, That the Legislature hereby urges the  
10 Commission on Economic Development, regional economic  
11 development authorities and local redevelopment agencies to  
12 establish programs of economic development for the older  
13 neighborhoods in depressed areas of this State to improve economic  
14 prosperity and create economic benefits for the community, its  
15 residents, the local government and the State; and be it further

16 RESOLVED, That the Commission on Economic Development,  
17 regional economic development authorities and local redevelopment  
18 agencies are encouraged to utilize the provisions of Senate Bill No.  
19 229 of the 2005 Legislative Session which became effective on  
20 October 1, 2005, to promote the growth of business and industry in  
21 certain deprived areas in this State, thereby creating new jobs,  
22 increased property values and an enhanced standard of living  
23 desired by all Nevadans; and be it further
