ASSEMBLY JOINT RESOLUTION—Proposing to amend the Nevada Constitution to repeal the constitutional rule against perpetuities.

Legislative Counsel's Digest:

1 Existing law prohibits perpetuities except for charitable purposes. (Nev. Const.
2 Art. 15, § 4) The “Rule Against Perpetuities” as set forth in the Nevada
3 Constitution is a rule that prevents property rights from vesting, meaning coming
4 into ownership, within a period of time which is considered too remote. Under
5 existing law, any property interest must vest or terminate within 365 years after it is
6 created. (NRS 111.1031, 111.1035) This bill repeals the provision of the Nevada
7 Constitution that prohibits perpetuities.

1 RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF
2 NEVADA, JOINTLY, That Section 4 of Article 15 of the Nevada
3 Constitution is hereby repealed.
