AN ACT relating to the City of Sparks; authorizing the City Council to employ Special Counsel under certain circumstances; revising certain provisions governing the qualifications of members of the Civil Service Commission; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1      **Section 1** of this bill authorizes the City Council of the City of Sparks, by  
2 majority vote, after conducting a public hearing, to employ attorneys to perform  
3 any civil or criminal duty of the City Attorney. **Section 1** further provides that those  
4 attorneys are responsible only to the City Council and that the City Attorney does  
5 not have any authority over the employment of an attorney hired by the City  
6 Council pursuant to this section of the bill.

7      **Section 2** of this bill amends the Sparks City Charter to prohibit a person from  
8 serving as a member of the Civil Service Commission if the person is: (1) an  
9 employee of the City of Sparks; (2) serving as an appointed member of any other  
10 board, commission or committee of the City; or (3) related within the third degree  
11 of consanguinity or affinity to a person who is an employee of the City of Sparks.  
12 (Sparks City Charter § 9.010) **Section 3** of this bill exempts current members of the  
13 Civil Service Commission from these provisions until their current terms expire.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1      **Section 1.** The Charter of the City of Sparks, being chapter  
2      470, Statutes of Nevada 1975, at page 724, is hereby amended by  
3      adding thereto a new section to be designated as section 3.055,  
4      immediately following section 3.050, to read as follows:

5      *Sec. 3.055 Employment of Special Counsel. The City  
6      Council may, by majority vote, after conducting a public  
7      hearing, employ attorneys to perform any civil or criminal  
8      duty of the City Attorney. Such attorneys are responsible  
9      only to the City Council, and the City Attorney shall have no  
10     responsibility or authority concerning the subject matter of  
11     such employment.*

12     **Sec. 2.** Section 9.010 of the Charter of the City of Sparks,  
13     being chapter 470, Statutes of Nevada 1975, as last amended by  
14     chapter 350, Statutes of Nevada 1987, at page 791, is hereby  
15     amended to read as follows:

16     Sec. 9.010 Civil Service Commission: Appointment;  
17     *qualifications;* removal; compensation.

18     1. There is a Civil Service Commission consisting of  
19     five residents of the City who must be appointed by the  
20     Mayor, subject to confirmation by the City Council. They  
21     shall serve terms as established by ordinance.

22     2. *A person may not serve as a member of the  
23     Commission if he is:*

24        (a) *An employee of the City;*  
25        (b) *A member of the City Council or an appointed  
26        member of any other board, commission or committee of the  
27        City; or*

28        (c) *Related within the third degree of consanguinity or  
29        affinity to a person who is an employee of the City.*

30     3. Every person appointed as a member of the  
31     Commission shall, before entering upon the duties of his  
32     office, take and subscribe the oath of office prescribed by the  
33     Constitution of this State, and file it, certified by the officer  
34     administering it, with the Clerk of the City.

35     **[3.] 4.** Any member of the Commission may be  
36     removed by a majority vote of the Commission for cause,  
37     including the failure or refusal to perform the duties of the  
38     office, the absence from three successive regular meetings of  
39     the Commission, or ceasing to meet any qualification for  
40     appointment to the Commission as *set forth in this section or*  
41     provided by the City Council.

1           **[4.] 5.** Vacancies on the ~~Civil Service~~ Commission  
2 from whatever cause must be filled by appointment by the  
3 Mayor, subject to confirmation by the City Council.

4           **[5.] 6.** The City Council shall provide the services of  
5 such employees as are necessary to enable the ~~Civil Service~~  
6 Commission to carry out its duties in a timely and proficient  
7 manner.

8           **[6.] 7.** The City Council shall provide by ordinance the  
9 amount of compensation each member of the ~~Civil Service~~  
10 Commission is entitled to receive for each full meeting he  
11 attends.

12          **Sec. 3.** The amendatory provisions of section 2 of this act do  
13 not apply to the current term of a person who is a member of the  
14 Civil Service Commission on October 1, 2007.
