

SENATE BILL NO. 115—SENATOR COFFIN

FEBRUARY 19, 2007

Referred to Committee on Human Resources and Education

SUMMARY—Revises provisions governing the rights of parents of pupils with disabilities. (BDR 34-737)

AN ACT relating to education; providing that the rights of a parent of a pupil with a disability under the Individuals with Disabilities Education Act transfer to the pupil when the pupil attains the age of 18 years; providing that a parent of a pupil with a disability may request to represent the educational interests of the pupil when the pupil attains the age of 18 years; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

The Individuals with Disabilities Education Act (IDEA) authorizes, but does not require, a state to transfer the rights of a parent of a pupil with a disability under the IDEA to the pupil when the pupil attains the age of majority under state law. (20 U.S.C. § 1415(m)) The IDEA also requires that, if a state transfers the rights of a parent to the pupil, the state must provide a special rule that would allow the parent of the pupil with a disability to be appointed to represent the educational interests of the pupil under certain circumstances. (20 U.S.C. § 1415(m)(2)) If a court has appointed a guardian for a pupil with a disability, the rights that would otherwise transfer to the pupil must remain with or otherwise transfer to the guardian. The State Board of Education has adopted regulations which transfer the rights of a parent of a pupil with a disability to the pupil when the pupil attains the age of 18 years if a court has not appointed a guardian for the pupil. (NRS 388.520; NAC 388.195)

Section 2 of this bill provides that the rights of a parent of a pupil with a disability under the IDEA transfer to the pupil when the pupil attains the age of 18 years.

Section 3 of this bill authorizes the parent of a pupil with a disability to submit a concise application to the school district or the charter school in which the pupil is

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 388 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2. 1.** *Except as otherwise provided in this section and*
4 *section 3 of this act, any right accorded to a parent of a pupil with*
5 *a disability pursuant to the Individuals with Disabilities Education*
6 *Act, 20 U.S.C. §§ 1400 et seq., or the regulations adopted pursuant*
7 *thereto, transfers to the pupil when the pupil attains the age of 18*
8 *years.*

9 2. *Not less than 45 days before the date on which a pupil with*
10 *a disability attains the age of 18 years, the school district or*
11 *charter school in which the pupil is enrolled shall provide notice*
12 *to the:*

13 (a) *Parent of the transfer of his rights pursuant to subsection 1*
14 *and of the process for submission of an application to the school*
15 *district or charter school pursuant to section 3 of this act.*

16 (b) *Pupil concerning the transfer of rights to the pupil.*

17 3. *If a pupil with a disability attains the age of 18 years and*
18 *the pupil is enrolled in a program of special education pursuant to*
19 *NRS 388.440 to 388.5315, inclusive, and sections 2 and 3 of this*
20 *act, the school district or charter school in which the pupil is*
21 *enrolled shall provide any notice required pursuant to the*
22 *Individuals with Disabilities Education Act, 20 U.S.C. §§ 1400 et*
23 *seq., and the regulations adopted pursuant thereto, or NRS*
24 *388.440 to 388.5315, inclusive, and sections 2 and 3 of this act,*
25 *and the regulations adopted pursuant thereto, to the:*

26 (a) *Parent; and*

27 (b) *Pupil with a disability,*

28 ↪ *regardless of whether the parent is appointed to represent the*
29 *educational interests of the pupil pursuant to section 3 of this act*
30 *or the rights transfer to the pupil pursuant to subsection 1.*

31 4. *If a court of competent jurisdiction adjudicates a pupil*
32 *with a disability incompetent and appoints a guardian for the*
33 *pupil, all rights pursuant to the Individuals with Disabilities*
34 *Education Act, 20 U.S.C. §§ 1400 et seq., and the regulations*
35 *adopted pursuant thereto, remain with or otherwise transfer to the*
36 *guardian.*

37 **Sec. 3. 1.** *If a parent of a pupil with a disability believes*
38 *that the pupil does not have the ability to provide informed consent*
39 *with respect to his own educational program, the parent may, at*

1 *least 30 days before the pupil attains 18 years of age, submit an*
2 *application to the school district or the charter school in which the*
3 *pupil is enrolled to appoint the parent to represent the educational*
4 *interests of the pupil.*

5 *2. The application must be submitted on a concise form*
6 *prescribed by the school district or charter school. The*
7 *application:*

8 *(a) Must not be unduly burdensome on the parent to fill out;*
9 *and*

10 *(b) Must not require the pupil to sign the application or*
11 *otherwise require the pupil to grant permission for the parent to*
12 *represent the pupil's educational interests.*

13 *3. If the school district or charter school grants an*
14 *application, the parent shall continue to represent the educational*
15 *interests of the pupil until:*

16 *(a) The pupil receives a standard high school diploma or an*
17 *adjusted diploma;*

18 *(b) The pupil is no longer enrolled in a program of special*
19 *education pursuant to NRS 388.440 to 388.5315, inclusive, and*
20 *sections 2 and 3 of this act; or*

21 *(c) The parent elects to transfer the right to represent*
22 *educational interests to the pupil.*

23 *4. A parent whose application is denied may appeal that*
24 *determination in the manner set forth for hearings in the*
25 *Individuals with Disabilities Education Act, 20 U.S.C. §§ 1400 et*
26 *seq., and the regulations adopted pursuant thereto.*

27 **Sec. 4.** NRS 388.440 is hereby amended to read as follows:

28 388.440 As used in NRS 388.440 to 388.5315, inclusive **H** ,
29 *and sections 2 and 3 of this act:*

30 1. "Gifted and talented pupil" means a person under the age of
31 18 years who demonstrates such outstanding academic skills or
32 aptitudes that he cannot progress effectively in a regular school
33 program and therefore needs special instruction or special services.

34 2. "Pupil with a disability" means a person under the age of 22
35 years who deviates either educationally, physically, socially or
36 emotionally so markedly from normal patterns that he cannot
37 progress effectively in a regular school program and therefore needs
38 special instruction or special services.

39 **Sec. 5.** This act becomes effective on July 1, 2007.
