SUMMARY—Prohibits certain vehicles from traveling on that portion of State Route 159 that is designated as a scenic route and requiring the Department of Transportation to erect suitable markers along that portion of the Route. (BDR 43-211)

AN ACT relating to transportation; prohibiting certain vehicles from traveling on that portion of State Route 159 that is designated as a scenic route; requiring the Department of Transportation to erect suitable markers along that portion of the Route; requiring the Department to consider certain factors and to receive approval from the Board of Directors of the Department before reducing the maximum weight limits on certain highways; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 This bill prohibits oversized vehicles which do not have a point of origin or
2 destination on that portion of State Route 159 that is designated as a scenic route to
3 travel on that portion of the Route and requires the Department of Transportation to
4 erect suitable markers along that portion of the Route. Further, this bill requires the
5 Department to consider certain factors and receive approval from the Board of
6 Directors of the Department before reducing the maximum weight limits for
7 oversized vehicles as prescribed by existing law on a highway under its jurisdiction.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** The Legislature hereby finds and declares that:

2 1. Because of its unique character, the restrictions imposed on
3 certain large vehicles pursuant to this act are necessary for the
4 protection of the Red Rock Canyon National Conservation Area and
5 the safety and protection of the residents and visitors who enjoy the
6 scenic beauty and recreational opportunities of the Red Rock
7 Canyon.

8 2. The enactment of this act is not intended to encourage the
9 imposition of similar restrictions on other designated scenic routes
10 in this State.

11 **Sec. 2.** Chapter 484 of NRS is hereby amended by adding
12 thereto the provisions set forth as sections 3 and 4 of this act.

13 **Sec. 3. 1. Except as otherwise provided in subsection 3, it is**
14 **unlawful for an operator or driver of any vehicle which:**

15 (a) *Is registered pursuant to the provisions of NRS 706.801 to*
16 *706.861, inclusive; or*

17 (b) *Has a declared gross weight in excess of 26,000 pounds,*
18 *↪ and which does not have a point of origin or destination on*
19 *State Route 159 from mile post 0.0 to mile post 14.0 to travel on*
20 *such Route.*

21 2. *The Department of Transportation shall erect suitable*
22 *markers along State Route 159 and may locate them at such points*
23 *as the Department of Transportation deems appropriate.*

24 3. *This section does not apply to:*

25 (a) *An authorized emergency vehicle;*

26 (b) *A vehicle being used in the service of a public utility as*
27 *defined in NRS 704.020;*

28 (c) *A school bus; or*

29 (d) *A charter bus.*

30 **Sec. 4. 1. Except as otherwise provided in NRS 484.752,**
31 **before the Department of Transportation reduces the maximum**
32 **weight limits as prescribed in NRS 484.745, 484.748 and 484.7485**
33 **on a highway under its jurisdiction, the Department of**
34 **Transportation shall:**

35 (a) *Consider:*

36 (1) *The average number of vehicles traveling on the*
37 *highway each day;*

38 (2) *The number of vehicles that have a declared gross*
39 *weight in excess of 26,000 pounds that are included in the average*
40 *number pursuant to subparagraph (1);*

41 (3) *The availability of alternate routes to the highway;*



- 1 (4) *The impact on each alternate route of increased traffic*
2 *consisting of vehicles that have a declared gross weight in excess*
3 *of 26,000 pounds;*
4 (5) *The number of traffic accidents involving a vehicle that*
5 *has a declared gross weight in excess of 26,000 pounds on the*
6 *highway in the past 5 years;*
7 (6) *Any projected adverse economic or environmental*
8 *impact resulting from reducing the maximum weight limits on the*
9 *highway; and*
10 (7) *Any other factors the Department of Transportation*
11 *deems appropriate; and*
12 (b) *Present such considerations to the Board of Directors of*
13 *the Department of Transportation to receive the Board's approval*
14 *to reduce the maximum weight limits pursuant to this section.*
