AN ACT relating to public health; revising provisions concerning
the billing form that a hospital in this State is required to
use for all patients discharged from the hospital; and
providing other matters properly relating thereto.

Legislative Counsel’s Digest:

- 1 This bill eliminates references in existing law to the uniform billing form
2 commonly referred to as the “UB-82,” therefore requiring hospitals to use the
3 billing form prescribed by the Director of the Department of Health and Human
4 Services with the approval of a majority of the hospitals licensed in this State for all
5 patients discharged. (NRS 449.485, 686A.315)

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 449.485 is hereby amended to read as follows:
2 449.485 1. Each hospital in this State shall use for all patients
3 discharged ~~the form commonly referred to as the “UB-82,” or a~~
4 ~~different~~ **a** form prescribed by the Director with the approval of a
5 majority of the hospitals licensed in this State, and shall include in
6 the form all information required by the Department.

1 2. The Department shall by regulation:
2 (a) Specify the information required to be included in the form
3 for each patient; and

4 (b) Require each hospital to provide specified information from
5 the form to the Department.

6 3. Each insurance company or other payer shall accept the form
7 as the bill for services provided by hospitals in this State.

8 4. Except as otherwise provided in subsection 5, each hospital
9 with 100 or more beds shall provide the information required
10 pursuant to paragraph (b) of subsection 2 on magnetic tape or by
11 other means specified by the Department, or shall provide copies of
12 the forms and pay the costs of entering the information manually
13 from the copies.

14 5. The Director may exempt a hospital from the requirements
15 of subsection 4 if requiring the hospital to comply with the
16 requirements would cause the hospital financial hardship.

17 **Sec. 2.** NRS 686A.315 is hereby amended to read as follows:

18 686A.315 1. If a hospital submits to an insurer the form
19 ~~{commonly referred to as the "UB-82," the}~~ *prescribed by the*
20 *Director of the Department of Health and Human Services*
21 *pursuant to NRS 449.485, that* form must contain or be
22 accompanied by a statement ~~{in substantially the following form:}~~

25 Any person who misrepresents or falsifies essential
26 information requested on this form may, upon conviction, be
27 subject to a fine and imprisonment under state or federal law,
28 or both.

30 2. If a person who is licensed to practice one of the health
31 professions regulated by title 54 of NRS submits to an insurer the
32 form commonly referred to as the "HCFA-1500" for a patient who
33 is not covered by any governmental program which offers insurance
34 coverage for health care, the form must be accompanied by a
35 statement ~~{in substantially the following form:}~~ *that reads*
36 *substantially as follows:*

38 Any person who knowingly files a statement of claim
39 containing any misrepresentation or any false, incomplete or
40 misleading information may be guilty of a criminal act
41 punishable under state or federal law, or both, and may be
42 subject to civil penalties.



- 1 3. The failure to provide any of the statements required by this
- 2 section is not a defense in a prosecution for insurance fraud pursuant
- 3 to NRS 686A.291.
- 4 **Sec. 3.** This act becomes effective upon passage and approval.
