SUMMARY—Enacts the Uniform Assignment of Rents Act.

relating thereto.**Legislative Counsel's Digest:**

Nevada has adopted the lien theory of mortgages under which “no title passes to the mortgagee by virtue of the mortgage” and the mortgage grants the mortgagee only a right of security, which is capable of being enforced by foreclosure if the mortgagor defaults on the mortgage obligation. (*Flyge v. Flynn*, 63 Nev. 201, 224 (1946)) Because no title passes to the mortgagee, a mortgage does not by itself convey to the mortgagee the right to collect rents accruing from the mortgaged real property. To address the circumstances which arise when a mortgagee obtains the right to collect rents accruing from the mortgaged real property, the Uniform Law Commissioners promulgated the Uniform Assignment of Rents Act in 2005.

Section 24 of this bill provides that any mortgage, deed of trust or other document that creates a security interest in real property also creates an assignment of rents, which is a security interest in the rents arising from the real property. **Section 25** of this bill allows the assignment of rents to be recorded in the office of the recorder of the county in which the real property is located. Upon recording, the assignment of rents is perfected and takes priority over the rights of a person that acquires a judicial lien against, or purchases an interest in, the rents or the real property from which the rents arise.

Under **section 27** of this bill, an assignee under an assignment of rents may enforce the security interest by petitioning for the appointment of a receiver if the assignor is in default and has agreed to the appointment of a receiver in the event of the assignor's default or if the assignee has been made insecure about the enforcement of the security interest.

Section 28 of this bill allows an assignee to enforce an assignment of rents by means of a notification to the assignor following default. If the assignor fails to pay

over to the assignee any rents he collects following receipt of the notification, section 34 of this bill provides that the assignor is liable to the assignee for the amount of the rents not paid over to the assignee.

Section 29 of this bill provides that an assignee may enforce an assignment of rents by notification to the tenants of the real property following a default by the assignor. Once a tenant receives a notification, the tenant must pay any unpaid accrued rents and any unaccrued rents as they accrue to the assignee. If a tenant pays rent to an assignee following receipt of a notification, the tenant discharges his rental obligation to the assignee. However, unless the tenant occupies the premises as his primary residence, a tenant who pays rent to the assignor following receipt of a notification has not discharged his rental obligations to the assignee.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Title 9 of NRS is hereby amended by adding thereto a new chapter to consist of the provisions set forth as sections 2 to 38, inclusive, of this act.

Sec. 2. *This chapter may be cited as the Uniform Assignment of Rents Act.*

Sec. 3. *As used in this chapter, unless the context otherwise requires, the words and terms defined in sections 4 to 22, inclusive, of this act have the meanings ascribed to them in those sections.*

Sec. 4. *“Assignee” means a person entitled to enforce an assignment of rents.*

Sec. 5. *“Assignment of rents” means a transfer of an interest in rents in connection with an obligation secured by real property located in this State and from which the rents arise.*

Sec. 6. *“Assignor” means a person that makes an assignment of rents or the successor owner of the real property from which the rents arise.*

Sec. 7. *“Cash proceeds” means proceeds that are money, checks, deposit accounts or the like.*

Sec. 8. *“Day” means calendar day.*

Sec. 9. *“Deposit account” means a demand, time, savings, passbook or similar account maintained with a bank, savings bank, savings and loan association, credit union or trust company.*

Sec. 10. *“Document” means information that is inscribed on a tangible medium or that is stored on an electronic or other medium and is retrievable in perceivable form.*

Sec. 11. *“Notification” means a document containing information that this chapter requires a person to provide to another, signed by the person required to provide the information.*

Sec. 12. *“Person” means an individual, corporation, business trust, estate, trust, partnership, limited-liability company,*



1 *association, joint venture, public corporation, government or*
2 *governmental subdivision, agency or instrumentality or any other*
3 *legal or commercial entity.*

4 **Sec. 13.** *“Proceeds” means personal property that is received*
5 *or collected on account of a tenant’s obligation to pay rents.*

6 **Sec. 14.** *“Purchase” means to take by sale, lease, discount,*
7 *negotiation, mortgage, pledge, lien, security interest, issue or*
8 *reissue, gift or any other voluntary transaction creating an interest*
9 *in property.*

10 **Sec. 15.** *“Rents” means:*

11 *1. Sums payable for the right to possess or occupy, or for the*
12 *actual possession or occupation of, real property of another*
13 *person;*

14 *2. Sums payable to an assignor under a policy of rental*
15 *interruption insurance covering real property;*

16 *3. Claims arising out of a default in the payment of sums*
17 *payable for the right to possess or occupy real property of another*
18 *person;*

19 *4. Sums payable to terminate an agreement to possess or*
20 *occupy real property of another person;*

21 *5. Sums payable to an assignor for payment or*
22 *reimbursement of expenses incurred in owning, operating and*
23 *maintaining, or constructing or installing improvements on, real*
24 *property; or*

25 *6. Any other sums payable under an agreement relating to*
26 *the real property of another person that constitute rents under law*
27 *of this State other than this chapter.*

28 **Sec. 16.** *“Secured obligation” means an obligation the*
29 *performance of which is secured by an assignment of rents.*

30 **Sec. 17.** *“Security instrument” means a document, however*
31 *denominated, that creates or provides for a security interest in real*
32 *property, whether or not it also creates or provides for a security*
33 *interest in personal property.*

34 **Sec. 18.** *“Security interest” means an interest in property*
35 *that arises by agreement and secures performance of an*
36 *obligation.*

37 **Sec. 19.** *“Sign” means, with present intent to authenticate or*
38 *adopt a document:*

39 *1. To execute or adopt a tangible symbol; or*

40 *2. To attach to or logically associate with the document an*
41 *electronic sound, symbol or process.*

42 **Sec. 20.** *“State” means a state of the United States, the*
43 *District of Columbia, Puerto Rico, the United States Virgin*
44 *Islands or any territory or insular possession subject to the*
45 *jurisdiction of the United States.*



1 **Sec. 21.** *“Submit for recording” means to submit a document*
2 *complying with applicable legal standards, with required fees and*
3 *taxes, to the appropriate governmental office pursuant to NRS*
4 *111.310 to 111.365, inclusive.*

5 **Sec. 22.** *“Tenant” means a person that has an obligation to*
6 *pay sums for the right to possess or occupy, or for possessing or*
7 *occupying, the real property of another person.*

8 **Sec. 23.** 1. *Except as otherwise provided in subsections 3*
9 *and 4, a person gives a notification or a copy of a notification*
10 *under this chapter:*

11 (a) *By depositing it with the United States Postal Service or*
12 *with a commercially reasonable delivery service, properly*
13 *addressed to the intended recipient’s address as specified in*
14 *subsection 2, with first-class postage or cost of delivery provided*
15 *for; or*

16 (b) *If the recipient agreed to receive notification by facsimile*
17 *transmission, electronic mail or other electronic transmission, by*
18 *sending it to the recipient in the agreed manner at the address*
19 *specified in the agreement.*

20 2. *The following rules determine the proper address for*
21 *giving a notification under subsection 1:*

22 (a) *A person giving a notification to an assignee shall use the*
23 *address for notices to the assignee provided in the document*
24 *creating the assignment of rents, but, if the assignee has provided*
25 *the person giving the notification with a more recent address for*
26 *notices, the person giving the notification shall use that address.*

27 (b) *A person giving a notification to an assignor shall use the*
28 *address for notices to the assignor provided in the document*
29 *creating the assignment of rents, but, if the assignor has provided*
30 *the person giving the notification with a more recent address for*
31 *notices, the person giving the notification shall use that address.*

32 (c) *If a tenant’s agreement with an assignor provides an*
33 *address for notices to the tenant and the person giving notification*
34 *has received a copy of the agreement or knows the address for*
35 *notices specified in the agreement, the person giving the*
36 *notification shall use that address in giving a notification to the*
37 *tenant. Otherwise, the person shall use the address of the premises*
38 *covered by the agreement.*

39 3. *If a person giving a notification pursuant to this chapter*
40 *and the recipient have agreed to the method for giving a*
41 *notification, any notification must be given by that method.*

42 4. *If a notification is received by the recipient, it is effective*
43 *even if it was not given in accordance with subsection 1 or 3.*

44 **Sec. 24.** 1. *An enforceable security instrument creates an*
45 *assignment of rents arising from the real property described in the*



1 security instrument, unless the security instrument provides
2 otherwise.

3 2. An assignment of rents creates a presently effective
4 security interest in all accrued and unaccrued rents arising from
5 the real property described in the document creating the
6 assignment, regardless of whether the document is in the form of
7 an absolute assignment, an absolute assignment conditioned upon
8 default, an assignment as additional security or any other form.
9 The security interest in rents is separate and distinct from any
10 security interest held by the assignee in the real property.

11 **Sec. 25. 1.** A document creating an assignment of rents
12 may be submitted for recording in the office of the recorder of the
13 county in which the real property is located in the same manner as
14 any other document evidencing a conveyance of an interest in real
15 property.

16 2. Upon recording, the security interest in rents created by an
17 assignment of rents is fully perfected, even if a provision of the
18 document creating the assignment or law of this State other than
19 this chapter would preclude or defer enforcement of the security
20 interest until the occurrence of a subsequent event, including,
21 without limitation, a subsequent default of the assignor, the
22 assignee's obtaining possession of the real property or the
23 appointment of a receiver.

24 3. Except as otherwise provided in subsection 4, a perfected
25 security interest in rents takes priority over the rights of a person
26 that, after the security interest is perfected:

27 (a) Acquires a judicial lien against the rents or the real
28 property from which the rents arise; or

29 (b) Purchases an interest in the rents or the real property from
30 which the rents arise.

31 4. A perfected security interest in rents has priority over the
32 rights of a person described in subsection 3 with respect to future
33 advances to the same extent as the assignee's security interest in
34 the real property has priority over the rights of that person with
35 respect to future advances.

36 **Sec. 26. 1.** An assignee may enforce an assignment of rents
37 using one or more of the methods specified in sections 27, 28 and
38 29 of this act or any other method sufficient to enforce the
39 assignment under law of this State other than this chapter.

40 2. From the date of enforcement, the assignee or, in the case
41 of enforcement by appointment of a receiver under section 27 of
42 this act, the receiver is entitled to collect all rents that:

43 (a) Have accrued but remain unpaid on that date; and

44 (b) Accrue on or after that date, as those rents accrue.



1 **Sec. 27. 1. An assignee is entitled to the appointment of a**
2 **receiver for the real property subject to the assignment of rents if:**

3 **(a) The assignor is in default and:**

4 **(1) The assignor has agreed in a signed document to the**
5 **appointment of a receiver in the event of the assignor's default;**

6 **(2) It appears likely that the real property may not be**
7 **sufficient to satisfy the secured obligation;**

8 **(3) The assignor has failed to turn over to the assignee**
9 **proceeds that the assignee was entitled to collect; or**

10 **(4) A subordinate assignee of rents obtains the appointment**
11 **of a receiver for the real property; or**

12 **(b) Other circumstances exist that would justify the**
13 **appointment of a receiver under law of this State other than this**
14 **chapter.**

15 **2. An assignee may file a petition for the appointment of a**
16 **receiver in connection with an action:**

17 **(a) To foreclose the security instrument;**

18 **(b) For specific performance of the assignment;**

19 **(c) Seeking a remedy on account of waste or threatened waste**
20 **of the real property subject to the assignment; or**

21 **(d) Otherwise to enforce the secured obligation or the**
22 **assignee's remedies arising from the assignment.**

23 **3. An assignee that files a petition under subsection 2 shall**
24 **also give a copy of the petition in the manner specified in section**
25 **23 of this act to any other person that, 10 days before the date the**
26 **petition is filed, held a recorded assignment of rents arising from**
27 **the real property.**

28 **4. If an assignee enforces an assignment of rents under this**
29 **section, the date of enforcement is the date on which the court**
30 **enters an order appointing a receiver for the real property subject**
31 **to the assignment.**

32 **5. From the date of its appointment, a receiver is entitled to**
33 **collect rents as provided in subsection 2 of section 26 of this act.**
34 **The receiver also has the authority provided in the order of**
35 **appointment and law of this State other than this chapter.**

36 **6. The following rules govern priority among receivers:**

37 **(a) If more than one assignee qualifies under this section for**
38 **the appointment of a receiver, a receivership requested by an**
39 **assignee entitled to priority in rents under this chapter has priority**
40 **over a receivership requested by a subordinate assignee, even if a**
41 **court has previously appointed a receiver for the subordinate**
42 **assignee.**

43 **(b) If a subordinate assignee obtains the appointment of a**
44 **receiver, the receiver may collect the rents and apply the proceeds**



1 *in the manner specified in the order appointing the receiver until a*
2 *receiver is appointed under a senior assignment of rents.*

3 **Sec. 28.** 1. *Upon the assignor's default, or as otherwise*
4 *agreed by the assignor, the assignee may give the assignor a*
5 *notification demanding that the assignor pay over the proceeds of*
6 *any rents that the assignee is entitled to collect under section 26 of*
7 *this act. The assignee shall also give a copy of the notification to*
8 *any other person that, 10 days before the notification date, held a*
9 *recorded assignment of rents arising from the real property.*

10 2. *If an assignee enforces an assignment of rents under this*
11 *section, the date of enforcement is the date on which the assignor*
12 *receives a notification under subsection 1.*

13 3. *An assignee's failure to give a notification under*
14 *subsection 1 to any person holding a recorded assignment of rents*
15 *does not affect the effectiveness of the notification as to the*
16 *assignor, but the other person is entitled to any relief permitted*
17 *under law of this State other than this chapter.*

18 4. *An assignee that holds a security interest in rents solely by*
19 *virtue of subsection 1 of section 24 of this act may not enforce the*
20 *security interest under this section while the assignor occupies the*
21 *real property as the assignor's primary residence.*

22 **Sec. 29.** 1. *Upon the assignor's default, or as otherwise*
23 *agreed by the assignor, the assignee may give to a tenant of the*
24 *real property a notification demanding that the tenant pay to the*
25 *assignee all unpaid accrued rents and all unaccrued rents as they*
26 *accrue. The assignee shall give a copy of the notification to the*
27 *assignor and to any other person that, 10 days before the*
28 *notification date, held a recorded assignment of rents arising from*
29 *the real property. The notification must be signed by the assignee*
30 *and:*

31 (a) *Identify the tenant, assignor, assignee, premises covered by*
32 *the agreement between the tenant and the assignor and*
33 *assignment of rents being enforced;*

34 (b) *Provide the recording data for the document creating the*
35 *assignment or other reasonable proof that the assignment was*
36 *made;*

37 (c) *State that the assignee has the right to collect rents in*
38 *accordance with the assignment;*

39 (d) *Direct the tenant to pay to the assignee all unpaid accrued*
40 *rents and all unaccrued rents as they accrue;*

41 (e) *Describe the manner in which subsections 3 and 4 affect*
42 *the tenant's payment obligations;*

43 (f) *Provide the name and telephone number of a contact*
44 *person and an address to which the tenant can direct payment of*



1 rents and any inquiry for additional information about the
2 assignment or the assignee's right to enforce the assignment; and

3 (g) Contain a statement that the tenant may consult a lawyer if
4 the tenant has questions about its rights and obligations.

5 2. If an assignee enforces an assignment of rents under this
6 section, the date of enforcement is the date on which the tenant
7 receives a notification substantially complying with subsection 1.

8 3. Subject to subsection 4 and any other claim or defense that
9 a tenant has under law of this State other than this chapter,
10 following receipt of a notification substantially complying with
11 subsection 1:

12 (a) A tenant is obligated to pay to the assignee all unpaid
13 accrued rents and all unaccrued rents as they accrue, unless the
14 tenant has previously received a notification from another
15 assignee of rents given by that assignee in accordance with this
16 section and the other assignee has not cancelled that notification;

17 (b) Unless the tenant occupies the premises as the tenant's
18 primary residence, a tenant that pays rents to the assignor is not
19 discharged from the obligation to pay rents to the assignee;

20 (c) A tenant's payment to the assignee of rents then due
21 satisfies the tenant's obligation under the tenant's agreement with
22 the assignor to the extent of the payment made; and

23 (d) A tenant's obligation to pay rents to the assignee continues
24 until the tenant receives a court order directing the tenant to pay
25 the rent in a different manner or a signed document from the
26 assignee cancelling its notification, whichever occurs first.

27 4. A tenant that has received a notification under subsection
28 1 is not in default for nonpayment of rents accruing within 30
29 days after the date the notification is received before the earlier of:

30 (a) Ten days after the date the next regularly scheduled rental
31 payment would be due; or

32 (b) Thirty days after the date the tenant receives the
33 notification.

34 5. Upon receiving a notification from another creditor that is
35 entitled to priority under subsection 3 of section 25 of this act that
36 the other creditor has enforced and is continuing to enforce its
37 interest in rents, an assignee that has given a notification to a
38 tenant under subsection 1 shall immediately give another
39 notification to the tenant cancelling the earlier notification.

40 6. An assignee's failure to give a notification under
41 subsection 1 to any person holding a recorded assignment of rents
42 does not affect the effectiveness of the notification as to the
43 assignor and those tenants receiving the notification. However, the
44 person entitled to the notification is entitled to any relief permitted
45 by law of this State other than this chapter.



7. An assignee that holds a security interest in rents solely by virtue of subsection 1 of section 24 of this act may not enforce the security interest under this section while the assignor occupies the real property as the assignor's primary residence.

Sec. 30. No particular phrasing is required for the notification specified in section 29 of this act. However, the following form of notification, when properly completed, is sufficient to satisfy the requirements of section 29 of this act:

1. The Assignee named above has become the person entitled to collect your rents on the Premises listed above under _____ (Name of document) (the "Assignment of Rents") dated _____ (Date), and recorded at _____ (Recording data) in the _____ (Appropriate governmental office under NRS 111.310 to 111.365, inclusive). You may obtain additional information about the Assignment of Rents and the Assignee's right to enforce it at the address listed above.

2. The Landlord is in default under the Assignment of Rents. Under the Assignment of Rents, the Assignee is entitled to collect rents from the Premises.



3. This notification affects your rights and obligations under the agreement under which you occupy the Premises (your "Agreement"). In order to provide you with an opportunity to consult with a lawyer, if your next scheduled rental payment is due within 30 days after you receive this notification, neither the Assignee nor the Landlord can hold you in default under your Agreement for nonpayment of that rental payment until 10 days after the due date of that payment or 30 days following the date you receive this notification, whichever occurs first. You may consult a lawyer at your expense concerning your rights and obligations under your Agreement and the effect of this notification.

4. You must pay to the Assignee at the address listed above all rents under your Agreement which are due and payable on the date you receive this notification and all rents accruing under your Agreement after you receive this notification. If you pay rents to the Assignee after receiving this notification, the payment will satisfy your rental obligation to the extent of that payment.

5. Unless you occupy the Premises as your primary residence, if you pay any rents to the Landlord after receiving this notification, your payment to the Landlord will not discharge your rental obligation, and the Assignee may hold you liable for that rental obligation notwithstanding your payment to the Landlord.

6. If you have previously received a notification from another person that also holds an assignment of the rents due under your Agreement, you should continue paying your rents to the person that sent that notification until that person cancels that notification. Once that notification is cancelled, you must begin paying rents to the Assignee in accordance with this notification.

7. Your obligation to pay rents to the Assignee will continue until you receive either:

(a) A written order from a court directing you to pay the rent in a manner specified in that order; or

(b) Written instructions from the Assignee cancelling this notification.

Sec. 31. The enforcement of an assignment of rents by one or more of the methods identified in sections 27, 28 and 29 of this act, the application of proceeds by the assignee under section 32 of this act after enforcement, the payment of expenses under section

33 of this act or an action under subsection 3 of section 34 of this act does not:

1. Make the assignee a mortgagee in possession of the real property;
2. Make the assignee an agent of the assignor;
3. Constitute an election of remedies that precludes a later action to enforce the secured obligation;
4. Make the secured obligation unenforceable;
5. Limit any right available to the assignee with respect to the secured obligation; or
6. Violate the provisions of NRS 40.430.

Sec. 32. Unless otherwise agreed, an assignee that collects rents under this chapter or collects upon a judgment in an action under subsection 3 of section 34 of this act shall apply the sums collected in the following order to:

1. The assignee's reasonable expenses of enforcing its assignment of rents, including, without limitation, to the extent provided for by agreement and not prohibited by law of this State other than this chapter, reasonable attorney's fees and costs incurred by the assignee;
2. Reimbursement of any expenses incurred by the assignee to protect or maintain the real property subject to the assignment;
3. Payment of the secured obligation;
4. Payment of any obligation secured by a subordinate security interest or other lien on the rents if, before distribution of the proceeds, the assignor and assignee receive a notification from the holder of the interest or lien demanding payment of the proceeds; and
5. The assignor.

Sec. 33. 1. Unless otherwise agreed by the assignee, and subject to subsection 3, an assignee that collects rents following enforcement under section 28 or 29 of this act need not apply them to the payment of expenses of protecting or maintaining the real property subject to the assignment.

2. Unless a tenant has made an enforceable agreement not to assert claims or defenses, the right of the assignee to collect rents from the tenant is subject to the terms of the agreement between the assignor and tenant and any claim or defense arising from the assignor's nonperformance of that agreement.

3. This chapter does not limit the standing or right of a tenant to request a court to appoint a receiver for the real property subject to the assignment or to seek other relief on the ground that the assignee's nonpayment of expenses of protecting or maintaining the real property has caused or threatened harm to the tenant's interest in the property. Whether the tenant is entitled



1 *to the appointment of a receiver or other relief is governed by law*
2 *of this State other than this chapter.*

3 **Sec. 34. 1.** *If an assignor collects rents that the assignee is*
4 *entitled to collect under this chapter:*

5 *(a) The assignor shall turn over the proceeds to the assignee,*
6 *less any amount representing payment of expenses authorized by*
7 *the assignee; and*

8 *(b) The assignee continues to have a security interest in the*
9 *proceeds so long as they are identifiable.*

10 **2.** *For purposes of this chapter, cash proceeds are identifiable*
11 *if they are maintained in a segregated account or, if commingled*
12 *with other funds, to the extent the assignee can identify them by a*
13 *method of tracing, including, without limitation, application of*
14 *equitable principles, that is permitted under law of this State other*
15 *than this chapter with respect to commingled funds.*

16 **3.** *In addition to any other remedy available to the assignee*
17 *under law of this State other than this chapter, if an assignor fails*
18 *to turn over proceeds to the assignee as required by subsection 1,*
19 *the assignee may recover from the assignor in a civil action:*

20 *(a) The proceeds, or an amount equal to the proceeds, that the*
21 *assignor was obligated to turn over under subsection 1; and*

22 *(b) Reasonable attorney's fees and costs incurred by the*
23 *assignee to the extent provided for by agreement and not*
24 *prohibited by law of this State other than this chapter.*

25 **4.** *The assignee may maintain an action under subsection 3*
26 *without bringing an action to foreclose any security interest that it*
27 *may have in the real property. Any sums recovered in the action*
28 *must be applied in the manner specified in section 32 of this act.*

29 **5.** *Unless otherwise agreed, if an assignee entitled to priority*
30 *under subsection 3 of section 25 of this act enforces its interest in*
31 *rents after another creditor holding a subordinate security interest*
32 *in rents has enforced its interest under section 28 or 29 of this act,*
33 *the creditor holding the subordinate security interest in rents is not*
34 *obligated to turn over any proceeds that it collects in good faith*
35 *before the creditor receives notification that the senior assignee*
36 *has enforced its interest in rents. The creditor shall turn over to*
37 *the senior assignee any proceeds that it collects after it receives the*
38 *notification.*

39 **6.** *As used in this section, "good faith" means honesty in fact*
40 *and the observance of reasonable commercial standards of fair*
41 *dealing.*

21 *conflict between that person and a secured party with a conflicting*
22 *security interest in the proceeds.*

23 **Sec. 36.** *This chapter does not preclude subordination by*
24 *agreement as to rents or proceeds.*

25 **Sec. 37.** *In applying and construing the Uniform Assignment*
26 *of Rents Act, consideration must be given to the need to promote*

39 *signed and delivered before October 1, 2007.*
