SUMMARY—Adopts the Revised Uniform Anatomical Gift Act.

AN ACT relating to anatomical gifts; adopting the Revised Uniform Anatomical Gift Act; providing penalties; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Under existing law, Nevada has enacted the Uniform Anatomical Gift Act, which establishes the rights of donors and other authorized persons to affirmatively make anatomical gifts of human bodies and parts for the purpose of transplantation, therapy, research or education. The existing Uniform Act also sets forth various requirements and procedures for making, amending, revoking and refusing to make anatomical gifts. (NRS 451.500-451.590)

This bill replaces the existing Uniform Act with the Revised Uniform Anatomical Gift Act. This bill retains many of the provisions of the existing Uniform Act. However, this bill reorganizes and updates various provisions from the existing Uniform Act, and it adds certain new provisions to better facilitate the process of making anatomical gifts.

Section 22 of this bill revises the existing Uniform Act by expanding the persons who may make an anatomical gift to include an agent or guardian of a person under certain circumstances and an emancipated minor, a minor who applies for a driver's license and the parents of an unemancipated minor under certain circumstances.

Section 23 of this bill revises the existing Uniform Act by expanding the methods for making an anatomical gift to include making an anatomical gift on a state-issued identification card, through a donor registry or, during a terminal illness or injury, through any oral or physical communication witnessed by at least two adults, at least one of whom is a disinterested witness.

Section 24 of this bill revises the existing Uniform Act by expanding the methods for amending and revoking an anatomical gift to include destroying or cancelling the record of the anatomical gift, or any part thereof, with the intent to revoke the gift and, during a terminal illness or injury, making any oral or physical communication witnessed by at least two adults, at least one of whom is a disinterested witness.

Section 25 of this bill revises the existing Uniform Act by updating and clarifying the provisions governing a person's right to refuse to make an anatomical gift and the procedures a person must follow to amend or revoke such a refusal.

Section 34 of this bill amends the existing Uniform Act by adding a new prohibition which provides that a person who, in order to obtain a financial gain, intentionally falsifies, forges, conceals, defaces or obliterates a document making, amending or revoking an anatomical gift or refusing to make an anatomical gift is guilty of a category C felony.

Section 58 of this bill amends the existing Uniform Act by increasing the penalty from a category D felony to a category C felony for a person who unlawfully purchases or sells a body part for transplantation or therapy when the body part is intended for an anatomical gift.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Chapter 451 of NRS is hereby amended by adding thereto the provisions set forth as sections 2 to 41, inclusive, of this act.

Sec. 2. *"Adult" means a natural person who is at least 18 years of age.*

Sec. 3. *"Agent" means a natural person:*

1. Authorized to make health-care decisions on the principal's behalf by a power of attorney for health care; or

2. Expressly authorized to make an anatomical gift on the principal's behalf by any other record signed by the principal.

Sec. 4. *"Disinterested witness" means a witness other than the spouse, child, parent, sibling, grandchild, grandparent or guardian of the natural person who makes, amends, revokes or refuses to make an anatomical gift, or another adult who exhibited special care and concern for the natural person. The term does not include a person to which an anatomical gift could pass under section 29 of this act.*

Sec. 5. *"Donor registry" means a database that contains records of anatomical gifts and amendments to or revocations of anatomical gifts. The term includes, without limitation, a donor registry that has entered into a contract with the Department of Motor Vehicles pursuant to NRS 483.340 or 483.840.*

Sec. 6. *"Driver's license" means a license or permit issued by the Department of Motor Vehicles to operate a vehicle, whether or not conditions are attached to the license or permit.*

Sec. 7. *"Eye bank" means a person that is licensed, accredited or regulated under federal or state law to engage in the recovery, screening, testing, processing, storage or distribution of human eyes or portions of human eyes.*



1 **Sec. 8.** *“Guardian” means a person appointed by a court to*
2 *make decisions regarding the support, care, education, health or*
3 *welfare of a natural person. The term does not include a guardian*
4 *ad litem.*

5 **Sec. 9.** *“Know” means to have actual knowledge.*

6 **Sec. 10.** *“Minor” means a natural person who is under 18*
7 *years of age.*

8 **Sec. 11.** *“Organ procurement organization” means a person*
9 *designated by the Secretary of the United States Department of*
10 *Health and Human Services as an organ procurement*
11 *organization.*

12 **Sec. 12.** *“Parent” means a parent whose parental rights have*
13 *not been terminated.*

14 **Sec. 13.** *“Prospective donor” means a natural person who is*
15 *dead or near death and has been determined by a procurement*
16 *organization to have a part that could be medically suitable for*
17 *transplantation, therapy, research or education. The term does not*
18 *include a natural person who has made a refusal.*

19 **Sec. 14.** *“Reasonably available” means able to be contacted*
20 *by a procurement organization without undue effort and willing*
21 *and able to act in a timely manner consistent with existing medical*
22 *criteria necessary for the making of an anatomical gift.*

23 **Sec. 15.** *“Recipient” means a natural person into whose body*
24 *a decedent’s part has been or is intended to be transplanted.*

25 **Sec. 16.** *“Record” means information that is inscribed on a*
26 *tangible medium or that is stored in an electronic or other medium*
27 *and is retrievable in perceivable form.*

28 **Sec. 17.** *“Refusal” means a record created under section 25*
29 *of this act that expressly states an intent to bar other persons from*
30 *making an anatomical gift of a natural person’s body or part.*

31 **Sec. 18.** *“Sign” means, with the present intent to*
32 *authenticate or adopt a record:*

33 1. *To execute or adopt a tangible symbol; or*

34 2. *To attach to or logically associate with the record an*
35 *electronic symbol, sound or process.*

36 **Sec. 19.** *“Tissue” means a portion of the human body other*
37 *than an organ or an eye. The term does not include blood unless*
38 *the blood is donated for the purpose of research or education.*

39 **Sec. 20.** *“Tissue bank” means a person that is licensed,*
40 *accredited or regulated under federal or state law to engage in the*
41 *recovery, screening, testing, processing, storage or distribution of*
42 *tissue.*

43 **Sec. 21.** *“Transplant hospital” means a hospital that*
44 *furnishes organ transplants and other medical and surgical*
45 *specialty services required for the care of transplant patients.*



1 **Sec. 22.** *Subject to section 26 of this act, an anatomical gift*
2 *of a donor's body or part may be made during the life of the donor*
3 *for the purpose of transplantation, therapy, research or education*
4 *in the manner provided in section 23 of this act by:*

5 1. *The donor, if the donor is an adult or if the donor is a*
6 *minor and is:*

7 (a) *Emancipated; or*

8 (b) *Authorized under state law to apply for a driver's license*
9 *because the donor is at least 16 years of age;*

10 2. *An agent of the donor, unless the power of attorney for*
11 *health care or other record prohibits the agent from making an*
12 *anatomical gift;*

13 3. *A parent of the donor, if the donor is an unemancipated*
14 *minor; or*

15 4. *The donor's guardian.*

16 **Sec. 23.** 1. *A donor may make an anatomical gift:*

17 (a) *By authorizing a statement or symbol indicating that the*
18 *donor has made an anatomical gift to be imprinted on the donor's*
19 *driver's license or identification card;*

20 (b) *In a will;*

21 (c) *During a terminal illness or injury of the donor, by any*
22 *form of communication addressed to at least two adults, at least*
23 *one of whom is a disinterested witness; or*

24 (d) *As provided in subsection 2.*

25 2. *A donor or other person authorized to make an anatomical*
26 *gift under section 22 of this act may make a gift by a donor card or*
27 *other record signed by the donor or other person making the gift*
28 *or by authorizing that a statement or symbol indicating that the*
29 *donor has made an anatomical gift be included on a donor*
30 *registry. If the donor or other person is physically unable to sign a*
31 *record, the record may be signed by another natural person at the*
32 *direction of the donor or other person and must:*

33 (a) *Be witnessed by at least two adults, at least one of whom is*
34 *a disinterested witness, who have signed at the request of the*
35 *donor or the other person; and*

36 (b) *State that it has been signed and witnessed as provided in*
37 *paragraph (a).*

38 3. *Revocation, suspension, expiration or cancellation of a*
39 *driver's license or identification card upon which an anatomical*
40 *gift is indicated does not invalidate the gift.*

41 4. *An anatomical gift made by will takes effect upon the*
42 *donor's death whether or not the will is probated. Invalidation of*
43 *the will after the donor's death does not invalidate the gift.*

Sec. 24. 1. *Subject to section 26 of this act, a donor or other person authorized to make an anatomical gift under section 22 of this act may amend or revoke an anatomical gift by:*

(a) A record signed by:

(1) The donor;

(2) The other person; or

(3) Subject to subsection 2, another natural person acting at the direction of the donor or the other person if the donor or other person is physically unable to sign; or

(b) A later-executed document of gift that amends or revokes a previous anatomical gift or portion of an anatomical gift, either expressly or by inconsistency.

2. *A record signed pursuant to subparagraph (3) of paragraph (a) of subsection 1 must:*

(a) Be witnessed by at least two adults, at least one of whom is a disinterested witness, who have signed at the request of the donor or the other person; and

(b) State that it has been signed and witnessed as provided in paragraph (a).

3. *Subject to section 26 of this act, a donor or other person authorized to make an anatomical gift under section 22 of this act may revoke an anatomical gift by the destruction or cancellation of the document of gift, or the portion of the document of gift used to make the gift, with the intent to revoke the gift.*

4. *A donor may amend or revoke an anatomical gift that was not made in a will by any form of communication during a terminal illness or injury addressed to at least two adults, at least one of whom is a disinterested witness.*

5. *A donor who makes an anatomical gift in a will may amend or revoke the gift in the manner provided for amendment or revocation of wills or as provided in subsection 1.*

Sec. 25. 1. *A natural person may refuse to make an anatomical gift of his body or part by:*

(a) A record signed by:

(1) Him; or

(2) Subject to subsection 2, another natural person acting at his direction if he is physically unable to sign;

(b) His will, whether or not the will is admitted to probate or invalidated after his death; or

(c) Any form of communication made by him during his terminal illness or injury addressed to at least two adults, at least one of whom is a disinterested witness.

2. *A record signed pursuant to subparagraph (2) of paragraph (a) of subsection 1 must:*



1 (a) Be witnessed by at least two adults, at least one of whom is
2 a disinterested witness, who have signed at the request of the
3 natural person; and

4 (b) State that it has been signed and witnessed as provided in
5 paragraph (a).

6 3. A natural person who has made a refusal may amend or
7 revoke the refusal:

8 (a) In the manner provided in subsection 1 for making a
9 refusal;

10 (b) By subsequently making an anatomical gift pursuant to
11 section 23 of this act that is inconsistent with the refusal; or

12 (c) By destroying or cancelling the record evidencing the
13 refusal, or the portion of the record used to make the refusal, with
14 the intent to revoke the refusal.

15 4. Except as otherwise provided in subsection 8 of section 26
16 of this act, in the absence of an express, contrary indication by the
17 natural person set forth in the refusal, a natural person's
18 unrevoked refusal to make an anatomical gift of his body or part
19 bars all other persons from making an anatomical gift of his body
20 or part.

21 **Sec. 26. 1.** Except as otherwise provided in subsection 7
22 and subject to subsection 6, in the absence of an express, contrary
23 indication by the donor, a person other than the donor is barred
24 from making, amending or revoking an anatomical gift of a
25 donor's body or part if the donor made an anatomical gift of the
26 donor's body or part under section 23 of this act or an amendment
27 to an anatomical gift of the donor's body or part under section 24
28 of this act.

29 2. A donor's revocation of an anatomical gift of the donor's
30 body or part under section 24 of this act is not a refusal and does
31 not bar another person specified in section 22 or 27 of this act
32 from making an anatomical gift of the donor's body or part under
33 section 23 or 28 of this act.

34 3. If a person other than the donor makes an unrevoked
35 anatomical gift of the donor's body or part under section 23 of this
36 act or an amendment to an anatomical gift of the donor's body or
37 part under section 24 of this act, another person may not make,
38 amend or revoke the gift of the donor's body or part under section
39 28 of this act.

40 4. A revocation of an anatomical gift of a donor's body or
41 part under section 24 of this act by a person other than the donor
42 does not bar another person from making an anatomical gift of
43 the body or part under section 23 or 28 of this act.

44 5. In the absence of an express, contrary indication by the
45 donor or other person authorized to make an anatomical gift

1 *under section 22 of this act, an anatomical gift of a part is neither*
2 *a refusal to give another part nor a limitation on the making of an*
3 *anatomical gift of another part at a later time by the donor or*
4 *another person.*

5 *6. In the absence of an express, contrary indication by the*
6 *donor or other person authorized to make an anatomical gift*
7 *under section 22 of this act, an anatomical gift of a part for one or*
8 *more of the purposes set forth in section 22 of this act is not a*
9 *limitation on the making of an anatomical gift of the part for any*
10 *of the other purposes by the donor or any other person under*
11 *section 23 or 28 of this act.*

12 *7. If a donor who is an unemancipated minor dies, a parent*
13 *of the donor who is reasonably available may revoke or amend an*
14 *anatomical gift of the donor's body or part.*

15 *8. If an unemancipated minor who signed a refusal dies, a*
16 *parent of the minor who is reasonably available may revoke the*
17 *minor's refusal.*

18 **Sec. 27. 1.** *Subject to subsections 2 and 3 and unless barred*
19 *by section 25 or 26 of this act, an anatomical gift of a decedent's*
20 *body or part for the purpose of transplantation, therapy, research*
21 *or education may be made by any member of the following classes*
22 *of persons who is reasonably available, in the order of priority*
23 *listed:*

24 *(a) An agent of the decedent at the time of death who could*
25 *have made an anatomical gift under subsection 2 of section 22 of*
26 *this act immediately before the decedent's death;*

27 *(b) The spouse of the decedent;*

28 *(c) Adult children of the decedent;*

29 *(d) Parents of the decedent;*

30 *(e) Adult siblings of the decedent;*

31 *(f) Adult grandchildren of the decedent;*

32 *(g) Grandparents of the decedent;*

33 *(h) An adult who exhibited special care and concern for the*
34 *decedent;*

35 *(i) The persons who were acting as the guardians of the person*
36 *of the decedent at the time of death; and*

37 *(j) Any other person having the authority to dispose of the*
38 *decedent's body.*

39 **2.** *If there is more than one member of a class listed in*
40 *paragraphs (a), (c), (d), (e), (f), (g) or (i) of subsection 1 entitled to*
41 *make an anatomical gift, an anatomical gift may be made by a*
42 *member of the class unless that member or a person to which the*
43 *gift may pass under section 29 of this act knows of an objection by*
44 *another member of the class. If an objection is known, the gift*



1 *may be made only by a majority of the members of the class who*
2 *are reasonably available.*

3 3. *A person may not make an anatomical gift if, at the time of*
4 *the decedent's death, a person in a prior class under subsection 1*
5 *is reasonably available to make or to object to the making of an*
6 *anatomical gift.*

7 **Sec. 28.** 1. *A person authorized to make an anatomical gift*
8 *under section 27 of this act may make an anatomical gift by a*
9 *document of gift signed by the person making the gift or by that*
10 *person's oral communication that is electronically recorded or is*
11 *contemporaneously reduced to a record and signed by the natural*
12 *person receiving the oral communication.*

13 2. *Subject to subsection 3, an anatomical gift by a person*
14 *authorized under section 27 of this act may be amended or*
15 *revoked orally or in a record by any member of a prior class who*
16 *is reasonably available. If more than one member of the prior*
17 *class is reasonably available, the gift made by a person authorized*
18 *under section 27 of this act may be:*

19 (a) *Amended only if a majority of the reasonably available*
20 *members agree to the amending of the gift; or*

21 (b) *Revoked only if a majority of the reasonably available*
22 *members agree to the revoking of the gift or if they are equally*
23 *divided as to whether to revoke the gift.*

24 3. *A revocation under subsection 2 is effective only if, before*
25 *an incision has been made to remove a part from the donor's body*
26 *or before invasive procedures have begun to prepare the recipient,*
27 *the procurement organization, transplant hospital or physician or*
28 *technician knows of the revocation.*

29 **Sec. 29.** 1. *An anatomical gift may be made to the*
30 *following persons named in the document of gift:*

31 (a) *A hospital, accredited medical school, dental school,*
32 *college, university, organ procurement organization or other*
33 *appropriate person, for research or education;*

34 (b) *Subject to subsection 2, a natural person designated by the*
35 *person making the anatomical gift if the natural person is the*
36 *recipient of the part; or*

37 (c) *An eye bank or tissue bank.*

38 2. *If an anatomical gift to a natural person under paragraph*
39 *(b) of subsection 1 is not medically suitable for transplantation*
40 *into the natural person, the gift, in the absence of an express,*
41 *contrary indication by the person making the gift:*

42 (a) *If it is medically suitable for transplantation or therapy for*
43 *other natural persons, must be used for transplantation or*
44 *therapy, and the gift passes in accordance with subsection 8.*



(b) If it is not medically suitable for transplantation or therapy for other natural persons, may be used for research or education and, if so used, the gift passes to the appropriate procurement, research or educational organization or other appropriate person for research or education.

3. If an anatomical gift of one or more specific parts or of all parts is made in a document of gift that does not name a person described in subsection 1 but identifies the purpose for which an anatomical gift may be used, the following rules apply:

(a) If the part is an eye and the gift is for the purpose of transplantation or therapy, the gift passes to the appropriate eye bank.

(b) If the part is tissue and the gift is for the purpose of transplantation or therapy, the gift passes to the appropriate tissue bank.

(c) If the part is an organ and the gift is for the purpose of transplantation or therapy, the gift passes to the appropriate organ procurement organization as custodian of the organ.

(d) If the part is an organ, an eye or tissue and the gift is for the purpose of research or education, the gift passes to the appropriate procurement, research or educational organization or other appropriate person for research or education.

4. For the purpose of subsection 3, if there is more than one purpose of an anatomical gift set forth in the document of gift but the purposes are not set forth in any priority, the gift, in the absence of an express, contrary indication by the person making the gift:

(a) If it is medically suitable for transplantation or therapy, must be used for transplantation or therapy, and the gift passes in accordance with paragraphs (a), (b) and (c) of subsection 3.

(b) If it is not medically suitable for transplantation or therapy, may be used for research or education and, if so used, the gift passes to the appropriate procurement, research or educational organization or other appropriate person for research or education.

5. If an anatomical gift of one or more specific parts is made in a document of gift that does not name a person described in subsection 1 and does not identify the purpose of the gift, the gift, in the absence of an express, contrary indication by the person making the gift:

(a) If it is medically suitable for transplantation or therapy, must be used for transplantation or therapy, and the gift passes in accordance with subsection 8.

(b) If it is not medically suitable for transplantation or therapy, may be used for research or education and, if so used, the gift

4 6. *If a document of gift specifies only a general intent to*
5 *make an anatomical gift by words such as “donor” or “organ*

9 (a) *If it is medically suitable for transplantation or therapy,*
10 *must be used for transplantation or therapy, and the gift passes in*
11 *accordance with subsection 8.*

12 (b) *If it is not medically suitable for transplantation or therapy,*
13 *may be used for research or education and, if so used, the gift*
14 *passes to the appropriate procurement, research or educational*
15 *organization or other appropriate person for research or*
16 *education.*

17 7. *If a document of gift specifies only a general intent to*
18 *make an anatomical gift by words such as “body donor” or by a*
19 *symbol or statement of similar import, the gift, in the absence of*
20 *an express, contrary indication by the person making the gift:*

21 (a) *If any part is medically suitable for transplantation or*
22 *therapy, must be used for transplantation or therapy, and the gift*
23 *passes in accordance with subsection 8.*

24 (b) *If any part is not medically suitable for transplantation or*
25 *therapy, may be used for research or education and, if so used, the*
26 *gift passes to the appropriate procurement, research or*
27 *educational organization or other appropriate person for research*
28 *or education.*

29 8. *For purposes of subsections 2, 5, 6 and 7, if an anatomical*
30 *gift is medically suitable for transplantation or therapy, the*
31 *following rules apply:*

32 (a) *If the part is an eye, the gift passes to the appropriate eye*
33 *bank.*

34 (b) *If the part is tissue, the gift passes to the appropriate tissue*
35 *bank.*

36 (c) *If the part is an organ, the gift passes to the appropriate*
37 *organ procurement organization as custodian of the organ.*

38 9. *An anatomical gift of an organ for transplantation or*
39 *therapy, other than an anatomical gift under paragraph (b) of*
40 *subsection 1, passes to the organ procurement organization as*
41 *custodian of the organ.*

42 10. *If an anatomical gift does not pass pursuant to*
43 *subsections 1 to 9, inclusive, or the decedent’s body or part is not*
44 *used for transplantation, therapy, research or education, custody*



1 *of the body or part passes to the person under obligation to dispose*
2 *of the body or part.*

3 *11. A person may not accept an anatomical gift if the person*
4 *knows that the gift was not effectively made under section 23 or 28*
5 *of this act or if the person knows that the decedent made a refusal*
6 *under section 25 of this act that was not revoked. For purposes of*
7 *this subsection, if a person knows that an anatomical gift was*
8 *made on a document of gift, the person is deemed to know of any*
9 *amendment or revocation of the gift or any refusal to make an*
10 *anatomical gift on the same document of gift.*

11 *12. Except as otherwise provided in paragraph (b) of*
12 *subsection 1, nothing in NRS 451.500 to 451.590, inclusive, and*
13 *sections 2 to 41, inclusive, of this act affects the allocation of*
14 *organs for transplantation or therapy.*

15 **Sec. 30.** *1. The following persons shall make a reasonable*
16 *search of a natural person who the person reasonably believes is*
17 *dead or near death for a document of gift or other information*
18 *identifying the natural person as a donor or as a natural person*
19 *who made a refusal:*

20 *(a) A law enforcement officer, firefighter, paramedic or other*
21 *emergency rescuer finding the natural person; and*

22 *(b) If no other source of the information is immediately*
23 *available, a hospital, as soon as practical after the natural*
24 *person's arrival at the hospital.*

25 *2. If a document of gift or a refusal to make an anatomical*
26 *gift is located by the search required by paragraph (a) of*
27 *subsection 1 and the natural person or deceased natural person to*
28 *whom it relates is taken to a hospital, the person responsible for*
29 *conducting the search shall send the document of gift or refusal to*
30 *the hospital.*

31 *3. A person is not subject to criminal or civil liability for*
32 *failing to discharge the duties imposed by this section but may be*
33 *subject to administrative sanctions.*

34 **Sec. 31.** *1. A document of gift need not be delivered during*
35 *the donor's lifetime to be effective.*

36 *2. Upon or after a natural person's death, a person in*
37 *possession of a document of gift or a refusal to make an*
38 *anatomical gift with respect to the natural person shall allow*
39 *examination and copying of the document of gift or refusal by a*
40 *person authorized to make or object to the making of an*
41 *anatomical gift with respect to the natural person or by a person to*
42 *which the gift could pass under section 29 of this act.*

43 **Sec. 32.** *1. When a hospital refers a natural person at or*
44 *near death to a procurement organization, the organization shall*
45 *make a reasonable search of the records of any donor registry that*



1 *it knows exists for the geographical area in which the natural*
2 *person resides to ascertain whether the natural person has made*
3 *an anatomical gift.*

4 2. *When a hospital refers a natural person at or near death to*
5 *a procurement organization, the organization may conduct any*
6 *reasonable examination necessary to ensure the medical*
7 *suitability of a part that is or could be the subject of an anatomical*
8 *gift for transplantation, therapy, research or education from a*
9 *donor or a prospective donor. During the examination period,*
10 *measures necessary to ensure the medical suitability of the part*
11 *may not be withdrawn unless the hospital or procurement*
12 *organization knows that the natural person expressed a contrary*
13 *intent.*

14 3. *Unless prohibited by law other than NRS 451.500 to*
15 *451.590, inclusive, and sections 2 to 41, inclusive, of this act, at*

6. If the holder wishes to make a donation to the Anatomical Gift Account, the Department shall collect the donation and deposit the money collected in the State Treasury for credit to the Anatomical Gift Account.

7. The Department shall submit to the ~~organ~~ donor registry with which the Department has entered into a contract pursuant to paragraph (c) of subsection 5 information from the records of the Department relating to persons who have identification cards issued by the Department that indicate the intention of those persons to make an anatomical gift. The Department shall adopt regulations to carry out the provisions of this subsection.

8. As used in this section, “photograph” has the meaning ascribed to it in NRS 483.125.
