
SENATE BILL NO. 180—SENATORS BEERS AND WASHINGTON**FEBRUARY 28, 2007**

SUMMARY—Provides the registered owner of a vehicle with the opportunity to make a voluntary contribution to the State Highway Fund at the time of the renewal of the registration. (BDR 43-696)

AN ACT relating to the registration of vehicles; providing the registered owner of a vehicle with the opportunity to make a voluntary contribution to the State Highway Fund at the time of the renewal of the registration of the vehicle; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill provides a mechanism pursuant to which the registered owner of a
2 vehicle may, at the time of the renewal of the registration of the vehicle, contribute
3 voluntarily to the State Highway Fund an amount of money in excess of that
4 required to pay the license fees, registration fees and governmental services taxes
5 otherwise due for the renewal of the registration. The bill requires that money
6 donated pursuant to this new provision be used only for the construction,
7 maintenance and repair of the public highways of this State.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 482 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *1. When the registered owner of a vehicle applies for the
4 renewal of the registration of the vehicle through the Internet or
5 in person at an office of the Department or through a designee of
6 the Department, the Department shall provide or cause to be
7 provided to the registered owner the opportunity to remit
8 voluntarily to the State of Nevada an amount of money in addition
9 to all other applicable registration and license fees and
10 governmental services taxes otherwise due for the renewal of the
11 registration of the vehicle.*

12 *2. If the registered owner of a vehicle wishes to remit
13 voluntarily to the State of Nevada an amount of money in addition
14 to all other applicable registration and license fees and
15 governmental services taxes otherwise due for the renewal of the
16 registration of the vehicle, the Department or its designee shall:*

17 *(a) Accept the remittance from the registered owner; and
18 (b) Deposit the remittance with the State Treasurer for credit
19 to the State Highway Fund. The money deposited in the State
20 Highway Fund pursuant to this paragraph must be used
21 exclusively for the construction, maintenance and repair of the
22 public highways of this State and must not be used to pay
23 administrative expenses of any kind.*

24 *3. The Director, in cooperation with the Department of
25 Taxation, shall adopt regulations to carry out the provisions of
26 this section.*
