SUMMARY—Makes appropriations to the State Department of Conservation and Natural Resources for the Division of Water Resources, Division of Forestry, Forestry Conservation Camps and Division of State Parks. (BDR S-1221)

AN ACT making appropriations to the State Department of Conservation and Natural Resources for replacement vehicles and computer hardware and software and to restore the balance in the Channel Clearance Account; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** There is hereby appropriated from the State
- 2 General Fund to the:
- 3 1. Division of Water Resources of the State Department of
- 4 Conservation and Natural Resources the sum of \$82,539 for three
- 5 replacement trucks and computer hardware, and \$250,000 to restore
- 6 the balance in the Channel Clearance Account as established in NRS
- 7 532.220 and 532.230.
- 8 2. Division of Forestry of the Department the sum of \$887,623
- 9 for the replacement of computer hardware and software and 22
- 10 vehicles that are old or in poor condition.

1 3. Department for Forestry Conservation Camps the sum of
2 \$731,271 for the replacement of computer hardware and software,
3 and to purchase 15 new pick-up trucks and mechanic service trucks.

4 4. Division of State Parks of the Department the sum of
5 \$1,802,636 for the replacement of AutoCAD stations, personal
6 computers and software, and 61 vehicles that are inoperable or in
7 poor condition, and the purchase of Geographic Information System
8 hardware and software.

9 **Sec. 2.** Any remaining balance of the appropriations made by
10 section 1 of this act except the \$250,000 appropriated to restore the
11 balance in the Channel Clearance Account must not be committed
12 for expenditure after June 30, 2009, by the entity to which the
13 appropriations are made or any entity to which money from the
14 appropriations is granted or otherwise transferred in any manner,
15 and any portion of the appropriated money remaining must not be
16 spent for any purpose after September 18, 2009, by either the entity
17 to which the money was appropriated or the entity to which the
18 money was subsequently granted or transferred, and must be
19 reverted to the State General Fund on or before September 18, 2009.

20 **Sec. 3.** This act becomes effective upon passage and approval.
