AN ACT relating to the Legislative Committee on Public Lands; revising the duties of the Committee; authorizing the Committee to review and comment on issues relating to water resources in this State; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

Existing law establishes the duties of the Legislative Committee on Public Lands. Certain duties of the Committee, including reviewing the programs and activities of: (1) the Colorado River Commission of Nevada; (2) all public water authorities, districts and systems in this State; and (3) all other public or private entities who have agreements with counties concerning the planning, development or distribution of water resources, expire by limitation on June 30, 2007. (NRS 218.5368)

Section 1 of this bill authorizes the Committee to engage in various activities relating to water resources, including, without limitation, studying and commenting on laws, regulations and policies regulating the use, allocation and management of water resources in Nevada. Section 2 of this bill removes the provision that requires certain duties of the Committee to expire by limitation on June 30, 2007.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1      **Section 1.** NRS 218.5368 is hereby amended to read as  
2 follows:

3      218.5368 **1.** The Committee shall:

4      **[A]** (a) Actively support the efforts of state and local  
5 governments in the western states regarding public lands and state  
6 sovereignty as impaired by federal ownership of land.

7      **[B]** (b) Advance knowledge and understanding in local,  
8 regional and national forums of Nevada's unique situation with  
9 respect to public lands.

10     **[C]** (c) Support legislation that will enhance state and local  
11 roles in the management of public lands and will increase the  
12 disposal of public lands.

14     **2. The Committee:**

15     (a) *Shall review* the programs and activities of:

16     **[A]** (1) The Colorado River Commission of Nevada;

17     **[B]** (2) All public water authorities, districts and systems in  
18 the State of Nevada, including, without limitation, the Southern  
19 Nevada Water Authority, the Truckee Meadows Water Authority,  
20 the Virgin Valley Water District, the Carson Water Subconservancy  
21 District, the Humboldt River Basin Water Authority and the  
22 Truckee-Carson Irrigation District; and

23     **[C]** (3) All other public or private entities with which any  
24 county in the State has an agreement regarding the planning,  
25 development or distribution of water resources, or any combination  
26 thereof.

28     (b) *Shall, on* or before January 15 of each odd-numbered year,  
29 submit to the Director of the Legislative Counsel Bureau for  
30 transmittal to the Legislature a report concerning the review

33 resources in this State, including, without limitation:*
