

SENATE BILL NO. 277—SENATORS WIENER, AMODEI, CARE,
HORSFORD, MCGINNESS AND WASHINGTON

MARCH 13, 2007

Referred to Committee on Transportation and Homeland Security

SUMMARY—Authorizes the court to assign certain offenders to a program of treatment for certain offenses. (BDR 43-888)

AN ACT relating to traffic laws; authorizing the court to order certain offenders who plead guilty or nolo contendere to a third offense of driving under the influence of intoxicating liquor or a controlled substance to a program for the treatment of alcoholism or drug abuse; revising certain penalties for driving under the influence of intoxicating liquor or a controlled substance; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law allows an offender who is found guilty of a first or second
2 violation of driving under the influence of intoxicating liquor or a controlled
3 substance to apply to the court to attend a certified program of treatment for
4 alcoholism or drug abuse. (NRS 484.3792, 484.37937, 484.3794) Upon successful
5 completion of the program, the court will reduce the sentence of the offender. (NRS
6 484.37937, 484.3794) However, no treatment option or reduced sentence is
7 authorized for a third offense, which is a felony offense. (NRS 484.3792) This bill
8 authorizes the court to order an offender who enters a plea of guilty or nolo
9 contendere to a third-offense violation of driving under the influence of intoxicating
10 liquor or a controlled substance to a program of treatment for a minimum of 3 years
11 and to suspend the offender’s sentence until the program of treatment is completed.
12 If the offender successfully completes the program of treatment, his conviction will
13 be reduced to a second-offense violation of driving under the influence of
14 intoxicating liquor or a controlled substance, which is a misdemeanor. Thus, for the
15 purposes of employment, civil rights, licensing or any other public or private
16 purpose, the conviction would be reflected as a misdemeanor. However, the
17 conviction would stand as a prior felony conviction for the purpose of any



18 additional penalties that may be imposed for subsequent offenses for driving under
19 the influence of intoxicating liquor or a controlled substance.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 484 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 1. *An offender who enters a plea of guilty or nolo contendere*
4 *to a violation of NRS 484.379 that is punishable pursuant to*
5 *paragraph (c) of subsection 1 of NRS 484.3792 may, at the time he*
6 *enters his plea, provided that the prosecuting attorney agrees,*
7 *apply to the court to undergo a program of treatment for*
8 *alcoholism or drug abuse which is certified by the Health Division*
9 *of the Department of Health and Human Services for at least 3*
10 *years if:*

11 (a) *The offender is diagnosed as an alcoholic or abuser of*
12 *drugs by:*

13 (1) *An alcohol and drug abuse counselor who is licensed or*
14 *certified pursuant to chapter 641C of NRS to make that diagnosis;*
15 *or*

16 (2) *A physician who is certified to make that diagnosis by*
17 *the Board of Medical Examiners; and*

18 (b) *The offender agrees to pay the costs of the treatment to the*
19 *extent of his financial resources.*

20 2. *A prosecuting attorney may, within 10 days after receiving*
21 *notice of an application for treatment pursuant to this section,*
22 *request a hearing on the matter. The court shall order a hearing*
23 *on the application upon the request of the prosecuting attorney or*
24 *may order a hearing on its own motion.*

25 3. *At the hearing on the application for treatment, the*
26 *prosecuting attorney may present the court with any relevant*
27 *evidence on the matter. If a hearing is not held, the court shall*
28 *decide the matter and other information before the court.*

29 4. *If the court determines that an application for treatment*
30 *should be granted, the court shall:*

31 (a) *Immediately sentence the offender and enter judgment*
32 *accordingly.*

33 (b) *Suspend the sentence of the offender for not more than 5*
34 *years upon the condition that the offender be accepted for*
35 *treatment by a treatment facility, that he complete the treatment*
36 *satisfactorily and that he comply with any other condition ordered*
37 *by the court.*

38 (c) *Advise the offender that:*



1 (1) *If he is accepted for treatment by such a facility, he may*
2 *be placed under the supervision of the facility for a period not to*
3 *exceed 5 years and during treatment he may be confined in an*
4 *institution or, at the discretion of the treatment facility, released*
5 *for treatment or supervised aftercare in the community.*

6 (2) *If he is not accepted for treatment by such a treatment*
7 *facility, or if he fails to complete the treatment satisfactorily, he*
8 *shall serve the sentence imposed by the court. Any sentence of*
9 *imprisonment must be reduced by a time equal to that which he*
10 *served before beginning treatment.*

11 (3) *If he completes the treatment satisfactorily:*

12 (I) *The court shall vacate his sentence of imprisonment*
13 *and reduce his conviction from a violation of paragraph (c) of*
14 *subsection 1 of NRS 484.3792 to a violation of paragraph (b) of*
15 *subsection 1 of NRS 484.3792.*

16 (II) *Such a conviction shall be deemed a misdemeanor*
17 *for all public purposes, except that the conviction must remain on*
18 *his record of criminal history as a felony and shall be deemed a*
19 *prior felony conviction for purposes of enhancement under*
20 *subsection 2 of NRS 484.3792.*

21 5. *The court shall administer the program of treatment*
22 *pursuant to the procedures provided in NRS 458.320 and 458.330,*
23 *except that the court:*

24 (a) *Shall not defer the sentence or set aside the conviction*
25 *upon the election of treatment, except as otherwise provided in this*
26 *section; and*

27 (b) *May immediately revoke the suspension of sentence for a*
28 *violation of a condition of the suspension.*

29 6. *To participate in a program of treatment, the offender must*
30 *meet the following conditions, including, without limitation:*

31 (a) *The offender shall serve a minimum of 6 months of*
32 *residential confinement pursuant to NRS 4.376 to 4.3766,*
33 *inclusive;*

34 (b) *The offender shall have installed, at his own expense, a*
35 *device pursuant to NRS 484.3943 for a period of not less than 12*
36 *months which may be extended at the discretion of the court;*

37 (c) *The offender may not drive any vehicle which is not*
38 *equipped with a device pursuant to NRS 484.3943;*

39 (d) *At the discretion of the court or treatment facility, the*
40 *offender may be subject to periodic testing for the use of alcohol*
41 *or controlled substances while participating in a program of*
42 *treatment; and*

43 (e) *Any other conditions that the court deems necessary.*

44 7. *An offender may not apply to the court to undergo a*
45 *program of treatment for alcoholism or drug abuse pursuant to*



1 *this section if he has previously applied to receive treatment*
2 *pursuant to this section or if he has previously been convicted of:*

3 (a) *A violation of NRS 484.3795;*

4 (b) *A violation of NRS 484.37955;*

5 (c) *A homicide resulting from driving or being in actual*
6 *physical control of a vehicle while under the influence of*
7 *intoxicating liquor or a controlled substance or resulting from any*
8 *other conduct prohibited by NRS 484.379, 484.3795 or 484.37955;*

9 (d) *A violation of paragraph (c) of subsection 1 of*
10 *NRS 484.3792;*

11 (e) *A violation of subsection 2 of NRS 484.3792; or*

12 (f) *A violation of law of any other jurisdiction that prohibits*
13 *the same or similar conduct as set forth in paragraph (a), (b), (c)*
14 *or (d).*

15 8. *As used in this section, "treatment facility" has the*
16 *meaning ascribed to it in NRS 484.3793.*

17 **Sec. 2.** NRS 484.3792 is hereby amended to read as follows:

18 484.3792 1. Unless a greater penalty is provided pursuant to
19 NRS 484.3795 or 484.37955, and except as otherwise provided in
20 subsection 2, a person who violates the provisions of NRS 484.379:

21 (a) For the first offense within 7 years, is guilty of a
22 misdemeanor. Unless he is allowed to undergo treatment as
23 provided in NRS 484.37937, the court shall:

24 (1) Except as otherwise provided in subparagraph (4) or
25 subsection 7, order him to pay tuition for an educational course on
26 the abuse of alcohol and controlled substances approved by the
27 Department and complete the course within the time specified in the
28 order, and the court shall notify the Department if he fails to
29 complete the course within the specified time;

30 (2) Unless the sentence is reduced pursuant to NRS
31 484.37937, sentence him to imprisonment for not less than 2 days
32 nor more than 6 months in jail, or to perform not less than 48 hours,
33 but not more than 96 hours, of community service while dressed in
34 distinctive garb that identifies him as having violated the provisions
35 of NRS 484.379;

36 (3) Fine him not less than \$400 nor more than \$1,000; and

37 (4) If he is found to have a concentration of alcohol of 0.18
38 or more in his blood or breath, order him to attend a program of
39 treatment for the abuse of alcohol or drugs pursuant to the
40 provisions of NRS 484.37945.

41 (b) For a second offense within 7 years, is guilty of a
42 misdemeanor. Unless the sentence is reduced pursuant to NRS
43 484.3794, the court shall:

44 (1) Sentence him to:



1 (I) Imprisonment for not less than 10 days nor more than
2 6 months in jail; or

3 (II) Residential confinement for not less than 10 days nor
4 more than 6 months, in the manner provided in NRS 4.376 to
5 4.3766, inclusive, or 5.0755 to 5.078, inclusive;

6 (2) Fine him not less than \$750 nor more than \$1,000, or
7 order him to perform an equivalent number of hours of community
8 service while dressed in distinctive garb that identifies him as
9 having violated the provisions of NRS 484.379; and

10 (3) Order him to attend a program of treatment for the abuse
11 of alcohol or drugs pursuant to the provisions of NRS 484.37945.

12 ➔ A person who willfully fails or refuses to complete successfully a
13 term of residential confinement or a program of treatment ordered
14 pursuant to this paragraph is guilty of a misdemeanor.

15 (c) ~~For~~ *Except as otherwise provided in section 1 of this act,*
16 *for* a third offense within 7 years, is guilty of a category B felony
17 and shall be punished by imprisonment in the state prison for a
18 minimum term of not less than 1 year and a maximum term of not
19 more than 6 years, and shall be further punished by a fine of not less
20 than \$2,000 nor more than \$5,000. *The court may order the*
21 *offender to attend a program of treatment for the abuse of alcohol*
22 *or drugs pursuant to section 1 of this act.* An offender ~~is~~ *who is*
23 imprisoned *pursuant to the provisions of this paragraph* must,
24 insofar as practicable, be segregated from offenders whose crimes
25 were violent and, insofar as practicable, be assigned to an institution
26 or facility of minimum security.

27 2. Unless a greater penalty is provided in NRS 484.37955, a
28 person who has previously been convicted of:

29 (a) A violation of NRS 484.379 that is punishable as a felony
30 pursuant to paragraph (c) of subsection 1;

31 (b) A violation of NRS 484.3795;

32 (c) A homicide resulting from driving or being in actual physical
33 control of a vehicle while under the influence of intoxicating liquor
34 or a controlled substance or resulting from any other conduct
35 prohibited by NRS 484.379, 484.3795 or 484.37955; ~~or~~

36 (d) A violation of a law of any other jurisdiction that prohibits
37 the same or similar conduct as set forth in paragraph (a), (b) or (c)
38 ~~or~~;

39 (e) *A misdemeanor that was reduced from a felony after*
40 *successful completion of a program of treatment as set forth in*
41 *section 1 of this act,*

42 ➔ and who violates the provisions of NRS 484.379 is guilty of a
43 category B felony and shall be punished by imprisonment in the
44 state prison for a minimum term of not less than 2 years and a
45 maximum term of not more than 15 years, and shall be further



1 punished by a fine of not less than \$2,000 nor more than \$5,000. An
2 offender so imprisoned must, insofar as practicable, be segregated
3 from offenders whose crimes were violent and, insofar as
4 practicable, be assigned to an institution or facility of minimum
5 security.

6 3. Except as otherwise provided in this subsection, an offense
7 that occurred within 7 years immediately preceding the date of the
8 principal offense or after the principal offense constitutes a prior
9 offense for the purposes of this section when evidenced by a
10 conviction, without regard to the sequence of the offenses and
11 convictions. An offense which is listed in paragraphs (a) to (d),
12 inclusive, of subsection 2 that occurred on any date preceding the
13 date of the principal offense or after the principal offense constitutes
14 a prior offense for the purposes of this section when evidenced by a
15 conviction, without regard for the sequence of the offenses and
16 convictions. The facts concerning a prior offense must be alleged in
17 the complaint, indictment or information, must not be read to the
18 jury or proved at trial but must be proved at the time of sentencing
19 and, if the principal offense is alleged to be a felony, must also be
20 shown at the preliminary examination or presented to the grand jury.

21 4. A person convicted of violating the provisions of NRS
22 484.379 must not be released on probation, and a sentence imposed
23 for violating those provisions must not be suspended except, as
24 provided in NRS 4.373, 5.055, 484.37937 and 484.3794, *and*
25 *section 1 of this act*, that portion of the sentence imposed that
26 exceeds the mandatory minimum. A prosecuting attorney shall not
27 dismiss a charge of violating the provisions of NRS 484.379 in
28 exchange for a plea of guilty or nolo contendere to a lesser charge or
29 for any other reason unless he knows or it is obvious that the charge
30 is not supported by probable cause or cannot be proved at the time
31 of trial.

32 5. A term of confinement imposed pursuant to the provisions
33 of this section may be served intermittently at the discretion of the
34 judge or justice of the peace, except that a person who is convicted
35 of a second or subsequent offense within 7 years must be confined
36 for at least one segment of not less than 48 consecutive hours. This
37 discretion must be exercised after considering all the circumstances
38 surrounding the offense, and the family and employment of the
39 offender, but any sentence of 30 days or less must be served within
40 6 months after the date of conviction or, if the offender was
41 sentenced pursuant to NRS 484.37937 or 484.3794, *or section 1 of*
42 *this act*, and the suspension of his sentence was revoked, within 6
43 months after the date of revocation. Any time for which the offender
44 is confined must consist of not less than 24 consecutive hours.



1 6. Jail sentences simultaneously imposed pursuant to this
2 section and NRS 482.456, 483.560 or 485.330 must run
3 consecutively.

4 7. If the person who violated the provisions of NRS 484.379
5 possesses a driver's license issued by a state other than the State of
6 Nevada and does not reside in the State of Nevada, in carrying out
7 the provisions of subparagraph (1) of paragraph (a) of subsection 1,
8 the court shall:

9 (a) Order the person to pay tuition for and submit evidence of
10 completion of an educational course on the abuse of alcohol and
11 controlled substances approved by a governmental agency of the
12 state of his residence within the time specified in the order; or

13 (b) Order him to complete an educational course by
14 correspondence on the abuse of alcohol and controlled substances
15 approved by the Department within the time specified in the order,
16 and the court shall notify the Department if the person fails to
17 complete the assigned course within the specified time.

18 8. If the defendant was transporting a person who is less than
19 15 years of age in the motor vehicle at the time of the violation, the
20 court shall consider that fact as an aggravating factor in determining
21 the sentence of the defendant.

22 9. For the purpose of determining whether one offense occurs
23 within 7 years of another offense, any period of time between the
24 two offenses during which, for any such offense, the offender is
25 imprisoned, serving a term of residential confinement, confined in a
26 treatment facility, on parole or on probation must be excluded.

27 10. As used in this section, unless the context otherwise
28 requires:

29 (a) "Concentration of alcohol of 0.18 or more in his blood or
30 breath" means 0.18 gram or more of alcohol per 100 milliliters of
31 the blood of a person or per 210 liters of his breath.

32 (b) "Offense" means:

33 (1) A violation of NRS 484.379 or 484.3795;

34 (2) A homicide resulting from driving or being in actual
35 physical control of a vehicle while under the influence of
36 intoxicating liquor or a controlled substance or resulting from any
37 other conduct prohibited by NRS 484.379, 484.3795 or 484.37955;
38 or

39 (3) A violation of a law of any other jurisdiction that
40 prohibits the same or similar conduct as set forth in subparagraph
41 (1) or (2).

42 (c) "Treatment facility" has the meaning ascribed to it in
43 NRS 484.3793.



1 **Sec. 3.** NRS 484.37945 is hereby amended to read as follows:
2 484.37945 1. When a program of treatment is ordered
3 pursuant to paragraph (a) or (b) of subsection 1 of NRS 484.3792,
4 *or section 1 of this act*, the court shall place the offender under the
5 clinical supervision of a treatment facility for treatment for a period
6 not to exceed 1 year, in accordance with the report submitted to the
7 court pursuant to subsection 3, 4, 5 or 6 of NRS 484.37943. The
8 court shall:

9 (a) Order the offender confined in a treatment facility, then
10 release the offender for supervised aftercare in the community; or

11 (b) Release the offender for treatment in the community,
12 ➤ for the period of supervision ordered by the court.

13 2. The court shall:

14 (a) Require the treatment facility to submit monthly progress
15 reports on the treatment of an offender pursuant to this section; and

16 (b) Order the offender, to the extent of his financial resources, to
17 pay any charges for his treatment pursuant to this section. If the
18 offender does not have the financial resources to pay all those
19 charges, the court shall, to the extent possible, arrange for the
20 offender to obtain his treatment from a treatment facility that
21 receives a sufficient amount of federal or state money to offset the
22 remainder of the charges.

23 3. A treatment facility is not liable for any damages to person
24 or property caused by a person who:

25 (a) Drives, operates or is in actual physical control of a vehicle
26 or a vessel under power or sail while under the influence of
27 intoxicating liquor or a controlled substance; or

28 (b) Engages in any other conduct prohibited by NRS 484.379,
29 484.3795, 484.37955, subsection 2 of NRS 488.400, NRS 488.410,
30 488.420 or 488.425 or a law of any other jurisdiction that prohibits
31 the same or similar conduct,

32 ➤ after the treatment facility has certified to his successful
33 completion of a program of treatment ordered pursuant to paragraph
34 (a) or (b) of subsection 1 of NRS 484.3792 ~~§~~, *or section 1 of this*
35 *act.*

36 **Sec. 4.** NRS 484.37947 is hereby amended to read as follows:
37 484.37947 The provisions of NRS 484.37943 and 484.37945 ,
38 *and section 1 of this act* do not prohibit a court from:

39 1. Requiring an evaluation pursuant to NRS 484.37943 to be
40 conducted by an evaluation center that is administered by a private
41 company if the company meets the standards of the State Board of
42 Health pursuant to NRS 484.37935; or

43 2. Ordering the offender to attend a program of treatment that
44 is administered by a private company.
