SUMMARY—Revises provisions relating to fire protection districts. (BDR 42-471)

EXPLANATION – Matter in ***bolded italics*** is new; matter between brackets **[omitted material]** is material to be omitted.

AN ACT relating to fire protection; revising provisions that authorize a fire protection district receiving federal aid to annex territory which is contiguous to the district; revising provisions that authorize certain county fire protection districts to annex territory located in a fire protection district receiving federal aid; authorizing the consolidation of certain contiguous fire protection districts located in a county; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law provides for the creation of fire protection districts. (Chapters 473
2 and 474 of NRS) A fire protection district established pursuant to chapter 473 of
3 NRS may annex territory which is contiguous to the district only upon a petition
4 signed by a majority of the property owners within the territory and approval by the
5 State Forester Firewarden. (NRS 473.035)

6 **Section 1** of this bill provides an additional procedure for the annexation of
7 new territory in a fire protection district established pursuant to chapter 473 of
8 NRS. **Section 1** authorizes the board of county commissioners of the county in
9 which the district is organized to propose the annexation of new territory by the
10 adoption of a resolution and approval by the State Forester Firewarden.

11 **Section 3** of this bill authorizes a fire protection district established pursuant to
12 chapter 474 of NRS to annex all or part of a fire protection district organized under
13 the provisions of chapter 473 of NRS. The proposed annexation may be initiated by
14 a petition of the majority of the owners within the area proposed for annexation or
15 by a resolution of the board of county commissioners of the county in which the

16 district proposing the annexation is located. The State Forester Firewarden must
17 approve the annexation.

18 **Section 4** of this bill authorizes the consolidation of two or more contiguous
19 fire protection districts located in the same county. The proposed consolidation may
20 be initiated by a petition of a majority of the owners of the property located within
21 the districts proposed for consolidation or by a resolution of the board of county
22 commissioners of the county in which the districts proposed for consolidation are
23 located.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 473.035 is hereby amended to read as follows:
2 473.035 1. New territory may be included in any fire
3 protection district organized under this chapter in the manner
4 provided in subsections 2 to [5, inclusive].

5 ~~2. Upon receiving a written petition containing at least 7, inclusive.~~
6 *Any new territory which is proposed to be included in a fire
7 protection district must be contiguous to the district.*

8 *2. The inclusion of new territory in a fire protection district
9 organized under this chapter may be initiated by:*

10 *(a) A petition signed by a majority of the owners of the
11 property located within the territory proposed to be included in the
12 district; or*

13 *(b) A resolution of the board of county commissioners of the
14 county in which the district is located that includes a description
15 of the territory proposed to be included in the district.*

16 *3. The petition must include:*

17 *(a) A description of the territory proposed to be included
18 [(which territory must be contiguous to the district), which petition
19 must contain at least] in the fire protection district; and*

20 *(b) A statement advising the signers that their property will be
21 subject to the levy of a tax for the support of the fire protection
22 district. [and be signed by not less than a majority of the property
23 owners within the territory.]*

24 *4. Upon receipt of the petition or resolution*, the State Forester
25 Firewarden shall determine the feasibility of including that territory
26 *in the fire protection district* and shall notify the board of directors
27 of the district of his decision.

28 ~~5.~~ The board of directors, upon receipt of a notice in writing from the State Forester Firewarden of the decision to include territory in the fire protection district, shall prepare a resolution:

31 (i) Describing the territory to be included; and
32 (ii) Stating the purpose for its inclusion.

33 ~~6.~~ Upon the adoption of the resolution , the board of
34 directors shall forthwith notify the State Forester Firewarden of the

1 resolution. The territory is **included** in the fire protection district
2 from the date of the resolution.

3 **[S.7.]** 7. Upon the inclusion of any contiguous territory in a fire
4 protection district , the State Forester Firewarden shall adopt
5 regulations for the organization of the territory to meet the terms and
6 requirements for federal aid.

7 **Sec. 2.** Chapter 474 of NRS is hereby amended by adding
8 thereto the provisions set forth as sections 3 and 4 of this act.

9 **Sec. 3. 1. A county fire protection district organized**
10 **pursuant to this chapter may annex all or any part of a fire**
11 **protection district organized pursuant to chapter 473 of NRS.**

12 **2. The annexation may be initiated by:**

13 **(a) A petition signed by a majority of the owners of the**
14 **property located within the area proposed to be annexed; or**

15 **(b) A resolution of the board of county commissioners of the**
16 **county in which the district organized pursuant to this chapter is**
17 **located.**

18 **3. If, after notice and a hearing, the board of county**
19 **commissioners determines that the proposed annexation is feasible**
20 **and in the best interests of the county and the district, the board of**
21 **county commissioners shall adopt and submit to the State Forester**
22 **Firewarden a petition requesting annexation of the proposed area.**

23 **4. Upon receipt of the petition, the State Forester Firewarden**
24 **shall determine whether the annexation is feasible and shall notify**
25 **the board of county commissioners, in writing, of his decision.**

26 **5. Upon receipt of a notice from the State Forester**
27 **Firewarden that the annexation is approved, the board of county**
28 **commissioners shall adopt an ordinance which must include the**
29 **name and boundaries of the district.**

30 **6. The board of county commissioners shall cause a copy of**
31 **the ordinance, certified by the clerk of the board of county**
32 **commissioners, to be filed immediately for record in the office of**
33 **the county recorder.**

34 **7. The annexation of the proposed area of the district is**
35 **complete upon the filing of the ordinance pursuant to this section.**

36 **Sec. 4. 1. Two or more contiguous fire protection districts**
37 **located within a county and organized pursuant to this chapter**
38 **may be consolidated into a fire protection district consisting of the**
39 **total area of those fire protection districts.**

40 **2. The consolidation may be initiated by:**

41 **(a) A petition signed by a majority of the owners of property**
42 **located within the districts proposed to be consolidated; or**

43 **(b) A resolution of the board of county commissioners of the**
44 **county in which the districts are located if the resolution is**

1 *approved by the governing bodies of the fire protection districts*
2 *proposed to be consolidated.*

3 *3. If, after notice and a hearing, the board of county*
4 *commissioners determines that the proposed consolidation is*
5 *feasible and in the best interests of the county and the districts*
6 *proposed to be consolidated, the board of county commissioners*
7 *shall adopt an ordinance consolidating the districts. The*
8 *ordinance must include the name and boundaries of the*
9 *consolidated district.*

10 *4. The board of county commissioners shall cause a copy of*
11 *the ordinance, certified by the clerk of the board of county*
12 *commissioners, to be filed immediately for record in the office of*
13 *the county recorder.*

14 *5. All debts, obligations, liabilities and assets of the former*
15 *districts must be assumed by the consolidated district.*

16 **Sec. 5.** NRS 474.325 is hereby amended to read as follows:

17 474.325 The boundaries of any county fire protection district
18 formed under NRS 474.010 to 474.450, inclusive, may be altered
19 and new territory annexed thereto, incorporated and included
20 therein, and made a part thereof in the manner provided in :

21 1. NRS 474.335 to 474.395, inclusive ~~H~~; or

22 2. **Section 3 of this act.**

23 **Sec. 6.** The amendatory provisions of this act do not apply to
24 modify, directly or indirectly, any taxes levied or revenues pledged
25 in such a manner as to impair adversely any outstanding obligations
26 of a fire protection district, including, without limitation, bonds,
27 medium-term financing, letters of credit and any other financial
28 obligation, until all such obligations have been discharged in full or
29 provision for their payment and redemption has been fully made.

30 **Sec. 7.** This act becomes effective on July 1, 2007.
