**SUMMARY**—Revises certain provisions relating to state and local governmental purchasing. (BDR 27-782)

AN ACT relating to purchasing; prohibiting the solicitation or provision of certain information before the award of purchasing contracts; imposing certain requirements relating to inducements offered by bidders on such contracts; prohibiting the hiring of certain contracting officials within a certain period after their employment or service is terminated; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1       Under existing law, persons who have bid on a contract proposed to be awarded  
2 by a local government or by the Purchasing Division of the Department of  
3 Administration are prohibited from soliciting or obtaining proprietary information  
4 regarding the contract from officers or employees of the governmental entity on  
5 whose behalf the contract is being offered. (NRS 332.810, 333.800) **Sections 2 and**  
6 **4** of this bill expand this prohibition to include the soliciting or obtaining of  
7 information regarding another person's bid on the contract, unless such information  
8 is available to the general public. **Sections 1 and 3** of this bill prohibit officers and  
9 employees of the governmental entity on whose behalf a contract is being offered  
10 from offering or providing to a bidder on the contract certain information before the  
11 award of the contract. **Sections 1 and 3** also require those officers and employees  
12 to refuse inducements offered by bidders and to report such inducements to their  
13 immediate supervisors.

14     Under existing law, certain regulated businesses must observe a 1-year "cooling  
15 off" period before hiring certain former public officers and employees who were  
16 involved in regulating such a business. (NRS 281.236) **Section 5** of this bill  
17 prohibits a person who was awarded a state or local governmental purchasing  
18 contract in an amount that exceeds \$25,000 from employing, for a period of 1 year  
19 after the date of the award of the contract, a former public officer or employee  
20 whose position allowed him to affect, influence or otherwise provide input with

21 respect to the awarding of the contract. **Section 5** allows the Commission on Ethics  
22 to provide relief from the strict application of this rule under certain circumstances.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** Chapter 332 of NRS is hereby amended by adding  
2 thereto a new section to read as follows:

3       *1. An officer or employee of a local government who receives  
4 an offer or promise described in paragraph (a) or (b) of subsection  
5 1 of NRS 332.810 shall:*

6       *(a) Refuse the offer or promise; and*

7       *(b) Within 72 hours after receiving the offer or promise, report  
8 the occurrence to his immediate supervisor or, if he does not have  
9 an immediate supervisor, to the administrative head of the agency  
10 by which he is employed.*

11      *2. Before a contract is awarded pursuant to this chapter, an  
12 officer or employee of the local government shall not offer or  
13 provide to a person who has bid on the contract:*

14       *(a) Any proprietary information regarding the contract; or*

15       *(b) Any information regarding a bid on the contract submitted  
16 by another person, unless such information is available to the  
17 general public.*

18      *3. An officer or employee of a local government who violates  
19 the provisions of subsection 1 or 2 is subject to disciplinary action.*

20      **Sec. 2.** NRS 332.810 is hereby amended to read as follows:

21      332.810   1. Before a contract is awarded, a person who has  
22 bid on the contract or an officer, employee, representative, agent or  
23 consultant of such a person shall not:

24       (a) Make an offer or promise of future employment or business  
25 opportunity to, or engage in a discussion of future employment or  
26 business opportunity with, an evaluator or member of the governing  
27 body offering the contract;

28       (b) Offer, give or promise to offer or give money, a gratuity or  
29 any other thing of value to an evaluator or member of the governing  
30 body offering the contract; or

31       (c) Solicit or obtain from an officer, employee or member of the  
32 governing body offering the contract ~~or any~~:

33       *(1) Any* proprietary information regarding the contract ~~or~~ ;  
34       *or*

35       *(2) Any information regarding a bid on the contract  
36 submitted by another person, unless such information is available  
37 to the general public.*

38      2. A person who violates any of the provisions of subsection 1  
39 is guilty of a gross misdemeanor and shall be punished by

1 imprisonment in the county jail for not more than 1 year, or by a  
2 fine of not less than \$2,000 nor more than \$50,000, or by both fine  
3 and imprisonment.

4 **Sec. 3.** Chapter 333 of NRS is hereby amended by adding  
5 thereto a new section to read as follows:

6     ***1. An officer or employee of the Purchasing Division or of a  
7 using agency who receives an offer or promise described in  
8 paragraph (a) or (b) of subsection 1 of NRS 333.800 shall:***

9         ***(a) Refuse the offer or promise; and***

10         ***(b) Within 72 hours after receiving the offer or promise, report  
11 the occurrence to his immediate supervisor or, if he does not have  
12 an immediate supervisor, to the administrative head of the agency  
13 by which he is employed.***

14     ***2. Before a contract is awarded pursuant to this chapter, an  
15 officer or employee of the Purchasing Division or of a using  
16 agency shall not offer or provide to a person who has bid on the  
17 contract:***

18         ***(a) Any proprietary information regarding the contract; or***

19         ***(b) Any information regarding a bid on the contract submitted  
20 by another person, unless such information is available to the  
21 general public.***

22     ***3. An officer or employee of the Purchasing Division or of a  
23 using agency who violates the provisions of subsection 1 or 2 is  
24 subject to disciplinary action.***

25     **Sec. 4.** NRS 333.800 is hereby amended to read as follows:

26     333.800   1. Before a contract is awarded, a person who has  
27 provided a bid or proposal on the contract or an officer, employee,  
28 representative, agent or consultant of such a person shall not:

29         (a) Make an offer or promise of future employment or business  
30 opportunity to, or engage in a discussion of future employment or  
31 business opportunity with, the Chief, a purchasing officer or an  
32 employee of the using agency for which the contract is being  
33 offered;

34         (b) Offer, give or promise to offer or give money, a gratuity or  
35 any other thing of value to the Chief, a purchasing officer or an  
36 employee of the using agency for which the contract is being  
37 offered; or

38         (c) Solicit or obtain ~~[any proprietary information regarding the  
39 contract]~~ from the Chief, a purchasing officer or an employee of the  
40 using agency for which the contract is being offered ~~[.]~~:

41             ***(1) Any proprietary information regarding the contract; or***  
42             ***(2) Any information regarding a bid or proposal on the  
43 contract submitted by another person, unless such information is  
44 available to the general public.***

1       2. A person who violates any of the provisions of subsection 1  
2 is guilty of a gross misdemeanor and shall be punished by  
3 imprisonment in the county jail for not more than 1 year, or by a  
4 fine of not less than \$2,000 nor more than \$50,000, or by both fine  
5 and imprisonment.

6       **Sec. 5.** NRS 281.236 is hereby amended to read as follows:

7       281.236 1. A public utility or parent organization or  
8 subsidiary of a public utility shall not employ a former member of  
9 the Public Utilities Commission of Nevada for 1 year after the  
10 termination of his service on the Commission.

11      2. A person who holds a license issued pursuant to chapter 463  
12 or 464 of NRS or who is required to register with the Nevada  
13 Gaming Commission pursuant to chapter 463 of NRS shall not  
14 employ a former member of the State Gaming Control Board or the  
15 Nevada Gaming Commission for 1 year after the termination of the  
16 member's service on the Board or Commission.

17      3. In addition to the prohibitions set forth in subsections 1 and  
18 2, a business or industry whose activities are governed by  
19 regulations adopted by a department, division or other agency of the  
20 Executive Branch of **State** Government shall not, except as  
21 otherwise provided in subsection **[4.] 5,** employ a former public  
22 officer or employee of the agency, except a clerical employee, for 1  
23 year after the termination of his service or period of employment if:

24       (a) His principal duties included the formulation of policy  
25 contained in the regulations governing the business or industry;

26       (b) During the immediately preceding year , he directly  
27 performed activities, or controlled or influenced an audit, decision,  
28 investigation or other action, which significantly affected the  
29 business or industry which might, but for this section, employ him;  
30 or

31       (c) As a result of his governmental service or employment, he  
32 possesses knowledge of the trade secrets of a direct business  
33 competitor.

34      4. *A person to whom a contract was awarded by a local  
35 government pursuant to chapter 332 of NRS or by the Purchasing  
36 Division of the Department of Administration pursuant to chapter  
37 333 of NRS shall not, except as otherwise provided in subsection  
38 5, employ a former public officer or employee of the local  
39 government or Purchasing Division, as applicable, except a  
40 clerical employee, for 1 year after the termination of the officer's  
41 or employee's service or period of employment, if:*

42       (a) *The amount of the contract exceeded \$25,000;*

43       (b) *The contract was awarded within the 12-month period  
44 immediately preceding the termination of the officer's or  
45 employee's service or period of employment; and*

1       (c) *The position held by the former public officer or employee  
2 at the time the contract was awarded allowed him to affect,  
3 influence or otherwise provide input with respect to the awarding  
4 of the contract.*

5       5. A public officer or employee may request *that* the  
6 Commission on Ethics ~~to~~ apply the relevant facts in his case to the  
7 provisions of subsection 3 *or 4, as applicable*, and determine  
8 whether relief from the strict application of ~~the~~ *those* provisions is  
9 proper. If the Commission on Ethics determines that relief from the  
10 strict application of the provisions of subsection 3 *or 4, as  
11 applicable*, is not contrary to:

12       (a) The best interests of the public;  
13       (b) The continued integrity of State Government; and  
14       (c) The code of ethical standards prescribed in NRS 281.481,  
15       → it may issue an opinion to that effect and grant such relief. The  
16 opinion of the Commission on Ethics in such a case is subject to  
17 judicial review.

18       6. As used in this section, “regulation” has the meaning  
19 ascribed to it in NRS 233B.038.
