AN ACT relating to child welfare; requiring the Division of Child and Family Services of the Department of Health and Human Services to coordinate with and assist each agency which provides child welfare services in recruiting, training and licensing providers of family foster care; and providing other matters properly relating thereto.

3 require the Division to coordinate with and assist each agency which provides child
4 welfare services in recruiting, training and licensing providers of family foster care.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN

1 **Section 1.** NRS 432B.180 is hereby amended to read as
2 follows:
3 432B.180 The Division of Child and Family Services shall:

- 1 1. Administer any money granted to the State by the Federal
2 Government.
3 2. Plan, coordinate and monitor the delivery of child welfare
4 services provided throughout the State.
5 3. Provide child welfare services directly or arrange for the
6 provision of those services in a county whose population is less than
7 100,000.
8 4. Coordinate its activities with and assist the efforts of any law
9 enforcement agency, a court of competent jurisdiction, an agency
10 which provides child welfare services and any public or private
11 organization which provides social services for the prevention,
12 identification and treatment of abuse or neglect of children and for
13 permanent placement of children.
14 5. Involve communities in the improvement of child welfare
15 services.
16 6. Evaluate all child welfare services provided throughout the
17 State and withhold money from any agency providing child welfare
18 services which is not complying with the regulations adopted by the
19 Division of Child and Family Services.
20 7. Evaluate the plans submitted for approval pursuant to
21 NRS 432B.395.
22 8. In consultation with each agency which provides child
23 welfare services, request sufficient money for the provision of child
24 welfare services throughout this State.
25 9. *Coordinate with and assist each agency which provides
26 child welfare services in recruiting, training and licensing
27 providers of family foster care as defined in NRS 424.017.*
28 Sec. 2. This act becomes effective on July 1, 2007.
