SUMMARY—Makes various changes regarding health care.

AN ACT relating to health care; revising the method of selecting certain professionals for various boards related to health care; creating a new type of license for practicing medicine; changing the requirements for a license by endorsement to practice medicine; providing new requirements for certain nursing instructors; providing two new types of licenses for osteopathic medicine; providing a new type of license as a dispensing optician; providing in statute for the election of officers for the State Board of Physical Therapy Examiners; making various other changes relating to health care; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law provides methods of selecting certain persons for various boards
2 related to health care. (NRS 630.060, 630A.110, 631.130, 632.030, 633.191,
3 634.020, 634A.040, 635.020, 636.035, 637.030, 637A.035, 637B.100, 639.030,
4 640.030, 640A.080, 640B.170, 640B.180, 640C.150, 641.040, 641A.100, 641B.100
5 and 641C.150) **Section 1** of this bill establishes new requirements related to
6 selecting such persons if they are members of the profession being regulated by a
7 board. Specifically, each applicable professional association is required to provide a
8 list of nominees to the Governor for vacant positions on such boards. The Governor
9 may, but is not required to, appoint a person from the list.

Existing law provides certain special types of licenses that the Board of Medical Examiners may issue. (NRS 630.258-630.265) **Section 3** of this bill provides a new type of license for a foreign expert physician.

Existing law provides for certain persons to receive a license by endorsement to practice medicine. (NRS 630.1605) **Section 7** of this bill revises the requirements for such a license.

Existing law provides that each holder of a license to practice medicine or osteopathic medicine is required to report annually certain information concerning surgeries. (NRS 630.30665, 633.524) **Sections 7.5 and 54** of this act require a separate report of certain sentinel events and provide for an administrative penalty to be imposed if the holder of the license fails to file the report or knowingly files false information in a report.

Existing law provides certain requirements and the procedures for creating requirements for schools and courses of professional nursing. (NRS 632.430-632.470) **Section 11** of this bill provides for the various requirements for nursing instructors in clinical practice.

Existing law provides certain types of special licenses that the State Board of Osteopathic Medicine may issue. (NRS 633.401-633.411) **Section 24** of this bill provides a new type of license for a foreign expert osteopathic physician. **Section 25** of this bill provides a new type of license by endorsement to practice osteopathic medicine.

Existing law provides for the certification of osteopathic physician's assistants by the State Board of Osteopathic Medicine. (NRS 633.101, 633.431, 633.441, 633.451) **Section 37** of this bill changes the title of "osteopathic physician's assistant" to "physician assistant." **Sections 29 and 30** of this bill provide for the licensure, rather than certification, of such physician assistants. **Sections 16, 17, 22, 36, 37, 39, 40, 43, 49, 53, 55, 58, 69, 71 and 84-118** of this bill amend various statutes in accordance with these changes.

Existing law provides requirements for the licensing of dispensing opticians. (NRS 637.090-637.140) **Section 64** of this bill provides a new type of license for a person with an out-of-state license as a dispensing optician.

Existing law provides for the creation of the State Board of Physical Therapy Examiners. (NRS 640.030) **Section 74** of this bill provides for the election of officers for that Board.

Section 119 of this bill repeals certain statutes, including, without limitation, NRS 632.450 which requires that the minimum length for a course of instruction in nursing is 2 years.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Chapter 629 of NRS is hereby amended by adding thereto a new section to read as follows:

1. If the Governor must appoint to a board a person who is a member of a profession being regulated by that board, the Governor shall solicit nominees from one or more applicable professional associations in this State.

2. To the extent practicable, such an applicable professional association shall provide nominees who represent the geographic diversity of this State.



1 3. *The Governor may appoint any qualified person to a*
2 *board, without regard to whether the person is nominated*
3 *pursuant to this section.*

4 4. *As used in this section, "board" refers to a board created*
5 *pursuant to chapter 630, 630A, 631, 632, 633, 634, 634A, 635, 636,*

7 *641C.*

8 **Sec. 2.** Chapter 630 of NRS is hereby amended by adding

11 **Sec. 3.** 1. *Except as otherwise provided in NRS 630.161,*
12 *the Board may issue a restricted license to a person who:*

13 (a) *Is a graduate of a foreign medical school;*

14 (b) *Teaches, researches or practices medicine outside the*
15 *United States;*

16 (c) *Is a recognized medical expert; and*

17 (d) *Intends to teach, research or practice clinical medicine at a*
18 *medical research facility or medical school in this State.*

19 2. *A person who applies for a restricted license is not required*
20 *to take or pass a written examination concerning his*
21 *qualifications to practice medicine, but the person must satisfy the*
22 *requirements for a restricted license set forth in regulations*
23 *adopted by the Board.*

24 3. *A person who holds a restricted license issued pursuant to*
25 *this section may practice medicine in this State only in accordance*
26 *with the terms and restrictions established by the Board.*

27 4. *If a person who holds a restricted license issued pursuant*
28 *to this section ceases to teach, research or practice clinical*
29 *medicine in this State at the medical research facility or medical*
30 *school where he is employed:*

31 (a) *The medical research facility or medical school, as*
32 *applicable, shall notify the Board; and*

33 (b) *Upon receipt of such notification, the restricted license*
34 *expires automatically.*

35 5. *The Board may renew or modify a restricted license issued*
36 *pursuant to this section, unless the restricted license has expired*
37 *automatically or has been revoked.*

38 6. *The provisions of this section do not limit the authority of*
39 *the Board to issue a restricted license to an applicant in*
40 *accordance with any other provision of this chapter.*

9 authorizing him to practice.

12 license may be issued to any person who:

13 (a) Is a citizen of the United States or is lawfully entitled to
14 remain and work in the United States;

17 (1) Approved by the Liaison Committee on Medical
18 Education of the American Medical Association and Association of
19 American Medical Colleges; or

20 (2) Which provides a course of professional instruction

24 Board of Medical Specialties and who agrees to maintain such

34 (b) "Deep sedation" means a controlled state of depressed
35 consciousness, produced by a pharmacologic or nonpharmacologic
36 method, or a combination thereof, and accompanied by a partial loss
37 of protective reflexes and the inability to respond purposefully to
38 verbal commands.

39 (c) "General anesthesia" means a controlled state of
40 unconsciousness, produced by a pharmacologic or
41 nonpharmacologic method, or a combination thereof, and
42 accompanied by partial or complete loss of protective reflexes and
43 the inability independently to maintain an airway and respond
44 purposefully to physical stimulation or verbal commands.



(d) "Sentinel event" means an unexpected occurrence involving death or serious physical or psychological injury or the risk thereof, including, without limitation, any process variation for which a recurrence would carry a significant chance of serious adverse outcome. The term includes loss of limb or function.

5 632.030 1. The Governor shall appoint:

6 (a) Three registered nurses who are graduates of an accredited
7 school of nursing, are licensed as professional nurses in the State of
8 Nevada and have been actively engaged in nursing for at least 5
9 years preceding the appointment.

10 (b) One practical nurse who is a graduate of an accredited school
11 of practical nursing, is licensed as a practical nurse in this State and
12 has been actively engaged in nursing for at least 5 years preceding
13 the appointment.

14 (c) One nursing assistant who is certified pursuant to the
15 provisions of this chapter.

16 (d) One member who represents the interests of persons or
17 agencies that regularly provide health care to patients who are
18 indigent, uninsured or unable to afford health care. This member

6. No member of the Board may serve more than two consecutive terms. For the purposes of this subsection, service of 2 or more years in filling an unexpired term constitutes a term.

(a) Any physician, dentist, dental hygienist, chiropractor, optometrist, podiatric physician, medical examiner, resident, intern, professional or practical nurse, nursing assistant, physician assistant ~~§~~ *licensed pursuant to chapter 630 or 633 of NRS*, psychiatrist, psychologist, marriage and family therapist, alcohol or drug abuse counselor, driver of an ambulance, advanced emergency medical technician or other person providing medical services licensed or certified to practice in this State.

(c) A coroner.

(f) Any employee of the Department of Health and Human Services.

(g) Any employee of a law enforcement agency or a county's office for protective services or an adult or juvenile probation officer.

(h) Any person who maintains or is employed by a facility or establishment that provides care for older persons.

(i) Any person who maintains, is employed by or serves as a volunteer for an agency or service which advises persons regarding



1 the abuse, neglect or exploitation of an older person and refers them
2 to persons and agencies where their requests and needs can be met.

3 (j) Any social worker.

4 2. Every physician who, as a member of the staff of a medical
5 facility or facility for the dependent, has reason to believe that a
6 nursing assistant has engaged in conduct which constitutes grounds
7 for the denial, suspension or revocation of a certificate shall notify
8 the superintendent, manager or other person in charge of the facility.
9 The superintendent, manager or other person in charge shall make a
10 report as required in subsection 1.

11 3. A report may be filed by any other person.

12 4. Any person who in good faith reports any violation of the
13 provisions of this chapter to the Executive Director of the Board

20 454.371, inclusive, may be possessed and administered by:

21 1. A practitioner.

22 2. A physician assistant *licensed pursuant to chapter 630 or*
23 *633 of NRS*, at the direction of his supervising physician or a
24 licensed dental hygienist acting in the office of and under the
25 supervision of a dentist.

26 3. Except as otherwise provided in subsection 4, a registered
27 nurse licensed to practice professional nursing or licensed practical
28 nurse, at the direction of a prescribing physician, physician assistant
29 ~~or~~ *licensed pursuant to chapter 630 or 633 of NRS*, dentist,
30 podiatric physician or advanced practitioner of nursing, or pursuant
31 to a chart order, for administration to a patient at another location.

32 4. In accordance with applicable regulations of the Board, a
33 registered nurse licensed to practice professional nursing or licensed
34 practical nurse who is:

35 (a) Employed by a health care agency or health care facility that
36 is authorized to provide emergency care, or to respond to the
37 immediate needs of a patient, in the residence of the patient; and

38 (b) Acting under the direction of the medical director of that
39 agency or facility who works in this State.

40 5. An intermediate emergency medical technician or an
41 advanced emergency medical technician, as authorized by
42 regulation of the State Board of Pharmacy and in accordance with
43 any applicable regulations of:

44 (a) The State Board of Health in a county whose population is
45 less than 100,000;



1 (b) A county board of health in a county whose population is
2 100,000 or more; or

3 (c) A district board of health created pursuant to NRS 439.362
4 or 439.370 in any county.

5 6. A respiratory therapist employed in a health care facility.
6 The therapist may possess and administer respiratory products only
7 at the direction of a physician.

8 7. A dialysis technician, under the direction or supervision of a
9 physician or registered nurse only if the drug or medicine is used for
10 the process of renal dialysis.

11 8. A medical student or student nurse in the course of his
12 studies at an approved college of medicine or school of professional
13 or practical nursing, at the direction of a physician and:

14 (a) In the presence of a physician or a registered nurse; or

15 (b) Under the supervision of a physician or a registered nurse if
16 the student is authorized by the college or school to administer the
17 drug or medicine outside the presence of a physician or nurse.

18 ➤ A medical student or student nurse may administer a dangerous
19 drug in the presence or under the supervision of a registered nurse
20 alone only if the circumstances are such that the registered nurse
21 would be authorized to administer it personally.

22 9. Any person designated by the head of a correctional
23 institution.

24 10. An ultimate user or any person designated by the ultimate
25 user pursuant to a written agreement.

26 11. A nuclear medicine technologist, at the direction of a
27 physician and in accordance with any conditions established by
28 regulation of the Board.

29 12. A radiologic technologist, at the direction of a physician
30 and in accordance with any conditions established by regulation of
31 the Board.

32 13. A chiropractic physician, but only if the drug or medicine
33 is a topical drug used for cooling and stretching external tissue
34 during therapeutic treatments.

35 14. A physical therapist, but only if the drug or medicine is a
36 topical drug which is:

37 (a) Used for cooling and stretching external tissue during
38 therapeutic treatments; and

39 (b) Prescribed by a licensed physician for:

40 (1) Iontophoresis; or

41 (2) The transmission of drugs through the skin using
42 ultrasound.

43 15. In accordance with applicable regulations of the State
44 Board of Health, an employee of a residential facility for groups, as



defined in NRS 449.017, pursuant to a written agreement entered into by the ultimate user.

16. A veterinary technician at the direction of his supervising veterinarian.

17. In accordance with applicable regulations of the Board, a registered pharmacist who:

(a) Is trained in and certified to carry out standards and practices for immunization programs;

(b) Is authorized to administer immunizations pursuant to written protocols from a physician; and

(c) Administers immunizations in compliance with the "Standards of Immunization Practices" recommended and approved by the United States Public Health Service Advisory Committee on Immunization Practices.

18. A person who is enrolled in a training program to become a physician assistant ***licensed pursuant to chapter 630 or 633 of NRS***, dental hygienist, intermediate emergency medical technician, advanced emergency medical technician, respiratory therapist, dialysis technician, nuclear medicine technologist, radiologic technologist, physical therapist or veterinary technician if the person possesses and administers the drug or medicine in the same manner and under the same conditions that apply, respectively, to a physician assistant ***licensed pursuant to chapter 630 or 633 of NRS***, dental hygienist, intermediate emergency medical technician, advanced emergency medical technician, respiratory therapist, dialysis technician, nuclear medicine technologist, radiologic technologist, physical therapist or veterinary technician who may possess and administer the drug or medicine, and under the direct supervision of a person licensed or registered to perform the respective medical art or a supervisor of such a person.

Sec. 116. NRS 454.215 is hereby amended to read as follows:

454.215 A dangerous drug may be dispensed by:

1. A registered pharmacist upon the legal prescription from a practitioner or to a pharmacy in a correctional institution upon the written order of the prescribing practitioner in charge;

2. A pharmacy in a correctional institution, in case of emergency, upon a written order signed by the chief medical officer;

3. A practitioner, or a physician assistant ***licensed pursuant to chapter 630 or 633 of NRS*** if authorized by the Board;

4. A registered nurse, when the nurse is engaged in the performance of any public health program approved by the Board;

5. A medical intern in the course of his internship;

6. An advanced practitioner of nursing who holds a certificate from the State Board of Nursing and a certificate from the State Board of Pharmacy permitting him to dispense dangerous drugs;



7. A registered nurse employed at an institution of the Department of Corrections to an offender in that institution;

8. A registered pharmacist from an institutional pharmacy pursuant to regulations adopted by the Board; or

9. A registered nurse to a patient at a rural clinic that is designated as such pursuant to NRS 433.233 and that is operated by the Division of Mental Health and Developmental Services of the Department of Health and Human Services if the nurse is providing mental health services at the rural clinic,

except that no person may dispense a dangerous drug in violation of a regulation adopted by the Board.

Sec. 117. NRS 454.221 is hereby amended to read as follows:

454.221 1. A person who furnishes any dangerous drug except upon the prescription of a practitioner is guilty of a category D felony and shall be punished as provided in NRS 193.130, unless the dangerous drug was obtained originally by a legal prescription.

2. The provisions of this section do not apply to the furnishing of any dangerous drug by:

(a) A practitioner to his patients;

(b) A physician assistant *licensed pursuant to chapter 630 or 633 of NRS* if authorized by the Board;

(c) A registered nurse while participating in a public health program approved by the Board, or an advanced practitioner of nursing who holds a certificate from the State Board of Nursing and a certificate from the State Board of Pharmacy permitting him to dispense dangerous drugs;

(d) A manufacturer or wholesaler or pharmacy to each other or to a practitioner or to a laboratory under records of sales and purchases that correctly give the date, the names and addresses of the supplier and the buyer, the drug and its quantity;

(e) A hospital pharmacy or a pharmacy so designated by a county health officer in a county whose population is 100,000 or more, or by a district health officer in any county within its jurisdiction or, in the absence of either, by the State Health Officer or his designated Medical Director of Emergency Medical Services, to a person or agency described in subsection 3 of NRS 639.268 to stock ambulances or other authorized vehicles or replenish the stock; or

(f) A pharmacy in a correctional institution to a person designated by the Director of the Department of Corrections to administer a lethal injection to a person who has been sentenced to death.

Sec. 118. NRS 484.393 is hereby amended to read as follows:

484.393 1. The results of any blood test administered under the provisions of NRS 484.383 or 484.391 are not admissible in any



1 hearing or criminal action arising out of acts alleged to have been
2 committed by a person who was driving or in actual physical control
3 of a vehicle while under the influence of intoxicating liquor or a
4 controlled substance or who was engaging in any other conduct
5 prohibited by NRS 484.379, 484.3795 or 484.37955 unless:

26 test when requested by a police officer or the person to be tested to

30 **Sec. 120.** A certificate for an osteopathic physician's assistant
31 that is current and valid on December 31, 2007, shall, on January 1,

34 **Sec. 121.** 1. This act becomes effective:

35 (a) Upon passage and approval for the purpose of adopting
36 regulations and performing any other preparatory administrative

39 2. The amendatory provisions of section 7 of this act expire by
40 limitation on January 1, 2012.
