

SENATE BILL NO. 43—COMMITTEE ON TRANSPORTATION

SUMMARY—Revises provisions relating to certain traffic offenses.

AN ACT relating to traffic laws; prohibiting a person from organizing an unauthorized speed contest on a public highway; increasing the penalty for driving a vehicle in willful or wanton disregard of the safety of persons or property; increasing the penalty for driving a vehicle in an unauthorized speed contest on a public highway; providing penalties; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Under existing law, a person who drives a vehicle in willful or wanton
2 disregard of the safety of persons or property or who drives a vehicle in an
3 unauthorized speed contest on a public highway is guilty of a misdemeanor and
4 may be punished by imprisonment in the county jail for not more than 6 months, or
5 by a fine of not more than \$1,000, or by both fine and imprisonment. In lieu of all
6 or a part of the punishment, the convicted person may be sentenced to perform a
7 fixed period of community service. (NRS 193.150, 484.377) **Section 3** of this bill
8 increases the penalty for committing either offense by establishing, in addition to
9 the possibility of imprisonment in the county jail, a minimum fine of \$250 for the
10 first offense, \$1,000 for the second offense and \$1,500 for the third and each
11 subsequent offense. A person convicted of driving a vehicle in an unauthorized
12 speed contest on a public highway is also required to perform a minimum number
13 of hours of community service. In addition to any fine, community service and
14 imprisonment imposed upon a person convicted of driving a vehicle in an
15 unauthorized speed contest on a public highway, the court must issue an order
16 suspending the driver's license of the person for a period of not less than 6 months
17 but not more than 2 years and, for the first offense, may issue an order impounding

for 15 days any vehicle registered to the person convicted of such an offense if the vehicle is used in the commission of the offense. For the second and each subsequent offense, the court must issue an order impounding for 30 days any vehicle registered to the person convicted of such an offense if the vehicle is used in the commission of the offense. **Section 3** also prohibits a person from organizing an unauthorized speed contest on a public highway and imposes the same penalties for such a violation as for a person who drives a vehicle in an unauthorized speed contest on a public highway.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. NRS 483.460 is hereby amended to read as follows:

483.460 1. Except as otherwise provided by specific statute, the Department shall revoke the license, permit or privilege of any of the driver upon receiving a record of his conviction of any of the following offenses, when that conviction has become final, and the driver is not eligible for a license, permit or privilege to drive for the period indicated:

(a) For a period of 3 years if the offense is:

(1) A violation of subsection ~~24~~ 5 of NRS 484.377.

(2) A violation of NRS 484.379 that is punishable as a felony pursuant to NRS 484.3792.

(3) A violation of NRS 484.3795 or a homicide resulting from driving or being in actual physical control of a vehicle while under the influence of intoxicating liquor or a controlled substance or resulting from any other conduct prohibited by NRS 484.379, 484.3795 or 484.37955.

➤ The period during which such a driver is not eligible for a license, permit or privilege to drive must be set aside during any period of imprisonment and the period of revocation must resume upon completion of the period of imprisonment or when the person is placed on residential confinement.

(b) For a period of 1 year if the offense is:

(1) Any other manslaughter, including vehicular manslaughter as described in NRS 484.3775, resulting from the driving of a motor vehicle or felony in the commission of which a motor vehicle is used, including the unlawful taking of a motor vehicle.

(2) Failure to stop and render aid as required pursuant to the laws of this State in the event of a motor vehicle accident resulting in the death or bodily injury of another.

(3) Perjury or the making of a false affidavit or statement under oath to the Department pursuant to NRS 483.010 to 483.630, inclusive, or pursuant to any other law relating to the ownership or driving of motor vehicles.

(4) Conviction, or forfeiture of bail not vacated, upon three charges of reckless driving committed within a period of 12 months.

(5) A violation of NRS 484.379 that is punishable pursuant to paragraph (b) of subsection 1 of NRS 484.3792 and the driver is not eligible for a restricted license during any of that period.

(6) A violation of NRS 484.348.

(c) For a period of 90 days, if the offense is a violation of NRS 484.379 that is punishable pursuant to paragraph (a) of subsection 1 of NRS 484.3792.

2. The Department shall revoke the license, permit or privilege of a driver convicted of violating NRS 484.379 who fails to complete the educational course on the use of alcohol and controlled substances within the time ordered by the court and shall add a period of 90 days during which the driver is not eligible for a license, permit or privilege to drive.

3. When the Department is notified by a court that a person who has been convicted of a violation of NRS 484.379 that is punishable pursuant to paragraph (a) of subsection 1 of NRS 484.3792 has been permitted to enter a program of treatment pursuant to NRS 484.37937, the Department shall reduce by one-half the period during which he is not eligible for a license, permit or privilege to drive, but shall restore that reduction in time if notified that he was not accepted for or failed to complete the treatment.

4. The Department shall revoke the license, permit or privilege to drive of a person who is required to install a device pursuant to NRS 484.3943 but who operates a motor vehicle without such a device:

(a) For 3 years, if it is his first such offense during the period of required use of the device.

(b) For 5 years, if it is his second such offense during the period of required use of the device.

5. A driver whose license, permit or privilege is revoked pursuant to subsection 4 is not eligible for a restricted license during the period set forth in paragraph (a) or (b) of that subsection, whichever applies.

6. In addition to any other requirements set forth by specific statute, if the Department is notified that a court has ordered the revocation, suspension or delay in the issuance of a license pursuant to title 5 of NRS, NRS 176.064 or 206.330, chapter 484 of NRS or any other provision of law, the Department shall take such actions as are necessary to carry out the court's order.

7. As used in this section, "device" has the meaning ascribed to it in NRS 484.3941.

Sec. 2. NRS 483.490 is hereby amended to read as follows:

483.490 1. Except as otherwise provided in this section, after a driver's license has been suspended or revoked for an offense other than a violation of NRS 484.379 that is punishable pursuant to paragraph (b) of subsection 1 of NRS 484.3792, and one-half of the period during which the driver is not eligible for a license has expired, the Department may, unless the statute authorizing the suspension prohibits the issuance of a restricted license, issue a restricted driver's license to an applicant permitting the applicant to drive a motor vehicle:

(a) To and from work or in the course of his work, or both; or

(b) To acquire supplies of medicine or food or receive regularly scheduled medical care for himself or a member of his immediate family.

➔ Before a restricted license may be issued, the applicant must submit sufficient documentary evidence to satisfy the Department that a severe hardship exists because the applicant has no alternative means of transportation and that the severe hardship outweighs the risk to the public if he is issued a restricted license.

2. A person who has been ordered to install a device in a motor vehicle pursuant to NRS 484.3943:

(a) Shall install the device not later than 21 days after the date on which the order was issued; and

(b) May not receive a restricted license pursuant to this section until:

(1) After at least 1 year of the period during which he is not eligible for a license, if he was convicted of:

(I) A violation of NRS 484.3795 or a homicide resulting from driving or being in actual physical control of a vehicle while under the influence of intoxicating liquor or a controlled substance or resulting from any other conduct prohibited by NRS 484.379, 484.3795 or 484.37955; or

(II) A violation of NRS 484.379 that is punishable as a felony pursuant to NRS 484.3792;

(2) After at least 180 days of the period during which he is not eligible for a license, if he was convicted of a violation of subsection ~~424~~ 5 of NRS 484.377; or

(3) After at least 45 days of the period during which he is not eligible for a license, if he was convicted of a violation of NRS 484.379 that is punishable pursuant to paragraph (a) of subsection 1 of NRS 484.3792.

3. If the Department has received a copy of an order requiring a person to install a device in a motor vehicle pursuant to NRS 484.3943, the Department shall not issue a restricted driver's license

1 to such a person pursuant to this section unless the applicant has
2 submitted proof of compliance with the order and subsection 2.

3 4. After a driver's license has been revoked or suspended
4 pursuant to title 5 of NRS, the Department may issue a restricted
5 driver's license to an applicant permitting the applicant to drive a
6 motor vehicle:

7 (a) If applicable, to and from work or in the course of his work,
8 or both; or

9 (b) If applicable, to and from school.

10 5. After a driver's license has been suspended pursuant to NRS
11 483.443, the Department may issue a restricted driver's license to an
12 applicant permitting the applicant to drive a motor vehicle:

13 (a) If applicable, to and from work or in the course of his work,
14 or both;

15 (b) To receive regularly scheduled medical care for himself or a
16 member of his immediate family; or

17 (c) If applicable, as necessary to exercise a court-ordered right to
18 visit a child.

19 6. A driver who violates a condition of a restricted license
20 issued pursuant to subsection 1 or by another jurisdiction is guilty of
21 a misdemeanor and, if the license of the driver was suspended or

23 (a) A violation of NRS 484.379, 484.3795 or 484.384;

24 (b) A homicide resulting from driving or being in actual

33 7. The periods of suspensions and revocations required
34 pursuant to this chapter and NRS 484.384 must run consecutively,
35 except as otherwise provided in NRS 483.465 and 483.475, when
36 the suspensions must run concurrently.

37 8. Whenever the Department suspends or revokes a license, the
38 period of suspension, or of ineligibility for a license after the
39 revocation, begins upon the effective date of the revocation or
40 suspension as contained in the notice thereof.

41 **Sec. 3.** NRS 484.377 is hereby amended to read as follows:

42 484.377 1. It is unlawful for a person to:

43 (a) Drive a vehicle in willful or wanton disregard of the safety of

(b) Drive a vehicle in an unauthorized speed contest on a public highway.

(c) Organize an unauthorized speed contest on a public highway.

➡ A violation of *paragraph (a) or (b) of* this subsection or subsection 1 of NRS 484.348 constitutes reckless driving.

2. *A person who violates paragraph (a) of subsection 1 is guilty of a misdemeanor and:*

(a) For the first offense, shall be punished:

(1) By a fine of not less than \$250 but not more than \$1,000; or

(2) By both fine and imprisonment in the county jail for not more than 6 months.

(b) For the second offense, shall be punished:

(1) By a fine of not less than \$1,000 but not more than \$1,500; or

(2) By both fine and imprisonment in the county jail for not more than 6 months.

(c) For the third and each subsequent offense, shall be punished:

(1) By a fine of not less than \$1,500 but not more than \$2,000; or

(2) By both fine and imprisonment in the county jail for not more than 6 months.

3. *A person who violates paragraph (b) or (c) of subsection 1 is guilty of a misdemeanor and:*

(a) For the first offense:

(1) Shall be punished by a fine of not less than \$250 but not more than \$1,000;

(2) Shall perform not less than 50 hours, but not more than 99 hours, of community service; and

(3) May be punished by imprisonment in the county jail for not more than 6 months.

(b) For the second offense:

(1) Shall be punished by a fine of not less than \$1,000 but not more than \$1,500;

(2) Shall perform not less than 100 hours, but not more than 199 hours, of community service; and

(3) May be punished by imprisonment in the county jail for not more than 6 months.

(c) For the third and each subsequent offense:

(1) Shall be punished by a fine of not less than \$1,500 but not more than \$2,000;

(2) Shall perform 200 hours of community service; and

1 (3) *May be punished by imprisonment in the county jail for*
2 *not more than 6 months.*

3 4. *In addition to any fine, community service and*
4 *imprisonment imposed upon a person pursuant to subsection 3,*
5 *the court:*

6 (a) *Shall issue an order suspending the driver's license of the*
7 *person for a period of not less than 6 months but not more than 2*
8 *years and requiring the person to surrender all driver's licenses*
9 *then held by the person;*

10 (b) *Within 5 days after issuing an order pursuant to paragraph*
11 *(a), shall forward to the Department any licenses, together with a*
12 *copy of the order;*

13 (c) *For the first offense, may issue an order impounding, for a*
14 *period of 15 days, any vehicle that is registered to the person who*
15 *violates paragraph (b) or (c) of subsection 1 if the vehicle is used*
16 *in the commission of the offense; and*

17 (d) *For the second and each subsequent offense, shall issue an*
18 *order impounding, for a period of 30 days, any vehicle that is*
19 *registered to the person who violates paragraph (b) or (c) of*
20 *subsection 1 if the vehicle is used in the commission of the*
21 *offense.*

22 5. Unless a greater penalty is provided pursuant to subsection 4
23 of NRS 484.348, a person who does any act or neglects any duty
24 imposed by law while driving or in actual physical control of any
25 vehicle in willful or wanton disregard of the safety of persons or
26 property, if the act or neglect of duty proximately causes the death
27 of or substantial bodily harm to a person other than himself, is guilty
28 of a category B felony and shall be punished by imprisonment in the
29 state prison for a minimum term of not less than 1 year and a
30 maximum term of not more than 6 years ~~[-, or]~~ *and* by a fine of not

34 be subject to the additional penalty set forth in NRS 484.3667 unless

37 7. *As used in this section, "organize" means to plan, schedule*
38 *or promote, or assist in the planning, scheduling or promotion of,*
39 *an unauthorized speed contest on a public highway, regardless of*
40 *whether a fee is charged for attending the unauthorized speed*
