

SENATE BILL NO. 443—COMMITTEE ON FINANCE

(ON BEHALF OF THE DEPARTMENT OF ADMINISTRATION)

SUMMARY—Makes an appropriation to the Nevada Cancer Institute for research, community outreach and education, and expansion of laboratory and clinical space. (BDR S-1234)

AN ACT making an appropriation to the Nevada Cancer Institute for research, community outreach and education, and expansion of laboratory and clinical space; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1.** 1. There is hereby appropriated from the State General Fund to the Nevada Cancer Institute the sum of \$10,000,000 for expansion of laboratory and clinical space.
2. There is hereby appropriated from the State General Fund to the Nevada Cancer Institute for research and community outreach and education:

3. Upon acceptance of the money appropriated by subsections 1 and 2, the Nevada Cancer Institute shall:
- (a) Prepare and transmit a report to the Interim Finance Committee on or before December 15, 2008, that describes each expenditure made from the money appropriated by subsections 1

1 and 2 from the date on which the money was received by the
2 Nevada Cancer Institute through December 1, 2008;

3 (b) Prepare and transmit a final report to the Interim Finance
4 Committee on or before September 18, 2009, that describes each
5 expenditure made from the money appropriated by subsections 1
6 and 2 from the date on which the money was received by the
7 Nevada Cancer Institute through June 30, 2009; and

8 (c) Upon request of the Legislative Commission, make available
9 to the Legislative Auditor any of the books, accounts, claims,
10 reports, vouchers or other records of information, confidential or
11 otherwise, of the Nevada Cancer Institute, regardless of their form
12 or location, that the Legislative Auditor deems necessary to conduct
13 an audit of the use of the money appropriated pursuant to
14 subsections 1 and 2.

15 **Sec. 2.** 1. Any remaining balance of the appropriation made
16 by subsection 1 of section 1 of this act must not be committed for
17 expenditure after June 30, 2009, by the entity to which the
18 appropriation is made or any entity to which money from the
19 appropriation is granted or otherwise transferred in any manner, and
20 any portion of the appropriated money remaining must not be spent
21 for any purpose after September 18, 2009, by either the entity to
22 which the money was appropriated or the entity to which the money
23 was subsequently granted or transferred, and must be reverted to the
24 State General Fund on or before September, 18, 2009.

25 2. Any balance of the sums appropriated by subsection 2 of
26 section 1 of this act remaining at the end of the respective fiscal
27 years must not be committed for expenditure after June 30 of the
28 respective fiscal years by the entity to which the appropriation is
29 made or any entity to which money from the appropriation is
30 granted or otherwise transferred in any manner, and any portion of
31 the appropriated money remaining must not be spent for any
32 purpose after September 19, 2008, and September 18, 2009,
33 respectively, by either the entity to which the money was
34 appropriated or the entity to which the money was subsequently
35 granted or transferred, and must be reverted to the State General
36 Fund on or before September 19, 2008, and September 18, 2009,
37 respectively.

38 **Sec. 3.** The appropriations made by the provisions of this act
39 are not intended to finance ongoing expenditures of state agencies,
40 and the expenditures financed with those appropriations must not be
41 included as base budget expenditures in the proposed budget for the
42 Executive Branch of State Government for the 2007-2009 biennium.

43 **Sec. 4.** This act becomes effective upon passage and approval.
