

SENATE BILL NO. 445—COMMITTEE ON FINANCE

SUMMARY—Makes an appropriation to the Foundation for Positively Kids to provide day care and other services for medically fragile children. (BDR S-1438)

AN ACT making an appropriation to the Foundation for Positively Kids to provide day care and other services for medically fragile children; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
- 2 General Fund to the Foundation for Positively Kids for day care and
- 3 other services and for the operation of a resource center for
- 4 medically fragile children:
- 5 For the Fiscal Year 2007-2008.....\$176,390
- 6 For the Fiscal Year 2008-2009.....\$323,679
- 7 2. Upon acceptance of the money appropriated by subsection 1,
- 8 the Foundation shall:
- 9 (a) Prepare and transmit a report to the Interim Finance
- 10 Committee on or before December 15, 2008, that describes each
- 11 expenditure made from the money appropriated by subsection 1
- 12 from the date on which the money was received by the Foundation
- 13 through December 1, 2008;
- 14 (b) Prepare and transmit a final report to the Interim Finance
- 15 Committee on or before September 18, 2009, that describes each
- 16 expenditure made from the money appropriated by subsection 1



1 from the date on which the money was received by the Foundation
2 through June 30, 2009; and

3 (c) Upon request of the Legislative Commission, make available
4 to the Legislative Auditor any of the books, accounts, claims,
5 reports, vouchers or other records of information, confidential or
6 otherwise, of the Foundation, regardless of their form or location,
7 that the Legislative Auditor deems necessary to conduct an audit of
8 the use of the money appropriated pursuant to subsection 1.

9 **Sec. 2.** The sums appropriated by section 1 of this act are
10 available for either fiscal year. Any remaining balance of those sums
11 must not be committed for expenditure after June 30, 2009, by the
12 entity to which the appropriation is made or any entity to which
13 money from the appropriation is granted or otherwise transferred in
14 any manner, and any portion of the appropriated money remaining
15 must not be spent for any purpose after September 18, 2009, by
16 either the entity to which the money was appropriated or the entity
17 to which the money was subsequently granted or transferred,
18 and must be reverted to the State General Fund on or before
19 September 18, 2009.

20 **Sec. 3.** The appropriations made by the provisions of this act
21 are not intended to finance ongoing expenditures of state agencies,
22 and the expenditures financed with those appropriations must not be
23 included as base budget expenditures in the proposed budget for the
24 Executive Branch of State Government for the 2009-2011 biennium.

25 **Sec. 4.** This act becomes effective upon passage and approval.
