

SENATE BILL NO. 446—COMMITTEE ON FINANCE

SUMMARY—Makes an appropriation to the Chinese Workers' Museum in Carson City for costs associated with the planning and design, and the construction and operation, of the proposed Chinese Workers' Museum of America. (BDR S-752)

AN ACT making an appropriation to the Chinese Workers' Museum in Carson City for costs associated with the planning and design, and the construction and operation, of the proposed Chinese Workers' Museum of America; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to the Chinese Workers' Museum in Carson City the
3 sum of \$100,000 for costs associated with the planning and design,
4 and the construction and operation, of the proposed Chinese
5 Workers' Museum of America.
6 2. Upon acceptance of the money appropriated by subsection 1,
7 the Chinese Workers' Museum shall:
8 (a) Prepare and transmit a report to the Interim Finance
9 Committee on or before December 15, 2008, that describes each
10 expenditure made from the money appropriated by subsection 1
11 from the date on which the money was received by the Chinese
12 Workers' Museum through December 1, 2008;
13 (b) Prepare and transmit a final report to the Interim Finance
14 Committee on or before September 16, 2011, that describes each

1 expenditure made from the money appropriated by subsection 1
2 from the date on which the money was received by the Chinese
3 Workers' Museum through June 30, 2011; and

4 (c) Upon request of the Legislative Commission, make available
5 to the Legislative Auditor any books, accounts, claims, reports,
6 vouchers or other records of information, confidential or otherwise,
7 of the Chinese Workers' Museum, regardless of their form or
8 location, that the Legislative Auditor deems necessary to conduct an
9 audit of the use of the money appropriated pursuant to subsection 1.

10 **Sec. 2.** Any remaining balance of the appropriation made by
11 section 1 of this act must not be committed for expenditure after
12 June 30, 2011, by the entity to which the appropriation is made or
13 any entity to which money from the appropriation is granted or
14 otherwise transferred in any manner, and any portion of the
15 appropriated money remaining must not be spent for any purpose
16 after September 16, 2011, by either the entity to which the money
17 was appropriated or the entity to which the money was subsequently
18 granted or transferred, and reverts to the State General Fund as soon
19 as all payments of money committed have been made.

20 **Sec. 3.** This act becomes effective upon passage and approval.
