SUMMARY—Extends the reversion date of a previous appropriation to the Department of Administration for the digital microwave project. (BDR S-1151)

AN ACT relating to technology; extending the date for the reversion of a portion of the appropriation made by the 2005 Legislature to the Department of Administration for the digital microwave project; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Under existing law, the 2005 Legislature made an appropriation from the State Highway Fund to the Department of Administration for information technology projects, and provided for the reversion to that Fund of any portion of that appropriation which has not been committed for expenditure by June 30, 2007. (Chapter 434, Statutes of Nevada 2005, pp. 1943, 1948) This bill extends the reversion date to June 30, 2009, for the unexpended portion of that appropriation designated for expenditure on the digital microwave project.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Section 32 of chapter 434, Statutes of Nevada 2005,
2 at page 1943, is hereby amended to read as follows:
3 Sec. 32. **I.** The following sums are hereby
4 appropriated from the State Highway Fund for the purposes
5 expressed in this section for the fiscal years beginning July 1,

31 *2. Any remaining balance of that portion of the
32 appropriation made by subsection 1 to the Department of
33 Administration for information technology projects which is
34 designated for the digital microwave project must not be
35 committed for expenditure after June 30, 2009, by the entity
36 to which the appropriation is made or any entity to which
37 money from the appropriation is granted or otherwise
38 transferred in any manner, and any portion of that
39 appropriated money remaining must not be spent for any
40 purpose after September 18, 2009, by either the entity to
41 which the money was appropriated or the entity to which the
42 money was subsequently granted or transferred, and must
43 be reverted to the State Highway Fund on or before
44 September 18, 2009.*

1 **Sec. 2.** Section 54 of chapter 434, Statutes of Nevada 2005, at
2 page 1948, is hereby amended to read as follows:

3 Sec. 54. 1. Except as otherwise provided in sections
4 **32**, 51 and 66 of this act, unencumbered balances of the
5 appropriations made in this act for the Fiscal Years 2005-
6 2006 and 2006-2007 must not be committed for expenditure
7 after June 30 of each fiscal year. Except as otherwise
8 provided in subsection 2 **~~H~~ and section 32 of this act**,
9 unencumbered balances of these appropriations revert to the
10 fund from which appropriated on or before September 15,
11 2006, and September 21, 2007, of each fiscal year,
12 respectively.

13 2. Any encumbered balance of the appropriations made
14 to the Legislative Fund by section 10 of this act does not
15 revert to the State General Fund but constitutes a balance
16 carried forward.

17 **Sec. 3.** This act becomes effective upon passage and approval.
