AN ACT making an appropriation to the Department of Taxation for continued development and implementation of the Unified Tax System; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. There is hereby appropriated from the State General Fund to the Department of Taxation the sum of \$3,674,059 for continued development and implementation of the Unified Tax System, and for costs of replacement servers, computer hardware and software, and office equipment.

Sec. 2. Any remaining balance of the appropriation made by section 1 of this act must not be committed for expenditure after June 30, 2009, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 18, 2009, by either the entity to which the money was appropriated or the entity to which the money was subsequently



- 1 granted or transferred, and must be reverted to the State General
- 2 Fund on or before September 18, 2009.
- 3 **Sec. 3.** This act becomes effective upon passage and approval.
