
SENATE BILL NO. 488—COMMITTEE ON NATURAL RESOURCES
(ON BEHALF OF THE LEGISLATIVE COMMITTEE ON PUBLIC LANDS)

SUMMARY—Makes an appropriation to the State Department of Agriculture for control or abatement of weeds in this State. (BDR S-398)

AN ACT making an appropriation to the State Department of Agriculture for control or abatement of weeds in this State; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** There is hereby appropriated from the State
2 General Fund to the State Department of Agriculture the sum of:

3 1. For the purpose of awarding grants of money pursuant to
4 section 2 of this act, \$450,000.

5 2. For the purpose of allocating and using money pursuant to
6 section 3 of this act, \$300,000.

7 **Sec. 2.** 1. The Director of the State Department of
8 Agriculture may use the money appropriated pursuant to subsection
9 1 of section 1 of this act to award grants of money to any
10 cooperative organization or other group of persons that is formed
11 and operated to control or abate weeds in any area of this State.

12 2. In reviewing an application for a grant, the Director shall
13 consider:

14 (a) The qualifications, ability and interest of the applicant in
15 controlling or abating weeds in this State;

1 (b) The previous history of the applicant, if any, in organizing or
2 engaging in any activity for the control or abatement of weeds in
3 this State; and

4 (c) Any other requirements specified by the Director for
5 awarding the grant.

6 **Sec. 3.** 1. The Director of the State Department of
7 Agriculture shall allocate and use the money appropriated pursuant
8 to subsection 2 of section 1 of this act as follows:

9 (a) Fifty thousand dollars must be used to hire seasonal
10 employees to provide assistance in carrying out any activity of the
11 Department relating to the control or abatement of noxious weeds in
12 this State;

13 (b) Fifty thousand dollars must be used to develop or apply
14 biological methods of controlling or abating noxious weeds in this
15 State;

16 (c) One hundred thousand dollars must be used to develop
17 programs to educate and encourage the involvement of the members
18 of the general public in issues and activities relating to the control or
19 abatement of noxious weeds in this State; and

20 (d) One hundred thousand dollars must be used to carry out any
21 other program or activity of the Department relating to the control or
22 abatement of noxious weeds in this State.

23 2. As used in this section, "noxious weed" means any species
24 of plant which is, or is likely to be, detrimental or destructive and
25 difficult to control or eradicate.

26 **Sec. 4.** Any remaining balance of the appropriation made by
27 section 1 of this act must not be committed for expenditure after
28 June 30, 2009, by the entity to which the appropriation is made or
29 any entity to which money from the appropriation is granted or
30 otherwise transferred in any manner, and any portion of the
31 appropriated money remaining must not be spent for any purpose
32 after September 18, 2009, by either the entity to which the money
33 was appropriated or the entity to which the money was subsequently
34 granted or transferred, and must be reverted to the State General
35 Fund on or before September 18, 2009.

36 **Sec. 5.** This act becomes effective upon passage and approval.
