AN ACT making appropriations to the Department of Health and Human Services for expenses relating to the annual salary of the State Dental Health Officer and for expenses relating to a grant program to enhance statewide wellness programs to reduce chronic diseases in this State; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** 1. There is hereby appropriated from the State  
2 General Fund to the Department of Health and Human Services for  
3 expenses relating to the annual salary of the State Dental Health  
4 Officer:

5              For the Fiscal Year 2007-2008.....\$150,000  
6              For the Fiscal Year 2008-2009.....\$150,000

7       2. Any balance of the sums appropriated by subsection 1  
8 remaining at the end of the respective fiscal years must not be  
9 committed for expenditure after June 30 of the respective fiscal  
10 years by the entity to which the appropriation is made or any entity  
11 to which money from the appropriation is granted or otherwise  
12 transferred in any manner, and any portion of the appropriated  
13 money remaining must not be spent for any purpose after

1 September 19, 2008, and September 18, 2009, respectively, by  
2 either the entity to which the money was appropriated or the entity  
3 to which the money was subsequently granted or transferred, and  
4 must be reverted to the State General Fund on or before  
5 September 19, 2008, and September 18, 2009, respectively.

6 **Sec. 2.** 1. There is hereby appropriated from the State  
7 General Fund to the Department of Health and Human Services for  
8 carrying out the provisions of section 3 of this act:

9       For the Fiscal Year 2007-2008.....\$5,000,000  
10      For the Fiscal Year 2008-2009.....\$5,000,000

11     2. Any balance of the sums appropriated by subsection 1  
12 remaining at the end of the respective fiscal years must not be  
13 committed for expenditure after June 30 of the respective fiscal  
14 years by the entity to which the appropriation is made or any entity  
15 to which money from the appropriation is granted or otherwise  
16 transferred in any manner, and any portion of the appropriated  
17 money remaining must not be spent for any purpose after  
18 September 19, 2008, and September 18, 2009, respectively, by  
19 either the entity to which the money was appropriated or the entity  
20 to which the money was subsequently granted or transferred, and  
21 must be reverted to the State General Fund on or before  
22 September 19, 2008, and September 18, 2009, respectively.

23     **Sec. 3.** 1. The Department of Health and Human Services  
24 shall establish a grant program to enhance statewide wellness  
25 programs to reduce chronic diseases in this State.

26     2. The Department shall prescribe the requirements for  
27 applying for a grant, which must include, without limitation, the  
28 submission of specific plans for spending the grant.

29     3. Grants may be made to public and private entities, including,  
30 without limitation, community organizations, school districts,  
31 employers, coalitions and taskforces.

32     4. The Grants Management Advisory Committee created  
33 within the Department pursuant to NRS 232.383 shall, in  
34 accordance with the provisions of NRS 232.385, review and make  
35 recommendations concerning requests for grants and monitor  
36 awards of grants, regardless of whether the grants are made to  
37 public or private entities.

38     5. The Department may make grants for any statewide wellness  
39 program that is intended to reduce chronic diseases in this State,  
40 including, without limitation, programs for the prevention of chronic  
41 diseases, programs that provide screening for chronic diseases,  
42 programs that provide educational activities concerning chronic  
43 diseases and programs that promote awareness of chronic diseases.

44     6. The Department shall provide technical assistance to  
45 recipients of grants.

1       7. The Department shall employ a full-time employee in the  
2 Office of Minority Health of the Department to assist in carrying out  
3 the provisions of this section.

4       **Sec. 4.** This act becomes effective on July 1, 2007.
