AN ACT making appropriations to the Department of Public Safety from both the State General Fund and the State Highway Fund; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to the Investigation Division of the Department of
3 Public Safety the sum of \$300,525 to partially fund replacement
4 vehicles and associated equipment, and for personal computers,
5 laptop computers, printers and related software.
6 2. There is hereby appropriated from the State General Fund to
7 the Division of Emergency Management of the Department of
8 Public Safety the sum of \$66,740 for computer hardware and
9 software and ID cards and door lock system.
10 3. There is hereby appropriated from the State General Fund to
11 the State Fire Marshal Division of the Department of Public Safety
12 the sum of \$222,551 to replace seven older, unreliable agency-
13 owned vehicles and to replace personal computers, laptop computers
14 and printers.
15 4. There is hereby appropriated from the State General Fund to
16 the Division of Parole and Probation of the Department of Public

1 Safety the sum of \$381,672 to replace 114 computers in each year of
2 the biennium.

3 5. There is hereby appropriated from the State General Fund to
4 the Department of Public Safety for the State Board of Parole
5 Commissioners the sum of \$89,771 to incorporate the Board's
6 practices, decisions and analysis into the Nevada Offender Tracking
7 and Information System and to replace computer hardware and
8 software.

9 6. There is hereby appropriated from the State General Fund to
10 the Training Division of the Department of Public Safety the sum of
11 \$24,921 to partially fund the replacement of computer hardware and
12 software, classroom furniture and protective suits.

13 **Sec. 2.** 1. There is hereby appropriated from the State
14 Highway Fund to the Nevada Highway Patrol Division of the
15 Department of Public Safety the sum of \$12,633,597 to fund over
16 300 new and replacement vehicles and related equipment, aircraft
17 navigational and communications equipment, video cameras for
18 patrol vehicles and seven motorcycles.

19 2. There is hereby appropriated from the State Highway Fund
20 to the Training Division of the Department of Public Safety the sum
21 of \$37,381 to partially fund computer hardware and software,
22 classroom furniture and protective suits.

23 3. There is hereby appropriated from the State Highway Fund
24 to the Investigation Division of the Department of Public Safety the
25 sum of \$29,941 to partially fund the replacement of computer
26 equipment and vehicles.

27 **Sec. 3.** Any remaining balance of the appropriations made by
28 sections 1 and 2 of this act must not be committed for expenditure
29 after June 30, 2009, by the entity to which the appropriations are
30 made or any entity to which money from the appropriations is
31 granted or otherwise transferred in any manner, and any portion of
32 the appropriated money remaining must not be spent for any
33 purpose after September 18, 2009, by either the entity to which the
34 money was appropriated or the entity to which the money was
35 subsequently granted or transferred, and must be reverted to the
36 State General Fund on or before September 18, 2009.

37 **Sec. 4.** This act becomes effective upon passage and approval.
