SUMMARY—Extends the reversion date of an appropriation made in the 22nd Special Session to the Advisory Council on the State Program for Fitness and Wellness. (BDR S-1466)

AN ACT relating to state financial administration; extending the reversion date of an appropriation made in the 22nd Special Session to the Advisory Council on the State Program for Fitness and Wellness; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 The 22nd Special Session of the Nevada Legislature made an appropriation of
2 \$100,000 to the Advisory Council on the State Program for Fitness and Wellness.
3 (Chapter 7, Statutes of Nevada 2005, 22nd Special Session, p. 122) This bill
4 extends the reversion date for the appropriation from June 30, 2007, to June 30,
5 2009, to allow the money to be expended during the next biennium. This bill also
6 adds the standard reporting requirements included this session for appropriations
7 made to entities other than agencies of the state or local governments.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Section 37 of chapter 7, Statutes of Nevada 2005,
2 22nd Special Session, at page 122, is hereby amended to read as
3 follows:

4 Sec. 37. 1. There is hereby appropriated from the
5 State General Fund to the Advisory Council on the State
6 Program for Fitness and Wellness, created pursuant to Senate

19 (c) *Upon request of the Legislative Commission, make*

24 *Legislative Auditor deems necessary to conduct an audit of*

30 *is granted or otherwise transferred in any manner, and any*
31 *portion of the appropriated money remaining must not be*
32 *spent for any purpose after September 18, 2009, by either*
33 *the entity to which the money was appropriated or the entity*
34 *to which the money was subsequently granted or*
35 *transferred, and must be reverted to the State General Fund*
